THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3101a. (1) An insurer, in conjunction with the issuance
- 2 of an-automobile insurance, policy, as defined in section 3303,
- 3 shall provide 2 certificates of insurance for each insured vehicle.
- 4 The insurer shall mark 1 of the certificates as the secretary of
- state's copy, which copy, except as otherwise provided in
- 6 subsection (2), shall be filed with the secretary of state by the
- 7 policyholder upon application for a vehicle registration. The
 - secretary of state shall not maintain the certificate of insurance
