THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 134. (1) Every certificate of authority or license in
- 2 force immediately prior to January 1, 1957 and existing under any
- 3 act repealed by this act is valid until its original expiration
- 4 date, unless earlier terminated in accordance with this act.
- 5 (2) Any plan of operation adopted by an association or
- 6 facility, and any premium or assessment levied against an insurer
- 7 member of that association or facility, is hereby validated
- 8 retroactively to the date of its original adoption or levy and

- 1 shall continue CONTINUES in force and effect according to the terms
- 2 of the plan of operation, premium, or assessment until otherwise
- 3 changed by the commissioner or the board of directors of the
- 4 association or facility pursuant to this act.
- 5 (3) An association or facility or the board of directors of
- 6 the association or facility is not a state agency and the money of
- 7 an association or facility is not state money. COMPLIANCE WITH
- 8 SECTION 3104(25) OR (26) BY THE CATASTROPHIC CLAIMS ASSOCIATION
- 9 CREATED UNDER CHAPTER 31 DOES NOT ALTER THE LEGAL STATUS OF THE
- 10 ASSOCIATION UNDER THIS SUBSECTION AND THE ASSOCIATION SHALL NOT
- 11 OTHERWISE BE TREATED AS A STATE AGENCY OR PUBLIC BODY.
- 12 (4) A-EXCEPT AS OTHERWISE PROVIDED IN SECTION 3104, A record
- of an association or facility shall be exempted IS EXEMPT from
- 14 disclosure pursuant to section 13 of the freedom of information
- act, Act No. 442 of the Public Acts of 1976, being section 15.243
- of the Michigan Compiled Laws 1976 PA 442, MCL 15.243.
- 17 (5) Any premium or assessment levied by an association or
- 18 facility, or any premium or assessment of a similar association or
- 19 facility formed under a law in force outside this state, is not a
- 20 burden or special burden for purposes of a calculation under
- 21 section 476a, and any premium or assessment paid to an association
- 22 or facility shall not be included in determining the aggregate
- 23 amount a foreign insurer pays to the commissioner under section
- **24** 476a.
- 25 (6) As used in this section, "association or facility" means
- 26 an association of insurers created under this act and any other
- 27 association or facility formed under this act as a nonprofit

- 1 organization of insurer members, including, but not limited to, the
- 2 following:
- 3 (a) The Michigan worker's compensation placement facility
- 4 created under chapter 23.
- 5 (b) The Michigan basic property insurance association created
- 6 under section CHAPTER 29.
- 7 (c) The catastrophic claims association created under chapter
- 8 31.
- 9 (d) The Michigan automobile insurance placement facility
- 10 created under chapter 33.
- 11 (e) The Michigan life and health insurance guaranty
- 12 association created under chapter 77.
- 13 (f) The property and casualty guaranty association created
- 14 under chapter 79.
- 15 (q) The assigned claims facility created under section 3171.
- 16 Sec. 3104. (1) An unincorporated, nonprofit association to be
- 17 known as the catastrophic claims association, hereinafter referred
- 18 to as the association, is created. Each insurer engaged in writing
- 19 insurance coverages that provide the security required by section
- 20 3101(1) within this state, as a condition of its authority to
- 21 transact insurance in this state, shall be a member of the
- 22 association and shall be IS bound by the plan of operation of the
- 23 association. Each insurer engaged in writing insurance coverages
- 24 that provide the security required by section 3103(1) within this
- 25 state, as a condition of its authority to transact insurance in
- 26 this state, shall be considered a member of the association, but
- 27 only for purposes of premiums under subsection (7)(d). Except as

- 1 expressly provided in this section, the association is not subject
- 2 to any laws of this state with respect to insurers, but in all
- 3 other respects the association is subject to the laws of this state
- 4 to the extent that the association would be if it were an insurer
- 5 organized and subsisting under chapter 50.
- 6 (2) The association shall provide and each member shall accept
- 7 indemnification for 100% of the amount of ultimate loss sustained
- 8 under personal protection insurance coverages in excess of the
- 9 following amounts in each loss occurrence:
- 10 (a) For a motor vehicle accident policy issued or renewed
- 11 before July 1, 2002, \$250,000.00.
- 12 (b) For a motor vehicle accident policy issued or renewed
- 13 during the period July 1, 2002 to June 30, 2003, \$300,000.00.
- 14 (c) For a motor vehicle accident policy issued or renewed
- 15 during the period July 1, 2003 to June 30, 2004, \$325,000.00.
- 16 (d) For a motor vehicle accident policy issued or renewed
- 17 during the period July 1, 2004 to June 30, 2005, \$350,000.00.
- 18 (e) For a motor vehicle accident policy issued or renewed
- 19 during the period July 1, 2005 to June 30, 2006, \$375,000.00.
- (f) For a motor vehicle accident policy issued or renewed
- 21 during the period July 1, 2006 to June 30, 2007, \$400,000.00.
- 22 (g) For a motor vehicle accident policy issued or renewed
- 23 during the period July 1, 2007 to June 30, 2008, \$420,000.00.
- 24 (h) For a motor vehicle accident policy issued or renewed
- 25 during the period July 1, 2008 to June 30, 2009, \$440,000.00.
- (i) For a motor vehicle accident policy issued or renewed
- 27 during the period July 1, 2009 to June 30, 2010, \$460,000.00.

- 1 (j) For a motor vehicle accident policy issued or renewed
- 2 during the period July 1, 2010 to June 30, 2011, \$480,000.00.
- 3 (k) For a motor vehicle accident policy issued or renewed
- 4 during the period July 1, 2011 to June 30, 2013, \$500,000.00.
- 5 Beginning July 1, 2013, this \$500,000.00 amount shall be increased
- 6 biennially on July 1 of each odd-numbered year, for policies issued
- 7 or renewed before July 1 of the following odd-numbered year, by the
- 8 lesser of 6% or the consumer price index, and rounded to the
- 9 nearest \$5,000.00. This biennial adjustment shall be calculated by
- 10 the association by January 1 of the year of its July 1 effective
- 11 date.
- 12 (3) An insurer may withdraw from the association only upon
- 13 ceasing to write insurance that provides the security required by
- 14 section 3101(1) in this state.
- 15 (4) An insurer whose membership in the association has been
- 16 terminated by withdrawal shall continue to be bound by the plan of
- 17 operation, and upon withdrawal, all unpaid premiums that have been
- 18 charged to the withdrawing member are payable as of the effective
- 19 date of the withdrawal.
- 20 (5) An unsatisfied net liability to the association of an
- 21 insolvent member shall be assumed by and apportioned among the
- 22 remaining members of the association as provided in the plan of
- 23 operation. The association has all rights allowed by law on behalf
- 24 of the remaining members against the estate or funds of the
- 25 insolvent member for sums due the association.
- 26 (6) If a member has been merged or consolidated into another
- 27 insurer or another insurer has reinsured a member's entire business

- 1 that provides the security required by section 3101(1) in this
- 2 state, the member and successors in interest of the member remain
- 3 liable for the member's obligations.
- 4 (7) The association shall do all of the following on behalf of
- 5 the members of the association:
- 6 (a) Assume 100% of all liability as provided in subsection
- 7 (2).
- 8 (b) Establish procedures by which members shall promptly
- 9 report to the association each claim that, on the basis of the
- 10 injuries or damages sustained, may reasonably be anticipated to
- 11 involve the association if the member is ultimately held legally
- 12 liable for the injuries or damages. Solely for the purpose of
- 13 reporting claims, the member shall in all instances consider itself
- 14 legally liable for the injuries or damages. The member shall also
- 15 advise the association of subsequent developments likely to
- 16 materially affect the interest of the association in the claim.
- 17 (c) Maintain relevant loss and expense data relative to all
- 18 liabilities of the association and require each member to furnish
- 19 statistics, in connection with liabilities of the association, at
- 20 the times and in the form and detail as may be required by the plan
- 21 of operation.
- 22 (d) In a manner provided for in the plan of operation,
- 23 calculate and charge to members of the association a total premium
- 24 sufficient to cover the expected losses and expenses of the
- 25 association that the association will likely incur during the
- 26 period for which the premium is applicable. The premium shall
- 27 include an amount to cover incurred but not reported losses for the

- 1 period and may be adjusted for any excess or deficient premiums
- 2 from previous periods. Excesses or deficiencies from previous
- 3 periods may be fully adjusted in a single period or may be adjusted
- 4 over several periods in a manner provided for in the plan of
- 5 operation. Each member shall be charged an amount equal to that
- 6 member's total written car years of insurance providing the
- 7 security required by section 3101(1) or 3103(1), or both, written
- 8 in this state during the period to which the premium applies,
- 9 multiplied by the average premium per car. The average premium per
- 10 car shall be the total premium calculated divided by the total
- 11 written car years of insurance providing the security required by
- 12 section 3101(1) or 3103(1) written in this state of all members
- 13 during the period to which the premium applies. A member shall be
- 14 charged a premium for a historic vehicle that is insured with the
- 15 member of 20% of the premium charged for a car insured with the
- 16 member. As used in this subdivision:
- 17 (i) "Car" includes a motorcycle but does not include a historic
- 18 vehicle.
- 19 (ii) "Historic vehicle" means a vehicle that is a registered
- 20 historic vehicle under section 803a or 803p of the Michigan vehicle
- 21 code, 1949 PA 300, MCL 257.803a and 257.803p.
- 22 (e) Require and accept the payment of premiums from members of
- 23 the association as provided for in the plan of operation. The
- 24 association shall do either of the following:
- 25 (i) Require payment of the premium in full within 45 days after
- 26 the premium charge.
- 27 (ii) Require payment of the premiums to be made periodically to

- 1 cover the actual cash obligations of the association.
- 2 (f) Receive and distribute all sums required by the operation
- 3 of the association.
- 4 (g) Establish procedures for reviewing claims procedures and
- 5 practices of members of the association. If the claims procedures
- 6 or practices of a member are considered inadequate to properly
- 7 service the liabilities of the association, the association may
- 8 undertake or may contract with another person, including another
- 9 member, to adjust or assist in the adjustment of claims for the
- 10 member on claims that create a potential liability to the
- 11 association and may charge the cost of the adjustment to the
- member.
- 13 (8) In addition to other powers granted to it by this section,
- 14 the association may do all of the following:
- 15 (a) Sue and be sued in the name of the association. A judgment
- 16 against the association shall not create any direct liability
- 17 against the individual members of the association. The association
- 18 may provide for the indemnification of its members, members of the
- 19 board of directors of the association, and officers, employees, and
- 20 other persons lawfully acting on behalf of the association.
- 21 (b) Reinsure all or any portion of its potential liability
- 22 with reinsurers licensed to transact insurance in this state or
- 23 approved by the commissioner.
- 24 (c) Provide for appropriate housing, equipment, and personnel
- 25 as may be necessary to assure the efficient operation of the
- 26 association.
- 27 (d) Pursuant to the plan of operation, adopt reasonable rules

- 1 for the administration of the association, enforce those rules, and
- 2 delegate authority, as the board considers necessary to assure the
- 3 proper administration and operation of the association consistent
- 4 with the plan of operation.
- 5 (e) Contract for goods and services, including independent
- 6 claims management, actuarial, investment, and legal services, from
- 7 others within or without this state to assure the efficient
- 8 operation of the association.
- 9 (f) Hear and determine complaints of a company or other
- 10 interested party concerning the operation of the association.
- 11 (q) Perform other acts not specifically enumerated in this
- 12 section that are necessary or proper to accomplish the purposes of
- 13 the association and that are not inconsistent with this section or
- 14 the plan of operation.
- 15 (9) A board of directors is created, hereinafter referred to
- 16 as the board, which shall be IS responsible for the operation of
- 17 the association consistent with the plan of operation and this
- 18 section.
- 19 (10) The plan of operation shall provide for all of the
- 20 following:
- 21 (a) The establishment of necessary facilities.
- 22 (b) The management and operation of the association.
- (c) Procedures to be utilized in charging premiums, including
- 24 adjustments from excess or deficient premiums from prior periods.
- 25 (d) Procedures governing the actual payment of premiums to the
- 26 association.
- (e) Reimbursement of each member of the board by the

- 1 association for actual and necessary expenses incurred on
- 2 association business.
- 3 (f) The investment policy of the association.
- 4 (g) Any other matters required by or necessary to effectively
- 5 implement this section.
- 6 (11) Each board shall include members that would contribute a
- 7 total of not less than 40% of the total premium calculated pursuant
- 8 to subsection (7)(d). Each director shall be entitled to 1 vote.
- 9 The initial term of office of a director shall be 2 years.
- 10 (12) As part of the plan of operation, the board shall adopt
- 11 rules providing for the composition and term of successor boards to
- 12 the initial board, consistent with the membership composition
- 13 requirements in subsections (11) and (13). Terms of the directors
- 14 shall be staggered so that the terms of all the directors do not
- 15 expire at the same time and so that a director does not serve a
- 16 term of more than 4 years.
- 17 (13) The board shall consist of 5 directors, and the
- 18 commissioner shall be an ex officio member of the board without
- 19 vote.
- 20 (14) Each director shall be appointed by the commissioner and
- 21 shall serve until that member's successor is selected and
- 22 qualified. The chairperson of the board shall be elected by the
- 23 board. A vacancy on the board shall be filled by the commissioner
- 24 consistent with the plan of operation.
- 25 (15) After the board is appointed, the board shall meet as
- 26 often as the chairperson, the commissioner, or the plan of
- 27 operation shall require, or at the request of any 3 members of the

- 1 board. The chairperson shall retain the right to vote on all
- 2 issues. Four members of the board constitute a quorum.
- 3 (16) An annual report of the operations of the association in
- 4 a form and detail as may be determined by the board shall be
- 5 furnished to each member.
- 6 (17) Not more than 60 days after the initial organizational
- 7 meeting of the board, the board shall submit to the commissioner
- 8 for approval a proposed plan of operation consistent with the
- 9 objectives and provisions of this section, which shall provide for
- 10 the economical, fair, and nondiscriminatory administration of the
- 11 association and for the prompt and efficient provision of
- 12 indemnity. If a plan is not submitted within this 60-day period,
- 13 then the commissioner, after consultation with the board, shall
- 14 formulate and place into effect a plan consistent with this
- 15 section.
- 16 (18) The plan of operation, unless approved sooner in writing,
- 17 shall be considered to meet the requirements of this section if it
- 18 is not disapproved by written order of the commissioner within 30
- 19 days after the date of its submission. Before disapproval of all or
- 20 any part of the proposed plan of operation, the commissioner shall
- 21 notify the board in what respect the plan of operation fails to
- 22 meet the requirements and objectives of this section. If the board
- 23 fails to submit a revised plan of operation that meets the
- 24 requirements and objectives of this section within the 30-day
- 25 period, the commissioner shall enter an order accordingly and shall
- 26 immediately formulate and place into effect a plan consistent with
- 27 the requirements and objectives of this section.

- 1 (19) The proposed plan of operation or amendments to the plan
- 2 of operation are subject to majority approval by the board,
- 3 ratified by a majority of the membership having a vote, with voting
- 4 rights being apportioned according to the premiums charged in
- 5 subsection (7)(d) and are subject to approval by the commissioner.
- 6 (20) Upon approval by the commissioner and ratification by the
- 7 members of the plan submitted, or upon the promulgation of a plan
- 8 by the commissioner, each insurer authorized to write insurance
- 9 providing the security required by section 3101(1) in this state,
- 10 as provided in this section, is bound by and shall formally
- 11 subscribe to and participate in the plan approved as a condition of
- 12 maintaining its authority to transact insurance in this state.
- 13 (21) The association is subject to all the reporting, loss
- 14 reserve, and investment requirements of the commissioner to the
- 15 same extent as would a member of the association.
- 16 (22) Premiums charged members by the association shall be
- 17 recognized in the rate-making procedures for insurance rates in the
- 18 same manner that expenses and premium taxes are recognized.
- 19 (23) The commissioner or an authorized representative of the
- 20 commissioner may visit the association at any time and examine any
- 21 and all the association's affairs.
- 22 (24) The association does not have liability for losses
- 23 occurring before July 1, 1978.
- 24 (25) THE BUSINESS THAT THE BOARD MAY PERFORM SHALL BE
- 25 CONDUCTED AT A MEETING OF THE BOARD AS IF THE BOARD WERE A PUBLIC
- 26 BODY UNDER THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO
- 27 15.275.

- 1 (26) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 2 RETAINED BY THE BOARD IN THE PERFORMANCE OF AN OFFICIAL FUNCTION IS
- 3 SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231
- 4 TO 15.246, AS IF THE BOARD WERE A PUBLIC BODY UNDER THE FREEDOM OF

- 7 (a) "Consumer price index" means the percentage of change in
- 8 the consumer price index for all urban consumers in the United

- 11 biennial adjustment under subsection (2)(k) as reported by the
- 12 United States department of labor, bureau of labor statistics, and

- 16 (c) "Ultimate loss" means the actual loss amounts that a
