## SUBSTITUTE FOR HOUSE BILL NO. 5052

A bill to amend 1990 PA 72, entitled "Local government fiscal responsibility act,"

(MCL 141.1201 to 141.1291) by adding sections 21a and 41a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21A. (1) AN EMERGENCY FINANCIAL MANAGER APPOINTED UNDER
- 2 THIS ARTICLE SHALL FILE WITH THE GOVERNOR, THE SENATE MAJORITY
- 3 LEADER, AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND POST ON
- 4 THE INTERNET ON THE WEBSITE OF THE LOCAL UNIT OF GOVERNMENT A
- 5 REPORT THAT CONTAINS ALL OF THE FOLLOWING:
- 6 (A) A DESCRIPTION OF EACH EXPENDITURE MADE, APPROVED, OR
- 7 DISAPPROVED DURING THE REPORTING PERIOD THAT HAS A CUMULATIVE VALUE
- 8 OF \$10,000.00 OR MORE AND THE SOURCE OF THE FUNDS.
- 9 (B) A LIST OF EACH CONTRACT THAT THE EMERGENCY FINANCIAL
- 10 MANAGER AWARDED OR APPROVED WITH A CUMULATIVE VALUE OF \$10,000.00
- 11 OR MORE, THE PURPOSE OF THE CONTRACT, AND THE IDENTITY OF THE
- 12 CONTRACTOR.

- 1 (C) A DESCRIPTION OF EACH LOAN SOUGHT, APPROVED, OR
- 2 DISAPPROVED DURING THE REPORTING PERIOD THAT HAS A CUMULATIVE VALUE
- 3 OF \$10,000.00 OR MORE AND THE PROPOSED USE OF THE FUNDS.
- 4 (D) A DESCRIPTION OF ANY NEW POSITION CREATED OR ANY VACANCY
- 5 IN A PERMANENT POSITION FILLED BY THE APPOINTING AUTHORITY.
- 6 (E) A DESCRIPTION OF ANY POSITION THAT HAS BEEN ELIMINATED OR
- 7 FROM WHICH AN EMPLOYEE HAS BEEN LAID OFF.
- 8 (2) THE REPORT REQUIRED UNDER THIS SECTION SHALL BE SUBMITTED
- 9 EVERY 6 MONTHS, BEGINNING 6 MONTHS AFTER THE STARTING DATE OF THE
- 10 EMERGENCY FINANCIAL MANAGER.
- 11 SEC. 41A. (1) AN EMERGENCY FINANCIAL MANAGER APPOINTED UNDER
- 12 THIS ARTICLE SHALL FILE WITH THE GOVERNOR, THE SENATE MAJORITY
- 13 LEADER, AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND POST ON
- 14 THE INTERNET ON THE WEBSITE OF THE SCHOOL DISTRICT A REPORT THAT
- 15 CONTAINS ALL OF THE FOLLOWING:
- 16 (A) A DESCRIPTION OF EACH EXPENDITURE MADE, APPROVED, OR
- 17 DISAPPROVED DURING THE REPORTING PERIOD THAT HAS A CUMULATIVE VALUE
- 18 OF \$10,000.00 OR MORE AND THE SOURCE OF THE FUNDS.
- 19 (B) A LIST OF EACH CONTRACT THAT THE EMERGENCY FINANCIAL
- 20 MANAGER AWARDED OR APPROVED WITH A CUMULATIVE VALUE OF \$10,000.00
- 21 OR MORE, THE PURPOSE OF THE CONTRACT, AND THE IDENTITY OF THE
- 22 CONTRACTOR.
- 23 (C) A DESCRIPTION OF EACH LOAN SOUGHT, APPROVED, OR
- 24 DISAPPROVED DURING THE REPORTING PERIOD THAT HAS A CUMULATIVE VALUE
- 25 OF \$10,000.00 OR MORE AND THE PROPOSED USE OF THE FUNDS.
- 26 (D) A DESCRIPTION OF ANY NEW POSITION CREATED OR ANY VACANCY
- 27 IN A PERMANENT POSITION FILLED BY THE APPOINTING AUTHORITY.

- 1 (E) A DESCRIPTION OF ANY POSITION THAT HAS BEEN ELIMINATED OR
- 2 FROM WHICH AN EMPLOYEE HAS BEEN LAID OFF.
- 3 (2) THE REPORT REQUIRED UNDER THIS SECTION SHALL BE SUBMITTED
- EVERY 6 MONTHS, BEGINNING 6 MONTHS AFTER THE STARTING DATE OF THE 4
- 5 EMERGENCY FINANCIAL MANAGER.
