- 3 328, MCL 750.462A TO 750.462I, THE COURT SHALL ORDER RESTITUTION
- 4 FOR THE FULL AMOUNT OF LOSS SUFFERED BY THE VICTIM. IN ADDITION TO
- RESTITUTION ORDERED UNDER SECTION 16, THE COURT MAY ORDER THE
- 6 DEFENDANT TO PAY ALL OF THE FOLLOWING:
- 7 (A) LOST INCOME, CALCULATED BY WHICHEVER OF THE FOLLOWING
- METHODS RESULTS IN THE LARGEST AMOUNT:
  - (i) THE GROSS AMOUNT RECEIVED BY THE DEFENDANT FROM OR THE
