## HOUSE SUBSTITUTE FOR SENATE BILL NO. 1013

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding sections 40110a, 43528a, and 43540d; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 40110A. THE LEGISLATURE HEREBY AUTHORIZES THE
- 2 ESTABLISHMENT OF THE FIRST OPEN SEASON FOR MOOSE. THE COMMISSION
- 3 MAY ISSUE ORDERS PERTAINING TO MOOSE FOR EACH OF THE PURPOSES
- 4 LISTED IN SECTION 40113A, INCLUDING, BUT NOT LIMITED TO, ORDERS
- 5 ESTABLISHING THE FIRST OPEN SEASON FOR MOOSE.

- 1 SEC. 43528A. (1) A RESIDENT SHALL NOT HUNT MOOSE WITHOUT A
- 2 MOOSE HUNTING LICENSE. THE FEE FOR A MOOSE HUNTING LICENSE IS
- 3 \$100.00. THE DEPARTMENT MAY ESTABLISH A NONREFUNDABLE APPLICATION
- 4 FEE NOT TO EXCEED \$4.00 FOR EACH PERSON WHO APPLIES FOR A MOOSE
- 5 HUNTING LICENSE.
- 6 (2) THE DEPARTMENT MAY ISSUE A KILL TAG WITH, OR AS PART OF, A
- 7 MOOSE HUNTING LICENSE. SECTION 43526(2) APPLIES WITH RESPECT TO A
- 8 MOOSE HUNTING LICENSE.
- 9 SEC. 43540D. (1) THE MOOSE HUNTING ADVISORY COUNCIL IS CREATED
- 10 WITHIN THE DEPARTMENT.
- 11 (2) THE COUNCIL SHALL CONSIST OF THE FOLLOWING 7 MEMBERS:
- 12 (A) THE DIRECTOR OF THE DEPARTMENT, OR HIS OR HER DESIGNEE.
- 13 (B) ONE MEMBER REPRESENTING AN ORGANIZATION THAT PROMOTES
- 14 CONSERVATION IN THIS STATE APPOINTED BY THE DIRECTOR.
- 15 (C) TWO MEMBERS REPRESENTING ORGANIZATIONS THAT PROMOTE
- 16 HUNTING OR FISHING IN THIS STATE APPOINTED BY THE DIRECTOR.
- 17 (D) ONE MEMBER APPOINTED BY THE DIRECTOR FROM A LIST OF 3
- 18 NAMES PROVIDED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.
- 19 (E) ONE MEMBER APPOINTED BY THE DIRECTOR FROM A LIST OF 3
- 20 NAMES PROVIDED BY THE MAJORITY LEADER OF THE SENATE.
- 21 (F) ONE MEMBER SELECTED BY THE MICHIGAN INTERTRIBAL COUNCIL.
- 22 (3) THE MEMBERS APPOINTED TO THE COUNCIL SHALL BE APPOINTED
- 23 WITHIN 60 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 24 ADDED THIS SECTION.
- 25 (4) THE FIRST MEETING OF THE COUNCIL SHALL BE CALLED BY THE
- 26 DIRECTOR OF THE DEPARTMENT WITHIN 60 DAYS AFTER THE EFFECTIVE DATE
- 27 OF THE AMENDATORY ACT THAT ADDED THIS SECTION. AT THE FIRST

- 1 MEETING, THE COUNCIL SHALL ELECT FROM AMONG ITS MEMBERS A
- 2 CHAIRPERSON AND OTHER OFFICERS AS IT CONSIDERS NECESSARY OR
- 3 APPROPRIATE. AFTER THE FIRST MEETING, THE COUNCIL SHALL MEET AT
- 4 LEAST QUARTERLY, OR MORE FREQUENTLY AT THE CALL OF THE CHAIRPERSON
- 5 OR IF REQUESTED BY A MAJORITY OF THE MEMBERS.
- 6 (5) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A
- 7 QUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE COUNCIL.
- 8 A MAJORITY OF THE MEMBERS PRESENT AND SERVING ARE REQUIRED FOR
- 9 OFFICIAL ACTION OF THE COUNCIL.
- 10 (6) THE BUSINESS THAT THE COUNCIL MAY PERFORM SHALL BE
- 11 CONDUCTED AT A PUBLIC MEETING OF THE COUNCIL HELD IN COMPLIANCE
- 12 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 13 (7) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 14 RETAINED BY THE COUNCIL IN THE PERFORMANCE OF AN OFFICIAL FUNCTION
- 15 IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL
- 16 15.231 TO 15.246.
- 17 (8) MEMBERS OF THE COUNCIL SHALL SERVE WITHOUT COMPENSATION.
- 18 HOWEVER, MEMBERS OF THE COUNCIL MAY BE REIMBURSED FOR THEIR ACTUAL
- 19 AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR
- 20 OFFICIAL DUTIES AS MEMBERS OF THE COUNCIL.
- 21 (9) THE COUNCIL SHALL, WITHIN 12 MONTHS AFTER THE EFFECTIVE
- 22 DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION, SUBMIT TO THE
- 23 DEPARTMENT, COMMISSION, AND THE LEGISLATURE A REPORT THAT MAKES
- 24 RECOMMENDATIONS ON WHETHER THE MOOSE HUNTING SEASON ESTABLISHED
- 25 PURSUANT TO SECTION 40110A SHOULD BE EXPANDED IN THIS STATE. THE
- 26 REPORT SHALL TAKE INTO ACCOUNT THE EFFECT AN EXPANDED MOOSE HUNTING
- 27 SEASON WOULD HAVE ON THE MOOSE POPULATION IN THIS STATE AND THE

- POTENTIAL ECONOMIC BENEFITS OF SUCH A SEASON. IF THE COUNCIL 1
- 2 RECOMMENDS AN EXPANDED MOOSE HUNTING SEASON, THE REPORT SHALL ALSO
- CONTAIN A RECOMMENDED SEASON LENGTH AND THE NUMBER OF MOOSE TO BE 3
- 4 TAKEN.
- 5 (10) THIS SECTION IS REPEALED EFFECTIVE 12 MONTHS AFTER THE
- EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
