- 24 ON A 4.0 SCALE OR THE EQUIVALENT ON ANOTHER SCALE, AS DETERMINED BY
- 25 THE SUPERINTENDENT OF PUBLIC INSTRUCTION.
- 26 (C) PASSES APPLICABLE EXAMINATIONS AS FOLLOWS:
- 27 (i) FOR TEACHING AT THE SECONDARY LEVEL UNDER AN INTERIM
