SUBSTITUTE FOR SENATE BILL NO. 1013

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding sections 40110a, 43528a, and 43540d; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 40110A. WITHIN 1 YEAR OF THE EFFECTIVE DATE OF THE
- 2 AMENDATORY ACT THAT ADDED THIS SECTION, THE COMMISSION SHALL ISSUE
- 3 ORDERS UNDER SECTION 40113A ESTABLISHING AN ANNUAL MOOSE HUNTING
- 4 SEASON. THE ORDERS SHALL PROVIDE THAT AT LEAST 1 MOOSE MAY BE TAKEN
- 5 DURING EACH MOOSE HUNTING SEASON.
- 6 SEC. 43528A. (1) A RESIDENT SHALL NOT HUNT MOOSE WITHOUT A
- 7 MOOSE HUNTING LICENSE. THE FEE FOR A MOOSE HUNTING LICENSE IS
- 8 \$100.00. THE DEPARTMENT MAY ESTABLISH A NONREFUNDABLE APPLICATION

- 1 FEE NOT TO EXCEED \$4.00 FOR EACH PERSON WHO APPLIES FOR A MOOSE
- 2 HUNTING LICENSE.
- 3 (2) THE DEPARTMENT MAY ISSUE A KILL TAG WITH, OR AS PART OF, A
- 4 MOOSE HUNTING LICENSE. SECTION 43526(2) APPLIES WITH RESPECT TO A
- 5 MOOSE HUNTING LICENSE.
- 6 SEC. 43540D. (1) THE MOOSE HUNTING ADVISORY COUNCIL IS CREATED
- 7 WITHIN THE DEPARTMENT.
- 8 (2) THE COUNCIL SHALL CONSIST OF THE FOLLOWING 7 MEMBERS:
- 9 (A) THE DIRECTOR OF THE DEPARTMENT, OR HIS OR HER DESIGNEE.
- 10 (B) ONE MEMBER REPRESENTING AN ORGANIZATION THAT PROMOTES
- 11 CONSERVATION IN THIS STATE APPOINTED BY THE DIRECTOR.
- 12 (C) TWO MEMBERS REPRESENTING ORGANIZATIONS THAT PROMOTE
- 13 HUNTING OR FISHING IN THIS STATE APPOINTED BY THE DIRECTOR.
- 14 (D) ONE MEMBER APPOINTED BY THE DIRECTOR FROM A LIST OF 3
- 15 NAMES PROVIDED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.
- 16 (E) ONE MEMBER APPOINTED BY THE DIRECTOR FROM A LIST OF 3
- 17 NAMES PROVIDED BY THE MAJORITY LEADER OF THE SENATE.
- 18 (F) ONE MEMBER SELECTED BY THE MICHIGAN INTERTRIBAL COUNCIL.
- 19 (3) THE MEMBERS APPOINTED TO THE COUNCIL SHALL BE APPOINTED
- 20 WITHIN 60 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 21 ADDED THIS SECTION.
- 22 (4) THE FIRST MEETING OF THE COUNCIL SHALL BE CALLED BY THE
- 23 DIRECTOR OF THE DEPARTMENT WITHIN 60 DAYS AFTER THE EFFECTIVE DATE
- 24 OF THE AMENDATORY ACT THAT ADDED THIS SECTION. AT THE FIRST
- 25 MEETING, THE COUNCIL SHALL ELECT FROM AMONG ITS MEMBERS A
- 26 CHAIRPERSON AND OTHER OFFICERS AS IT CONSIDERS NECESSARY OR
- 27 APPROPRIATE. AFTER THE FIRST MEETING, THE COUNCIL SHALL MEET AT

- 1 LEAST QUARTERLY, OR MORE FREQUENTLY AT THE CALL OF THE CHAIRPERSON
- 2 OR IF REQUESTED BY A MAJORITY OF THE MEMBERS.
- 3 (5) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A
- 4 QUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE COUNCIL.
- 5 A MAJORITY OF THE MEMBERS PRESENT AND SERVING ARE REQUIRED FOR
- 6 OFFICIAL ACTION OF THE COUNCIL.
- 7 (6) THE BUSINESS THAT THE COUNCIL MAY PERFORM SHALL BE
- 8 CONDUCTED AT A PUBLIC MEETING OF THE COUNCIL HELD IN COMPLIANCE
- 9 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 10 (7) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 11 RETAINED BY THE COUNCIL IN THE PERFORMANCE OF AN OFFICIAL FUNCTION
- 12 IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL
- 13 15.231 TO 15.246.
- 14 (8) MEMBERS OF THE COUNCIL SHALL SERVE WITHOUT COMPENSATION.
- 15 HOWEVER, MEMBERS OF THE COUNCIL MAY BE REIMBURSED FOR THEIR ACTUAL
- 16 AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR
- 17 OFFICIAL DUTIES AS MEMBERS OF THE COUNCIL.
- 18 (9) THE COUNCIL SHALL, WITHIN 12 MONTHS AFTER THE EFFECTIVE
- 19 DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION, SUBMIT TO THE
- 20 DEPARTMENT, COMMISSION, AND THE LEGISLATURE A REPORT THAT MAKES
- 21 RECOMMENDATIONS ON WHETHER THE MOOSE HUNTING SEASON ESTABLISHED
- 22 PURSUANT TO SECTION 40110A SHOULD BE EXPANDED IN THIS STATE. THE
- 23 REPORT SHALL TAKE INTO ACCOUNT THE EFFECT AN EXPANDED MOOSE HUNTING
- 24 SEASON WOULD HAVE ON THE MOOSE POPULATION IN THIS STATE AND THE
- 25 POTENTIAL ECONOMIC BENEFITS OF SUCH A SEASON. IF THE COUNCIL
- 26 RECOMMENDS AN EXPANDED MOOSE HUNTING SEASON, THE REPORT SHALL ALSO
- 27 CONTAIN A RECOMMENDED SEASON LENGTH AND THE NUMBER OF MOOSE TO BE

- 1 TAKEN.
- (10) THIS SECTION IS REPEALED EFFECTIVE 12 MONTHS AFTER THE 2
- 3 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
