SEC. 21A. (1) AN EMERGENCY FINANCIAL MANAGER APPOINTED UNDER THIS ARTICLE SHALL FILE A REPORT WITH THE GOVERNOR, THE SENATE 2 3 MAJORITY LEADER, AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES 4 THAT CONTAINS ALL OF THE FOLLOWING:

5 (A) A DESCRIPTION OF EACH EXPENDITURE MADE, APPROVED, OR DISAPPROVED DURING THE REPORTING PERIOD THAT HAS A VALUE OF 6 7 \$10,000.00 OR MORE AND THE SOURCE OF THE FUNDS.

(B) A LIST OF EACH CONTRACT THAT THE EMERGENCY FINANCIAL 8 9 MANAGER AWARDED OR APPROVED WITH A VALUE OF \$10,000.00 OR MORE, THE 10 PURPOSE OF THE CONTRACT, AND THE IDENTITY OF THE CONTRACTOR.
