THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 72. NOT LATER THAN THE 2011-2012 STATE FISCAL YEAR, THE
 LEGISLATURE SHALL ENACT A SYSTEM OF STATE FUNDING FOR DISTRICTS
 THAT DOES ALL OF THE FOLLOWING REGARDING TRANSPORTATION FUNDING:

4 (A) DETERMINES THE TOTAL AMOUNT OF STATE FUNDING EXPENDED BY
5 ALL DISTRICTS FOR TRANSPORTATION, OTHER THAN SPECIAL EDUCATION
6 TRANSPORTATION, FOR THE STATE FISCAL YEAR IMMEDIATELY PRECEDING THE
7 STATE FISCAL YEAR FOR WHICH MONEY IS BEING APPROPRIATED.

8 (B) REDUCES THE TOTAL AMOUNT OF FUNDING ALLOCATED TO ALL 9 DISTRICTS FOR PAYMENT OF THE STATE PORTION OF FOUNDATION ALLOWANCES 10 AND PER PUPIL PAYMENTS CALCULATED UNDER SECTION 20 BY AN AMOUNT

8 (D) ALLOCATES AN AMOUNT EQUAL TO THE TOTAL AMOUNT DETERMINED 9 UNDER SUBDIVISION (A) FOR A SEPARATE PAYMENT TO EACH DISTRICT IN 10 THE AMOUNT NECESSARY TO REIMBURSE THE DISTRICT FOR THE AMOUNT OF 11 STATE FUNDING EXPENDED BY THE DISTRICT FOR TRANSPORTATION, OTHER 12 THAN SPECIAL EDUCATION TRANSPORTATION, FOR THE STATE FISCAL YEAR 13 IMMEDIATELY PRECEDING THE STATE FISCAL YEAR FOR WHICH MONEY IS 14 BEING APPROPRIATED.
