HOUSE BILL No. 6358

July 28, 2010, Introduced by Rep. Haveman and referred to the Committee on New Economy and Quality of Life.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 20114a, 20120a, 20120b, 20120c, and 20120d
(MCL 324.20114a, 324.20120a, 324.20120b, 324.20120c, and
324.20120d), section 20114a as amended by 1996 PA 115, sections
20120a, 20120b, and 20120c as added by 1995 PA 71, and section
20120d as amended by 1996 PA 383, and by adding sections 20114b,
20114c, 20114d, 20120, and 20120e; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 20114a. (1) A person who, after June 5, 1995, is responsible for an activity causing a release in excess of the concentrations that satisfy the criteria established pursuant to section 20120a(1)(a) through (e), as appropriate for the use of the property, is subject to a civil fine as provided in this part

- 1 unless a fine or penalty has already been imposed for the release
- 2 under another part of this act. However, a civil fine shall not be
- 3 imposed under this section against a person who made a good faith
- 4 effort to prevent the release and to comply with the provisions of
- 5 this part.
- 6 (2) This section does not apply to a release from an
- 7 underground storage tank system as defined in part 213.
- 8 (1) SUBJECT TO SECTION 20114 AND OTHER APPLICABLE LAW, A
- 9 PERSON MAY UNDERTAKE RESPONSE ACTIVITIES WITHOUT PRIOR APPROVAL BY
- 10 THE DEPARTMENT UNLESS 1 OR MORE RESPONSE ACTIVITIES ARE BEING
- 11 CONDUCTED PURSUANT TO AN ADMINISTRATIVE ORDER OR AGREEMENT OR
- 12 JUDICIAL DECREE THAT REQUIRES PRIOR DEPARTMENT APPROVAL. EXCEPT AS
- 13 OTHERWISE PROVIDED IN THIS PART, CONDUCTING RESPONSE ACTIVITIES
- 14 UNDER THIS SECTION DOES NOT RELIEVE ANY PERSON WHO IS LIABLE UNDER
- 15 THIS PART FROM THE OBLIGATION TO CONDUCT FURTHER RESPONSE
- 16 ACTIVITIES AS MAY BE REQUIRED BY THE DEPARTMENT UNDER THIS PART OR
- 17 OTHER APPLICABLE LAW.
- 18 (2) UPON COMPLETION OF REMEDIAL ACTIONS THAT SATISFY THE
- 19 CLEANUP CRITERIA ESTABLISHED UNDER THIS PART, A PERSON UNDERTAKING
- 20 REMEDIAL ACTIONS MAY SUBMIT TO THE DEPARTMENT A NO FURTHER ACTION
- 21 REPORT.
- 22 SEC. 20114B. (1) SUBJECT TO SECTION 20114(1)(H), A PERSON
- 23 UNDERTAKING RESPONSE ACTIVITY UNDER THIS PART MAY SUBMIT TO THE
- 24 DEPARTMENT A RESPONSE ACTIVITY PLAN THAT INCLUDES A REQUEST FOR
- 25 DEPARTMENT APPROVAL OF 1 OR MORE ASPECTS OF RESPONSE ACTIVITY.
- 26 (2) A PERSON WHO SUBMITS A RESPONSE ACTIVITY PLAN UNDER THIS
- 27 SECTION AND WHO IS NOT SUBJECT TO AN ADMINISTRATIVE ORDER OR

- 1 AGREEMENT OR JUDICIAL DECREE THAT REQUIRES PRIOR DEPARTMENT
- 2 APPROVAL OF RESPONSE ACTIVITY SHALL SUBMIT A RESPONSE ACTIVITY PLAN
- 3 REVIEW REQUEST FORM WITH THE RESPONSE ACTIVITY PLAN. THE DEPARTMENT
- 4 SHALL SPECIFY THE REQUIRED CONTENT OF THE RESPONSE ACTIVITY REQUEST
- 5 FORM AND MAKE THE FORM AVAILABLE ON THE DEPARTMENT'S WEBSITE.
- 6 (3) UPON RECEIPT OF A RESPONSE ACTIVITY PLAN SUBMITTED FOR
- 7 APPROVAL UNDER THIS SUBSECTION, THE DEPARTMENT SHALL APPROVE,
- 8 APPROVE WITH CONDITIONS, OR DENY THE RESPONSE ACTIVITY PLAN, OR
- 9 SHALL NOTIFY THE SUBMITTER THAT THE PLAN DOES NOT CONTAIN
- 10 SUFFICIENT INFORMATION FOR THE DEPARTMENT TO MAKE A DECISION. THE
- 11 DEPARTMENT SHALL PROVIDE ITS DETERMINATION WITHIN 150 DAYS AFTER
- 12 THE PLAN WAS RECEIVED BY THE DEPARTMENT UNLESS THE PLAN REQUIRES
- 13 PUBLIC PARTICIPATION UNDER SECTION 20120D(2). IF THE PLAN REQUIRES
- 14 PUBLIC PARTICIPATION UNDER SECTION 20120D(2), THE DEPARTMENT SHALL
- 15 RESPOND WITHIN 180 DAYS. IF THE DEPARTMENT'S RESPONSE IS THAT THE
- 16 PLAN DOES NOT INCLUDE SUFFICIENT INFORMATION, THE DEPARTMENT SHALL
- 17 IDENTIFY THE INFORMATION THAT IS REQUIRED FOR THE DEPARTMENT TO
- 18 MAKE A DECISION. IF A PLAN IS APPROVED WITH CONDITIONS, THE
- 19 DEPARTMENT'S APPROVAL SHALL STATE WITH SPECIFICITY THE CONDITIONS
- 20 OF THE APPROVAL. IF THE PLAN IS DENIED, THE DEPARTMENT'S DENIAL
- 21 SHALL, TO THE EXTENT PRACTICAL, STATE WITH SPECIFICITY ALL OF THE
- 22 REASONS FOR DENIAL.
- 23 (4) IF THE DEPARTMENT FAILS TO PROVIDE A WRITTEN RESPONSE
- 24 WITHIN THE TIME FRAMES REQUIRED BY SUBSECTION (3), THE RESPONSE
- 25 ACTIVITY PLAN IS CONSIDERED APPROVED. IF THE DEPARTMENT DENIES A
- 26 RESPONSE ACTIVITY PLAN UNDER SUBSECTION (3), A PERSON MAY
- 27 SUBSEQUENTLY REVISE AND RESUBMIT THE RESPONSE ACTIVITY PLAN FOR

- 1 APPROVAL.
- 2 (5) ANY TIME FRAME REQUIRED BY THIS SECTION MAY BE EXTENDED BY
- 3 MUTUAL AGREEMENT OF THE DEPARTMENT AND A PERSON SUBMITTING A
- 4 RESPONSE ACTIVITY PLAN. AN AGREEMENT EXTENDING A TIME FRAME SHALL
- 5 BE IN WRITING.
- 6 (6) A PERSON REQUESTING APPROVAL OF A RESPONSE ACTIVITY PLAN
- 7 MAY APPEAL THE DEPARTMENT'S DECISION IN ACCORDANCE WITH SECTION
- 8 20114E, IF APPLICABLE.
- 9 SEC. 20114C. (1) IF REMEDIAL ACTIONS AT A FACILITY SATISFY
- 10 CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE, LAND USE OR
- 11 RESOURCE USE RESTRICTIONS OR MONITORING IS NOT REQUIRED.
- 12 (2) UPON COMPLETION OF REMEDIAL ACTIONS AT A FACILITY FOR A
- 13 CATEGORY OF CLEANUP THAT DOES NOT SATISFY CLEANUP CRITERIA FOR
- 14 UNRESTRICTED RESIDENTIAL USE, THE PERSON CONDUCTING THE REMEDIAL
- 15 ACTIONS SHALL PREPARE AND IMPLEMENT A POSTCLOSURE PLAN FOR THAT
- 16 FACILITY. A POSTCLOSURE PLAN SHALL INCLUDE BOTH OF THE FOLLOWING:
- 17 (A) LAND USE OR RESOURCE USE RESTRICTIONS AS PROVIDED IN
- 18 SUBSECTION (3).
- 19 (B) PERMANENT MARKERS TO DESCRIBE RESTRICTED AREAS OF THE
- 20 FACILITY AND THE NATURE OF ANY RESTRICTIONS. A PERMANENT MARKER IS
- 21 NOT REQUIRED UNDER THIS SUBDIVISION IF THE ONLY APPLICABLE LAND USE
- 22 OR RESOURCE USE RESTRICTIONS RELATE TO 1 OR MORE OF THE FOLLOWING:
- 23 (i) A FACILITY AT WHICH REMEDIAL ACTION SATISFIES THE CLEANUP
- 24 CRITERIA FOR THE NONRESIDENTIAL CATEGORY UNDER SECTION
- 25 20120A(1)(B).
- (ii) USE OF GROUNDWATER.
- 27 (iii) PROTECTION OF THE INTEGRITY OF EXPOSURE CONTROLS THAT

- 1 PREVENT CONTACT WITH SOIL, AND THOSE CONTROLS ARE COMPOSED SOLELY
- 2 OF ASPHALT, CONCRETE, OR LANDSCAPING MATERIALS. THIS SUBPARAGRAPH
- 3 DOES NOT APPLY IF THE HAZARDOUS SUBSTANCES THAT ARE ADDRESSED BY
- 4 THE BARRIER EXCEED A CLEANUP CRITERION BASED ON ACUTE TOXIC
- 5 EFFECTS, REACTIVITY, CORROSIVITY, IGNITABILITY, EXPLOSIVITY, OR
- 6 FLAMMABILITY, OR IF ANY HAZARDOUS SUBSTANCE ADDRESSED BY THE
- 7 EXPOSURE CONTROL IS PRESENT AT A CONCENTRATION OF MORE THAN 10
- 8 TIMES AN APPLICABLE SOIL DIRECT CONTACT CLEANUP CRITERION.
- 9 (iv) CONSTRUCTION REQUIREMENTS OR LIMITATIONS FOR STRUCTURES
- 10 THAT MAY BE BUILT IN THE FUTURE.
- 11 (3) LAND USE OR RESOURCE USE RESTRICTIONS THAT ASSURE THE
- 12 EFFECTIVENESS AND INTEGRITY OF ANY CONTAINMENT, EXPOSURE BARRIER,
- 13 OR OTHER LAND USE OR RESOURCE USE RESTRICTIONS NECESSARY TO ASSURE
- 14 THE EFFECTIVENESS AND INTEGRITY OF THE REMEDY SHALL BE DESCRIBED IN
- 15 A RESTRICTIVE COVENANT. A RESTRICTIVE COVENANT DEVELOPED TO COMPLY
- 16 WITH THIS PART SHALL BE IN A FORMAT MADE AVAILABLE ON THE
- 17 DEPARTMENT'S WEBSITE, WITH MODIFICATIONS TO REFLECT THE FACTS
- 18 APPLICABLE TO THE FACILITY. THE RESTRICTIVE COVENANT SHALL BE
- 19 RECORDED WITH THE REGISTER OF DEEDS FOR THE COUNTY IN WHICH THE
- 20 PROPERTY IS LOCATED WITHIN 21 DAYS AFTER THE COMPLETION OF THE
- 21 REMEDIAL ACTIONS OR WITHIN 21 DAYS AFTER THE COMPLETION OF
- 22 CONSTRUCTION OF THE CONTAINMENT OR BARRIER, AS APPROPRIATE. THE
- 23 RESTRICTIVE COVENANT SHALL ONLY BE RECORDED BY THE PROPERTY OWNER
- 24 OR WITH THE EXPRESS WRITTEN PERMISSION OF THE PROPERTY OWNER. THE
- 25 RESTRICTIONS SHALL RUN WITH THE LAND AND BE BINDING ON THE OWNER'S
- 26 SUCCESSORS, ASSIGNS, AND LESSEES. THE RESTRICTIVE COVENANT SHALL
- 27 INCLUDE A SURVEY AND PROPERTY DESCRIPTION THAT DEFINE THE AREAS

- 1 ADDRESSED BY THE REMEDIAL ACTIONS AND THE SCOPE OF ANY LAND USE OR
- 2 RESOURCE USE RESTRICTIONS. AT A MINIMUM, THE RESTRICTIVE COVENANT
- 3 SHALL DO ALL OF THE FOLLOWING:
- 4 (A) DESCRIBE THE GENERAL USES OF THE PROPERTY THAT ARE
- 5 CONSISTENT WITH THE CLEANUP CRITERIA.
- 6 (B) RESTRICT ACTIVITIES AT THE FACILITY THAT MAY INTERFERE
- 7 WITH REMEDIAL ACTIONS, OPERATION AND MAINTENANCE, MONITORING, OR
- 8 OTHER MEASURES NECESSARY TO ASSURE THE EFFECTIVENESS AND INTEGRITY
- 9 OF THE REMEDIAL ACTIONS.
- 10 (C) RESTRICT ACTIVITIES THAT MAY RESULT IN EXPOSURES ABOVE
- 11 LEVELS ATTAINED IN THE REMEDIAL ACTIONS.
- 12 (D) GRANT TO THE DEPARTMENT THE ABILITY TO ENFORCE THE
- 13 RESTRICTIVE COVENANT BY LEGAL ACTION IN A COURT OF APPROPRIATE
- 14 JURISDICTION.
- 15 (4) A PERSON SHALL NOT RECORD A RESTRICTIVE COVENANT
- 16 INDICATING APPROVAL BY THE DEPARTMENT UNLESS THE DEPARTMENT HAS
- 17 APPROVED THE RECORDING OF THE RESTRICTIVE COVENANT.
- 18 (5) A PERSON WHO IMPLEMENTS A POSTCLOSURE PLAN SHALL PROVIDE
- 19 NOTICE OF THE LAND USE OR RESOURCE USE RESTRICTIONS TO THE
- 20 DEPARTMENT AND TO THE ZONING AUTHORITY FOR THE LOCAL UNIT OF
- 21 GOVERNMENT IN WHICH THE FACILITY IS LOCATED WITHIN 30 DAYS AFTER
- 22 RECORDING THE LAND USE OR RESOURCE USE RESTRICTIONS WITH THE
- 23 REGISTER OF DEEDS.
- 24 (6) THE DEPARTMENT, WITH THE APPROVAL OF THE STATE
- 25 ADMINISTRATIVE BOARD, MAY PLACE RESTRICTIVE COVENANTS RELATED TO
- 26 LAND USE OR RESOURCE USE RESTRICTIONS ON DEEDS OF STATE-OWNED
- 27 PROPERTY.

- 1 (7) IMPLEMENTATION OF REMEDIAL ACTIONS DOES NOT RELIEVE A
- 2 PERSON WHO IS LIABLE UNDER SECTION 20126 OF THAT PERSON'S
- 3 RESPONSIBILITY TO REPORT AND PROVIDE FOR RESPONSE ACTIVITY TO
- 4 ADDRESS A SUBSEQUENT RELEASE OR THREAT OF RELEASE.
- 5 (8) IMPLEMENTATION BY ANY PERSON OF REMEDIAL ACTIONS WITHOUT
- 6 DEPARTMENT APPROVAL DOES NOT RELIEVE THAT PERSON OF AN OBLIGATION
- 7 TO UNDERTAKE RESPONSE ACTIVITIES OR LIMIT THE ABILITY OF THE
- 8 DEPARTMENT TO TAKE ACTION TO REQUIRE RESPONSE ACTIVITIES NECESSARY
- 9 TO COMPLY WITH THIS PART BY A PERSON WHO IS LIABLE UNDER SECTION
- 10 20126.
- 11 SEC. 20114D. (1) UPON COMPLETION OF REMEDIAL ACTIONS THAT
- 12 SATISFY APPLICABLE CLEANUP CRITERIA ESTABLISHED UNDER THIS PART,
- 13 AND ALL OTHER REQUIREMENTS OF THIS PART THAT ARE APPLICABLE TO

- 23 SHALL BE SUBMITTED WITH THE FOLLOWING, AS APPLICABLE:
- 24 (A) IF THE REMEDIAL ACTION AT THE FACILITY SATISFIES THE
- 25 CLEANUP CRITERIA FOR UNRESTRICTED RESIDENTIAL USE, NEITHER A
- 26 POSTCLOSURE PLAN OR A PROPOSED POSTCLOSURE AGREEMENT IS REQUIRED TO
- 27 BE SUBMITTED.

- 1 (B) IF THE REMEDIAL ACTION REQUIRES ONLY LAND USE OR RESOURCE
- 2 USE RESTRICTIONS AND FINANCIAL ASSURANCE IS NOT REQUIRED OR THE
- 3 FINANCIAL ASSURANCE IS DE MINIMIS, A POSTCLOSURE PLAN IS REQUIRED
- 4 BUT A PROPOSED POSTCLOSURE AGREEMENT IS NOT REQUIRED TO BE
- 5 SUBMITTED.
- 6 (C) FOR FACILITIES OTHER THAN THOSE DESCRIBED IN SUBDIVISION
- 7 (A) OR (B), A POSTCLOSURE PLAN AND A PROPOSED POSTCLOSURE AGREEMENT
- 8 ARE REQUIRED TO BE SUBMITTED.
- 9 (3) A PROPOSED POSTCLOSURE AGREEMENT THAT IS SUBMITTED AS PART
- 10 OF A NO FURTHER ACTION REPORT SHALL INCLUDE ALL OF THE FOLLOWING:
- 11 (A) PROVISIONS FOR MONITORING, OPERATION AND MAINTENANCE, AND
- 12 OVERSIGHT NECESSARY TO ASSURE THE EFFECTIVENESS AND INTEGRITY OF
- 13 THE REMEDIAL ACTION.
- 14 (B) FINANCIAL ASSURANCE TO PAY FOR MONITORING, OPERATION AND
- 15 MAINTENANCE, OVERSIGHT, AND OTHER COSTS DETERMINED BY THE
- 16 DEPARTMENT TO BE NECESSARY TO ASSURE THE EFFECTIVENESS AND
- 17 INTEGRITY OF THE REMEDIAL ACTION.
- 18 (C) A PROVISION REQUIRING NOTICE TO THE DEPARTMENT OF THE
- 19 OWNER'S INTENT TO CONVEY ANY INTEREST IN THE FACILITY 14 DAYS PRIOR
- 20 TO CONSUMMATING THE CONVEYANCE. A CONVEYANCE OF TITLE, AN EASEMENT,
- 21 OR OTHER INTEREST IN THE PROPERTY SHALL NOT BE CONSUMMATED BY THE
- 22 PROPERTY OWNER WITHOUT ADEQUATE AND COMPLETE PROVISION FOR
- 23 COMPLIANCE WITH THE TERMS AND CONDITIONS OF THE POSTCLOSURE PLAN
- 24 AND THE POSTCLOSURE AGREEMENT.
- 25 (D) A PROVISION GRANTING THE DEPARTMENT THE RIGHT TO ENTER THE
- 26 PROPERTY AT REASONABLE TIMES FOR THE PURPOSE OF DETERMINING AND
- 27 MONITORING COMPLIANCE WITH THE POSTCLOSURE PLAN AND POSTCLOSURE

- 1 AGREEMENT, INCLUDING THE RIGHT TO TAKE SAMPLES, INSPECT THE
- 2 OPERATION OF THE REMEDIAL ACTION MEASURES, AND INSPECT RECORDS.
- 3 (4) A POSTCLOSURE AGREEMENT MAY MODIFY THE TERMS OF A
- 4 POSTCLOSURE PLAN AS FOLLOWS:
- 5 (A) IF THE EXPOSURE TO HAZARDOUS SUBSTANCES MAY BE RELIABLY
- 6 RESTRICTED BY AN INSTITUTIONAL CONTROL IN LIEU OF A RESTRICTIVE
- 7 COVENANT, AND IMPOSITION OF LAND USE OR RESOURCE USE RESTRICTIONS
- 8 THROUGH RESTRICTIVE COVENANTS IS IMPRACTICAL, THE POSTCLOSURE
- 9 AGREEMENT MAY ALLOW FOR A REMEDIAL ACTION UNDER SECTION
- 10 20120A(1)(C) OR (D) OR (2) TO RELY ON AN INSTITUTIONAL CONTROL IN
- 11 LIEU OF A RESTRICTIVE COVENANT IN A POSTCLOSURE PLAN. MECHANISMS
- 12 THAT MAY BE CONSIDERED UNDER THIS SUBSECTION INCLUDE, BUT ARE NOT
- 13 LIMITED TO, AN ORDINANCE THAT RESTRICTS THE USE OF GROUNDWATER OR
- 14 AN AQUIFER IN A MANNER AND TO A DEGREE THAT PROTECTS AGAINST
- 15 UNACCEPTABLE EXPOSURES. AN ORDINANCE THAT SERVES AS AN EXPOSURE
- 16 CONTROL PURSUANT TO THIS SUBSECTION SHALL BE PUBLISHED AND
- 17 MAINTAINED IN THE SAME MANNER AS ZONING ORDINANCES AND SHALL
- 18 INCLUDE A REQUIREMENT THAT THE LOCAL UNIT OF GOVERNMENT NOTIFY THE
- 19 DEPARTMENT AT LEAST 30 DAYS PRIOR TO ADOPTING A MODIFICATION TO THE
- 20 ORDINANCE, OR TO THE LAPSING OR REVOCATION OF THE ORDINANCE.
- 21 (B) A POSTCLOSURE AGREEMENT MAY WAIVE THE REQUIREMENT FOR
- 22 PERMANENT MARKERS.
- 23 (5) THE PERSON SUBMITTING A NO FURTHER ACTION REPORT SHALL
- 24 INCLUDE A SIGNED AFFIDAVIT ATTESTING TO THE FACT THAT THE
- 25 INFORMATION UPON WHICH THE NO FURTHER ACTION REPORT IS BASED IS
- 26 COMPLETE AND TRUE TO THE BEST OF THAT PERSON'S KNOWLEDGE. THE NO
- 27 FURTHER ACTION REPORT SHALL ALSO INCLUDE A SIGNED AFFIDAVIT FROM AN

- 1 ENVIRONMENTAL CONSULTANT WHO MEETS THE PROFESSIONAL QUALIFICATIONS
- 2 DESCRIBED IN SECTION 20114E(2) AND WHO PREPARED THE NO FURTHER
- 3 ACTION REPORT, ATTESTING TO THE FACT THAT THE REMEDIAL ACTIONS
- 4 DETAILED IN THE NO FURTHER ACTION REPORT COMPLY WITH ALL APPLICABLE
- 5 REQUIREMENTS AND THAT THE INFORMATION UPON WHICH THE NO FURTHER
- 6 ACTION REPORT IS BASED IS COMPLETE AND TRUE TO THE BEST OF THAT
- 7 PERSON'S KNOWLEDGE. IN ADDITION, THE ENVIRONMENTAL CONSULTANT SHALL
- 8 ATTACH A CERTIFICATE OF INSURANCE DEMONSTRATING THAT THE
- 9 ENVIRONMENTAL CONSULTANT HAS OBTAINED AT LEAST ALL OF THE FOLLOWING
- 10 FROM A CARRIER THAT IS AUTHORIZED TO CONDUCT BUSINESS IN THIS
- 11 STATE:
- 12 (A) STATUTORY WORKER COMPENSATION INSURANCE AS REQUIRED IN
- 13 THIS STATE.
- 14 (B) PROFESSIONAL LIABILITY ERRORS AND OMISSIONS INSURANCE.
- 15 THIS POLICY MAY NOT EXCLUDE BODILY INJURY, PROPERTY DAMAGE, OR
- 16 CLAIMS ARISING OUT OF POLLUTION FOR ENVIRONMENTAL WORK AND SHALL BE
