SENATE BILL No. 728

August 5, 2009, Introduced by Senator STAMAS and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 653c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 653C. (1) UPON APPROACHING AND PASSING A STATIONARY
 2 POSTAL DELIVERY VEHICLE, THE DRIVER OF AN APPROACHING VEHICLE SHALL
 3 EXHIBIT DUE CARE AND CAUTION, AS REQUIRED UNDER THE FOLLOWING:
 - (A) ON ANY PUBLIC ROADWAY WITH AT LEAST 2 ADJACENT LANES
 PROCEEDING IN THE SAME DIRECTION OF THE STATIONARY POSTAL DELIVERY
 VEHICLE, THE DRIVER OF THE APPROACHING VEHICLE SHALL PROCEED WITH
 CAUTION AND YIELD THE RIGHT-OF-WAY BY MOVING INTO A LANE AT LEAST 1
 MOVING LANE OR 2 VEHICLE WIDTHS APART FROM THE STATIONARY POSTAL
 DELIVERY VEHICLE, UNLESS DIRECTED OTHERWISE BY A POLICE OFFICER. IF

- 1 MOVEMENT TO AN ADJACENT LANE OR 2 VEHICLE WIDTHS APART IS NOT
- 2 POSSIBLE DUE TO WEATHER, ROAD CONDITIONS, OR THE IMMEDIATE PRESENCE
- 3 OF VEHICULAR OR PEDESTRIAN TRAFFIC IN PARALLEL MOVING LANES, THE
- 4 DRIVER OF THE APPROACHING VEHICLE SHALL PROCEED AS REQUIRED IN
- 5 SUBDIVISION (B).
- 6 (B) ON ANY PUBLIC ROADWAY THAT DOES NOT HAVE AT LEAST 2
- 7 ADJACENT LANES PROCEEDING IN THE SAME DIRECTION AS THE STATIONARY
- 8 POSTAL DELIVERY VEHICLE, OR IF THE MOVEMENT BY THE DRIVER OF THE
- 9 VEHICLE INTO AN ADJACENT LANE OR 2 VEHICLE WIDTHS APART IS NOT
- 10 POSSIBLE AS DESCRIBED IN SUBDIVISION (A), THE APPROACHING VEHICLE
- 11 SHALL REDUCE AND MAINTAIN A SAFE SPEED FOR WEATHER, ROAD
- 12 CONDITIONS, AND VEHICULAR OR PEDESTRIAN TRAFFIC AND PROCEED WITH
- 13 DUE CARE AND CAUTION, OR AS DIRECTED BY A POLICE OFFICER.
- 14 (2) EXCEPT AS PROVIDED IN SUBSECTIONS (3) AND (4), A PERSON
- 15 WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR PUNISHABLE BY
- 16 A FINE OF NOT MORE THAN \$500.00 OR IMPRISONMENT FOR NOT MORE THAN
- 17 90 DAYS, OR BOTH.
- 18 (3) A PERSON WHO VIOLATES THIS SECTION AND CAUSES INJURY TO A
- 19 POSTAL WORKER OR CONTRACT POSTAL WORKER IN THE IMMEDIATE AREA OF
- 20 THE STATIONARY POSTAL DELIVERY VEHICLE IS GUILTY OF A FELONY
- 21 PUNISHABLE BY A FINE OF NOT MORE THAN \$1,000.00 OR IMPRISONMENT FOR
- 22 NOT MORE THAN 2 YEARS, OR BOTH.
- 23 (4) A PERSON WHO VIOLATES THIS SECTION AND CAUSES DEATH TO
- 24 POSTAL WORKER OR CONTRACT POSTAL WORKER IN THE IMMEDIATE AREA OF
- 25 THE STATIONARY POSTAL DELIVERY VEHICLE IS GUILTY OF A FELONY
- 26 PUNISHABLE BY A FINE OF NOT MORE THAN \$7,500.00 OR IMPRISONMENT FOR
- 27 NOT MORE THAN 15 YEARS, OR BOTH.

- 2 (A) "CONTRACT POSTAL WORKER" MEANS AN INDIVIDUAL WORKING UNDER
- 3 CONTRACT WITH THE UNITED STATES POSTAL SERVICE TO COLLECT OR
- 4 DELIVER UNITED STATES MAIL.
- 5 (B) "POSTAL DELIVERY VEHICLE" MEANS A VEHICLE OWNED OR
- 6 OPERATED BY THE UNITED STATES POSTAL SERVICE OR A CONTRACT POSTAL
- 7 WORKER TO COLLECT OR DELIVER UNITED STATES MAIL AND THAT IS CLEARLY
- 8 MARKED AS A VEHICLE USED FOR THAT PURPOSE.
- 9 (C) "POSTAL WORKER" MEANS AN INDIVIDUAL EMPLOYED BY THE UNITED
- 10 STATES POSTAL SERVICE TO COLLECT OR DELIVER UNITED STATES MAIL.
