House Changes to Senate-Passed:

1. **No Changes in Total Appropriations.** The Governor and Senate concurred in a spending plan which provided for a roll-up of the budget bill into four line items for FY 2011-12. The House concurred in the spending plan, but provided a bill which had budget line items in an unrolled-up format similar to the FY 2010-11 appropriations act, PA 162 of 2010.
