House Changes to Senate-Passed:

- Tobacco Tax Law Enforcement.** The Senate included \$3.0 million in tobacco tax revenue funding to increase enforcement efforts. The Governor and House did not include this funding. (3,000,000)
 - Fingerprint Fee Increase.** The Governor and Senate included \$3.0 million in restricted revenue from a proposed increase in fingerprint background check processing fees. The House did not include the revenue and supplanted it with GF/GP. 0
 - Various GF/GP Reductions.** The House added additional line item reductions, including \$44,800 to Special Maintenance and Utilities, \$132,100 from Fire Investigation, \$12,100 from Parole Absconder Sweeps, \$99,900 from Mental Health Awareness Grant, and \$143,900 from Traffic Services. (432,800)
 - IDG to Legislature.** The House removed a federal Homeland Security grant intended for security upgrades for the Capitol Building. (200,000)
 - Grant to Michigan International Speedway.** The House added an IDG grant of \$200 from MEDC to pay for traffic control by the Department of State Police. 200
 - Line Item Roll-Up.** The Governor and Senate provided a budget bill with appropriation line items rolled up in four line items for FY 2011-12. The House did not concur and kept the number of line items at the FY 2010-11 configuration. 0
