2 (a) Purchase more than 3.6 grams of ephedrine or

3 (2) A person who violates this section is guilty of a crime as4 follows:

5 (a) A person who violates subsection (1) (a) or (b) is guilty

(b) An individual who possesses ephedrine or pseudoephedrinepursuant to a prescription.

(c) A person who possesses ephedrine or pseudoephedrine for
retail sale pursuant to a license issued under the general sales
tax act, 1933 PA 167, MCL 205.51 to 205.78.

2 (e) A person who, in the course of his or her business, stores

10 (g) Possession of any pediatric product primarily intended for 11 administration to children under 12 years of age according to label 12 instructions.

13 (4) SUBSECTION (1) (D) DOES NOT APPLY TO A PERSON WHO
14 PARTICIPATES IN EITHER OF THE FOLLOWING:

(A) AN UNDERCOVER OPERATION IN WHICH THE INDIVIDUAL PURCHASES
OR RECEIVES A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR
PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
PSEUDOEPHEDRINE AS DESCRIBED IN SUBSECTION (1) UNDER THE DIRECTION
OF THE PERSON'S EMPLOYER AND WITH THE PRIOR APPROVAL OF THE LOCAL
PROSECUTOR'S OFFICE AS PART OF AN EMPLOYER-SPONSORED INTERNAL
ENFORCEMENT ACTION.

(B) AN UNDERCOVER OPERATION IN WHICH THE INDIVIDUAL PURCHASES
OR RECEIVES A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR
PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
PSEUDOEPHEDRINE AS DESCRIBED IN SUBSECTION (1) UNDER THE DIRECTION
