## **SENATE BILL No. 1189**

June 14, 2012, Introduced by Senators JANSEN, NOFS, PAVLOV, YOUNG, COLBECK, BOOHER, ANDERSON, KAHN, HANSEN and PAPPAGEORGE and referred to the Committee on Appropriations.

A bill to amend 2002 PA 100, entitled "Public employee retirement benefit protection act,"

(MCL 38.1681 to 38.1689) by amending the title and by adding section 8a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

An act to protect certain rights that public employees have in retirement benefits under certain circumstances; to provide for the establishment of certain funds and arrangements; TO PROTECT THE RIGHTS OF CERTAIN MEMBERS OF THE GOVERNING BOARDS OF RETIREMENT SYSTEMS; and to prescribe the powers and duties of certain

- retirement systems, state departments, courts, public officials,

- 3 OF THE RETIREMENT SYSTEM OR OTHER DECISION-MAKING BODY THAT IS
- 4 RESPONSIBLE FOR IMPLEMENTATION AND SUPERVISION OF A RETIREMENT
