## **HOUSE BILL No. 4184**

February 1, 2011, Introduced by Reps. Oakes, Horn, Bledsoe, Irwin, Santana, Cavanagh and Olumba and referred to the Committee on Judiciary.

A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

by amending section 307 (MCL 257.307), as amended by 2008 PA 36.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 307. (1) If an applicant for an operator's license or
- 2 chauffeur's license is a citizen of the United States, the
- 3 applicant shall supply a photographic identity document, a birth
- 4 certificate, or other sufficient documents as the secretary of
- 5 state may require to verify the identity and citizenship of the
- 6 applicant. If an applicant for an operator's or chauffeur's
- 7 license is not a citizen of the United States, the applicant
- 8 shall supply a photographic identity document and other
- 9 sufficient documents to verify the identity of the applicant and
- 10 the applicant's legal presence in the United States under
- 11 subdivision (b). The documents required under this subsection

- 1 shall include the applicant's full legal name, date of birth, and
- 2 address and residency and demonstrate that the applicant is a
- 3 citizen of the United States or is legally present in the United
- 4 States. If the applicant's full legal name differs from the name
- 5 of the applicant that appears on a document presented under this
- 6 subsection, the applicant shall present documents to verify his
- 7 or her current full legal name. THE SECRETARY OF STATE SHALL
- 8 ACCEPT AS 1 OF THE REQUIRED IDENTIFICATION DOCUMENTS AN
- 9 IDENTIFICATION CARD ISSUED BY THE DEPARTMENT OF CORRECTIONS TO
- 10 PRISONERS WHO ARE PLACED ON PAROLE OR RELEASED FROM A
- 11 CORRECTIONAL FACILITY, CONTAINING THE PRISONER'S NAME,
- 12 PHOTOGRAPH, AND OTHER INFORMATION IDENTIFYING THE PRISONER AS
- 13 PROVIDED IN SECTION 37(4) OF THE CORRECTIONS CODE OF 1953, 1953
- 14 PA 232, MCL 791.237. An application for an operator's or
- 15 chauffeur's license shall be made in a manner prescribed by the
- 16 secretary of state and shall contain all of the following:
- 17 (a) The applicant's full legal name, date of birth,
- 18 residence address, height, sex, eye color, signature, intent to
- 19 make an anatomical gift, other information required or permitted
- 20 on the license under this chapter, and, only to the extent
- 21 required to comply with federal law, the applicant's social
- 22 security number. The applicant may provide a mailing address if
- 23 the applicant receives mail at an address different from his or
- 24 her residence address.
- 25 (b) If the applicant is not a citizen of the United States,
- 26 the applicant shall provide documents demonstrating his or her
- 27 legal presence in the United States. A person legally present in

- 1 the United States includes, but is not limited to, a person
- 2 authorized by the United States government for employment in the
- 3 United States, a person with nonimmigrant status authorized under
- 4 federal law, and a person who is the beneficiary of an approved
- 5 immigrant visa petition or an approved labor certification. The
- 6 secretary of state shall adopt rules under the administrative
- 7 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328, as are
- 8 necessary for the administration of this subdivision. A
- 9 determination by the secretary of state that an applicant is not
- 10 legally present in the United States may be appealed under
- 11 section 631 of the revised judicature act of 1961, 1961 PA 236,
- **12** MCL 600.631.
- 13 (c) The following notice shall be included to inform the
- 14 applicant that under sections 5090 and 509r of the Michigan
- 15 election law, 1954 PA 116, MCL 168.5090 and 168.509r, the
- 16 secretary of state is required to use the residence address
- 17 provided on this application as the applicant's residence address
- 18 on the qualified voter file for voter registration and voting:
- 19 "NOTICE: Michigan law requires that the same address
- 20 be used for voter registration and driver license
- 21 purposes. Therefore, if the residence address
- you provide in this application differs from your
- voter registration address as it appears on the
- 24 qualified voter file, the secretary of state
- will automatically change your voter registration
- 26 to match the residence address on this application,
- after which your voter registration at your former

- 1 address will no longer be valid for voting purposes.
- 2 A new voter registration card, containing the
- information of your polling place, will be provided
- 4 to you by the clerk of the jurisdiction where your
- 5 residence address is located.".
- 6 (d) For an original or renewal operator's or chauffeur's
- 7 license with a vehicle group designation or indorsement, the
- 8 names of all states where the applicant has been licensed to
- 9 drive any type of motor vehicle during the previous 10 years.
- (e) For an operator's or chauffeur's license with a vehicle
- 11 group designation or indorsement, the following certifications by
- 12 the applicant:
- 13 (i) The applicant meets the applicable federal driver
- 14 qualification requirements under 49 CFR part 391 if the applicant
- 15 operates or intends to operate in interstate commerce or meets
- 16 the applicable qualifications of the department of state police
- 17 under the motor carrier safety act of 1963, 1963 PA 181, MCL
- 18 480.11 to 480.25, if the applicant operates or intends to operate
- 19 in intrastate commerce.
- 20 (ii) The vehicle in which the applicant will take the driving
- 21 skills tests is representative of the type of vehicle the
- 22 applicant operates or intends to operate.
- 23 (iii) The applicant is not subject to disqualification by the
- 24 United States secretary of transportation, or a suspension,
- 25 revocation, or cancellation under any state law for conviction of
- 26 an offense described in section 312f or 319b.
- 27 (iv) The applicant does not have a driver's license from more

- 1 than 1 state or jurisdiction.
- 2 (f) An applicant for an operator's or chauffeur's license
- 3 with a vehicle group designation and a hazardous material
- 4 indorsement shall provide his or her fingerprints as prescribed
- 5 by state and federal law.
- 6 (2) An applicant for an operator's or chauffeur's license
- 7 may have his or her image and signature captured or reproduced
- 8 when the application for the license is made. The secretary of
- 9 state shall acquire equipment purchased or leased under this
- 10 section under standard purchasing procedures of the department of
- 11 management and budget based on standards and specifications
- 12 established by the secretary of state. The secretary of state
- 13 shall not purchase or lease equipment until an appropriation for
- 14 the equipment has been made by the legislature. A digital
- 15 photographic image and signature captured under this section
- 16 shall appear on the applicant's operator's license or chauffeur's
- 17 license. A person's digital photographic image shall be used as
- 18 follows:
- 19 (a) By a federal, state, or local governmental agency for a
- 20 law enforcement purpose authorized by law.
- (b) By the secretary of state for a use specifically
- 22 authorized by law.
- (c) By the secretary of state for forwarding to the
- 24 department of state police the images to persons required to be
- 25 registered under the sex offenders registration act, 1994 PA 295,
- 26 MCL 28.721 to 28.736, upon the department of state police
- 27 providing the secretary of state an updated list of the names of

- 1 those persons.
- 2 (d) As necessary to comply with a law of this state or of
- 3 the United States.
- 4 (3) An application shall contain a signature or verification
- 5 and certification by the applicant, as determined by the
- 6 secretary of state, and shall be accompanied by the proper fee.
- 7 The secretary of state shall collect the application fee with the
- 8 application. The secretary of state shall refund the application
- 9 fee to the applicant if the license applied for is denied, but
- 10 shall not refund the fee to an applicant who fails to complete
- 11 the examination requirements of the secretary of state within 90
- 12 days after the date of application for a license.
- 13 (4) In conjunction with the application for an operator's
- 14 license or chauffeur's license, the secretary of state shall do
- 15 all of the following:
- 16 (a) Provide the applicant with all of the following:
- 17 (i) Information explaining the applicant's right to make an
- 18 anatomical gift in the event of death in accordance with section
- **19** 310.
- 20 (ii) Information describing the anatomical gift donor
- 21 registry program under part 101 of the public health code, 1978
- 22 PA 368, MCL 333.10101 to 333.10123. The information required
- 23 under this subparagraph includes the address and telephone number
- 24 of Michigan's federally designated organ procurement organization
- 25 or its successor organization as defined in section 10102 of the
- 26 public health code, 1978 PA 368, MCL 333.10102.
- 27 (iii) Information giving the applicant the opportunity to be

- 1 placed on the donor registry described in subparagraph (ii).
- 2 (b) Provide the applicant with the opportunity to specify on
- 3 his or her operator's or chauffeur's license that he or she is
- 4 willing to make an anatomical gift in the event of death in
- 5 accordance with section 310.
- 6 (c) Inform the applicant that, if he or she indicates to the
- 7 secretary of state under this section a willingness to have his
- 8 or her name placed on the donor registry described in subdivision
- 9 (a) (ii), the secretary of state will mark the applicant's record
- 10 for the donor registry.
- 11 (d) Provide the applicant with the opportunity to make a
- 12 donation of \$1.00 or more to the organ and tissue donation
- 13 education fund created under section 217o. A donation made under
- 14 this subdivision shall be deposited in the state treasury to the
- 15 credit of the organ and tissue donation education fund.
- 16 (5) The secretary of state may fulfill the requirements of
- 17 subsection (4) by 1 or more of the following methods:
- (a) Providing printed material enclosed with a mailed notice
- 19 for an operator's or chauffeur's license renewal or the issuance
- 20 of an operator's or chauffeur's license.
- (b) Providing printed material to an applicant who
- 22 personally appears at a secretary of state branch office.
- 23 (c) Through electronic information transmittals for
- 24 operator's and chauffeur's licenses processed by electronic
- 25 means.
- 26 (6) The secretary of state shall maintain a record of an
- 27 individual who indicates a willingness to have his or her name

- 1 placed on the donor registry described in subsection (4)(a)(ii).
- 2 Information about an applicant's indication of a willingness to
- 3 have his or her name placed on the donor registry that is
- 4 obtained by the secretary of state under subsection (4) and
- 5 forwarded under subsection (14) is exempt from disclosure under
- 6 section 13(1)(d) of the freedom of information act, 1976 PA 442,
- **7** MCL 15.243.
- 8 (7) If an application is received from a person previously
- 9 licensed in another jurisdiction, the secretary of state shall
- 10 request a copy of the applicant's driving record and other
- 11 available information from the national driver register. When
- 12 received, the driving record and other available information
- 13 become a part of the driver's record in this state.
- 14 (8) If an application is received for an original, renewal,
- 15 or upgrade of a vehicle group designation or indorsement, the
- 16 secretary of state shall request the person's complete driving
- 17 record from all states where the applicant was previously
- 18 licensed to drive any type of motor vehicle over the last 10
- 19 years before issuing a vehicle group designation or indorsement
- 20 to the applicant. If the applicant does not hold a valid
- 21 commercial motor vehicle driver license from a state where he or
- 22 she was licensed in the last 10 years, this complete driving
- 23 record request must be made not earlier than 24 hours before the
- 24 secretary of state issues the applicant a vehicle group
- 25 designation or indorsement. For all other drivers, this request
- 26 must be made not earlier than 10 days before the secretary of
- 27 state issues the applicant a vehicle group designation or

- 1 indorsement. The secretary of state shall also check the
- 2 applicant's driving record with the national driver register and
- 3 the federal commercial driver license information system before
- 4 issuing that group designation or indorsement. If the application
- 5 is for the renewal of a vehicle group designation or indorsement,
- 6 and if the secretary of state enters on the person's historical
- 7 driving record maintained under section 204a a notation that the
- 8 request was made and the date of the request, the secretary of
- 9 state is required to request the applicant's complete driving
- 10 record from other states only once under this section.
- 11 (9) Except for a vehicle group designation or indorsement or
- 12 as provided in this subsection or section 314(5), the secretary
- 13 of state may issue a renewal operator's or chauffeur's license
- 14 for 1 additional 4-year period or until the person is no longer
- 15 determined to be legally present under section 307 THIS SECTION
- 16 by mail or by other methods prescribed by the secretary of state.
- 17 The secretary of state may check the applicant's driving record
- 18 through the national driver register and the commercial driver
- 19 license information system before issuing a license under this
- 20 section. The secretary of state shall issue a renewal license
- 21 only in person if the person is a person required under section
- 22 5a of the sex offenders registration act, 1994 PA 295, MCL
- 23 28.725a, to maintain a valid operator's or chauffeur's license or
- 24 official state personal identification card. If a license is
- 25 renewed by mail or by other method, the secretary of state shall
- 26 issue evidence of renewal to indicate the date the license
- 27 expires in the future. The department of state police shall

- 1 provide to the secretary of state updated lists of persons
- 2 required under section 5a of the sex offenders registration act,
- 3 1994 PA 295, MCL 28.725a, to maintain a valid operator's or
- 4 chauffeur's license or official state personal identification
- 5 card.
- 6 (10) Upon request, the secretary of state shall provide an
- 7 information manual to an applicant explaining how to obtain a
- 8 vehicle group designation or indorsement. The manual shall
- 9 contain the information required under 49 CFR part 383.
- 10 (11) The secretary of state shall not disclose a social
- 11 security number obtained under subsection (1) to another person
- 12 except for use for 1 or more of the following purposes:
- 13 (a) Compliance with 49 USC 31301 to 31317 and regulations
- 14 and state law and rules related to this chapter.
- 15 (b) To carry out the purposes of section 466(a) of the
- 16 social security act, 42 USC 666, in connection with matters
- 17 relating to paternity, child support, or overdue child support.
- 18 (c) To check an applicant's driving record through the
- 19 national driver register and the commercial driver license
- 20 information system when issuing a license under this act.
- 21 (d) With the department of community health, for comparison
- 22 with vital records maintained by the department of community
- 23 health under part 28 of the public health code, 1978 PA 368, MCL
- 24 333.2801 to 333.2899.
- 25 (e) As otherwise required by law.
- 26 (12) The secretary of state shall not display a person's
- 27 social security number on the person's operator's or chauffeur's

- 1 license.
- 2 (13) A requirement under this section to include a social
- 3 security number on an application does not apply to an applicant
- 4 who demonstrates he or she is exempt under law from obtaining a
- 5 social security number.
- 6 (14) As required in section 10120 of the public health code,
- 7 1978 PA 368, MCL 333.10120, the secretary of state shall maintain
- 8 the donor registry in a manner that provides electronic access,
- 9 including, but not limited to, the transfer of data to this
- 10 state's federally designated organ procurement organization or
- 11 its successor organization, tissue banks, and eye banks, in a
- 12 manner that complies with that section.
- 13 (15) The secretary of state, with the approval of the state
- 14 administrative board created under 1921 PA 2, MCL 17.1 to 17.3,
- 15 may enter into agreements with the United States government to
- 16 verify whether an applicant for an operator's license or a
- 17 chauffeur's license under this section who is not a citizen of
- 18 the United States is authorized under federal law to be present
- 19 in the United States.
- 20 (16) The secretary of state shall not issue an operator's
- 21 license or a chauffeur's license to a person holding an
- 22 operator's license or chauffeur's license issued by another state
- 23 without confirmation that the person is terminating or has
- 24 terminated the operator's license or chauffeur's license issued
- 25 by the other state.
- 26 (17) The secretary of state shall do all of the following:
- (a) Ensure the physical security of locations where

- 1 operator's licenses and chauffeur's licenses are produced and the
- 2 security of document materials and papers from which operator's
- 3 licenses and chauffeur's licenses are produced.
- 4 (b) Subject all persons authorized to manufacture or produce
- 5 operator's licenses or chauffeur's licenses and all persons who
- 6 have the ability to affect the identity information that appears
- 7 on operator's licenses or chauffeur's licenses to appropriate
- 8 security clearance requirements. The security requirements of
- 9 this subdivision and subdivision (a) may require that licenses be
- 10 manufactured or produced in this state.
- 11 (c) Provide fraudulent document recognition programs to
- 12 department of state employees engaged in the issuance of
- 13 operator's licenses and chauffeur's licenses.
- 14 (18) THE SECRETARY OF STATE SHALL HAVE ELECTRONIC ACCESS TO
- 15 PRISONER BIOGRAPHY INFORMATION MAINTAINED BY THE DEPARTMENT OF
- 16 CORRECTIONS FOR THE PURPOSE OF VERIFYING THE IDENTITY OF A
- 17 PRISONER WHO APPLIES FOR AN OPERATOR'S OR CHAUFFEUR'S LICENSE
- 18 UNDER SUBSECTION (1).
- 19 Enacting section 1. This amendatory act does not take effect
