A bill to amend 1979 PA 218, entitled "Adult foster care facility licensing act,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 27A. (1) AN ADULT FOSTER CARE FACILITY SHALL PERMIT A

- TO, THE COST OF THE ELECTRONIC MONITORING DEVICE AND ITS

- 13 TAMPERS WITH, OR DESTROYS THE RESIDENT'S OR LEGAL REPRESENTATIVE'S
- 14 ELECTRONIC MONITORING DEVICE OR ITS FILM, TAPE, OR OTHER RECORDING
- 15 MEDIUM IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR
- 16 NOT MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN \$2,000.00, OR
- 17 BOTH.
- 18 (8) AS USED IN THIS SECTION, "ELECTRONIC MONITORING DEVICE"
- 19 MEANS A VIDEO SURVEILLANCE CAMERA, AN AUDIO DEVICE, A VIDEO
- 20 TELEPHONE, AN INTERNET VIDEO SURVEILLANCE DEVICE, OR A SIMILAR
- 21 DEVICE DESIGNED TO CAPTURE THE AUDIO RECORDINGS OR VISUAL IMAGES OF
