## **HOUSE BILL No. 4938**

## September 13, 2011, Introduced by Rep. Gilbert and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled

"Income tax act of 1967,"

by amending section 607 (MCL 206.607), as added by 2011 PA 38.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 607. (1) "Federal taxable income" means taxable income as 2 defined in section 63 of the internal revenue code, except that federal taxable income shall be calculated as if section 168(k) and 3 section 199 of the internal revenue code were not in effect. 4

(2) "Flow-through entity" means an entity that for the 5 applicable tax year is treated as a subchapter S corporation under 6 section 1362(a) of the internal revenue code, a general 7 partnership, a trust, a limited partnership, a limited liability 8 9 partnership, or a limited liability company, that for the tax year is not taxed as a corporation for federal income tax purposes. 10

(3) "Foreign operating entity" means a United States person
 that satisfies each of the following:

3 (a) Would otherwise be a part of a unitary business group that
4 has at least 1 person included in the unitary business group that
5 is taxable in this state.

6 (b) Has substantial operations outside the United States, the
7 District of Columbia, any territory or possession of the United
8 States except for the Commonwealth of Puerto Rico, or a political
9 subdivision of any of the foregoing.

10 (c) At least 80% of its income is active foreign business
11 income as defined in section 861(c)(1)(B) of the internal revenue
12 code.

(4) "Gross receipts" means the entire amount received by the 13 taxpayer as determined by using the taxpayer's method of accounting 14 used for federal income tax purposes, less any amount deducted as 15 bad debt for federal income tax purposes from any activity whether 16 17 in intrastate, interstate, or foreign commerce carried on for direct or indirect gain, benefit, or advantage to the taxpayer or 18 19 to others except for the following: (a) Proceeds from sales by a principal that the taxpayer 20 collects in an agency capacity solely on behalf of the principal 21 and delivers to the principal. 22

space not owned by that newspaper in another newspaper on behalf of 1 another person. This subdivision does not apply to any 2 3 consideration received by the taxpayer for acquiring that advertising space. 4 (f) Notwithstanding any other provision of this section, 5 amounts received by a taxpayer that manages real property owned by 6 a third party that are deposited into a separate account kept in 7 the name of that third party and that are not reimbursements to the 8 taxpayer and are not indirect payments for management services that 9 10 the taxpayer provides to that third party. (g) Proceeds from the taxpayer's transfer of an account receivable if the sale that generated the account receivable was included in gross receipts for federal income tax purposes. This subdivision does not apply to a taxpayer that during the tax year both buys and sells any receivables. (h) Proceeds from any of the following: issued by a regulated investment company as that term is defined under section 851 of the internal revenue code. (*ii*) The original issue of debt instruments. (i) Refunds from returned merchandise. (i) Cash and in-kind discounts. (k) Trade discounts. (*l*) Federal, state, or local tax refunds. 24

(p) Proceeds from a sale, transaction, exchange, involuntary 1 2 conversion, maturity, redemption, repurchase, recapitalization, or other disposition or reorganization of tangible, intangible, or 3 4 real property, less any gain from the disposition or reorganization to the extent that the gain is included in the taxpayer's federal 5 taxable income, if the property satisfies 1 or more of the 6 following: 7 (*i*) The property is a capital asset as defined in section 8 1221(a) of the internal revenue code. 9 (*ii*) The property is land that qualifies as property used in 10 11 the trade or business as defined in section 1231(b) of the internal 12 revenue code. 13 (iii) The property is used in a hedging transaction entered into by the taxpayer in the normal course of the taxpayer's trade or 14 business primarily to manage the risk of exposure to foreign 15 currency fluctuations that affect assets, liabilities, profits, 16 17 losses, equity, or investments in foreign operations; interest rate fluctuations; or commodity price fluctuations. For purposes of this 18 19 subparagraph, the actual transfer of title of real or tangible 20 personal property to another person is not a hedging transaction. 21 Only the overall net gain from the hedging transactions entered into during the tax year is included in gross receipts. As used in 22 23 this subparagraph, "hedging transaction" means that term as defined under section 1221 of the internal revenue code regardless of 24 whether the transaction was identified by the taxpayer as a hedge 25 26 for federal income tax purposes, provided, however, that 27 transactions excluded under this subparagraph and not identified as

a hedge for federal income tax purposes shall be identifiable to 1 the department by the taxpayer as a hedge in its books and records. 2 (*iv*) The property is investment and trading assets managed as 3 part of the person's treasury function. For purposes of this 4 subparagraph, a person principally engaged in the trade or business 5 of purchasing and selling investment and trading assets is not 6 performing a treasury function. Only the overall net gain from the 7 treasury function incurred during the tax year is included in gross 8 receipts. As used in this subparagraph, "treasury function" means 9 the pooling and management of investment and trading assets for the 10 11 purpose of satisfying the cash flow or liquidity needs of the 12 taxpayer's trade or business. (q) The proceeds from a policy of insurance, a settlement of a 13 14 claim, or a judgment in a civil action less any proceeds under this subdivision that are included in federal taxable income. 15 (r) For a sales finance company, as defined in section 2 of 16 the motor vehicle sales finance act, 1950 (Ex Sess) PA 27, MCL 17 492.102, and directly or indirectly owned in whole or in part by a 18 19 motor vehicle manufacturer as of January 1, 2008, and for a person that is a broker or dealer as defined under section 78c(a)(4) or 20 21 (5) of the securities exchange act of 1934, 15 USC 78c, or a person 22 included in the unitary business group of that broker or dealer that buys and sells for its own account, contracts that are subject 23 to the commodity exchange act, 7 USC 1 to 27f, amounts realized 24 25 from the repayment, maturity, sale, or redemption of the principal 26 of a loan, bond, or mutual fund, certificate of deposit, or similar 27 marketable instrument provided such instruments are not held as

27 (P) THE PROCEEDS FROM A POLICY OF INSURANCE, A SETTLEMENT OF A

CLAIM, OR A JUDGMENT IN A CIVIL ACTION LESS ANY PROCEEDS UNDER THIS 1 2 SUBDIVISION THAT ARE INCLUDED IN FEDERAL TAXABLE INCOME.

(5) "Insurance company" means an authorized insurer as defined 3 4 in section 108 of the insurance code of 1956, 1956 PA 218, MCL 500.108. 5

(6) "Internal revenue code" means the United States internal 6 revenue code of 1986 in effect on January 1, 2012 or, at the option 7 of the taxpayer, in effect for the tax year. 8

(7) "Member", when used for purposes of determining tax 9 liability for a flow-through entity, means a shareholder of a 10 11 subchapter S corporation, a partner in a general partnership, a limited partnership, or a limited liability partnership, a member 12 of a limited liability company, or a beneficiary of a trust that is 13 14 a flow-through entity, that is not taxed as a corporation for federal income tax purposes. 15

16 Enacting section 1. This amendatory act takes effect January 17 1, 2012.
