1 \$5.00 IS IMPOSED FOR EACH RETREAD TIRE SOLD BY A RETAIL SELLER.

2 (2) A RETAIL SELLER SHALL ADD THE AMOUNT OF THE FEE IMPOSED BY 3 SUBSECTION (1) TO THE TOTAL PRICE OF THE GOODS OR SERVICES SOLD AND 4 SHALL INDICATE THE FEE SEPARATELY ON ANY SALES RECEIPT, INVOICE, OR 5 OTHER RECORD OF THE SALE OF THE RETREAD TIRE.

6 (3) A RETAIL SELLER SHALL COLLECT THE FEE IMPOSED BY 7 SUBSECTION (1) FROM THE PURCHASER.
