THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 7ll. (1) THE GOVERNING BODY OF A LOCAL TAX COLLECTING UNIT
- 2 MAY ADOPT A RESOLUTION TO EXEMPT FROM THE COLLECTION OF TAXES UNDER
- 3 THIS ACT ALL PROPERTY OF A QUALIFIED DISABLED VETERAN.
- 4 (2) AS USED IN THIS SECTION:
- 5 (A) "FEDERAL POVERTY LEVEL" MEANS THE POVERTY GUIDELINES

- 10 (E) "VETERAN" MEANS A PERSON WHO SERVED IN THE ACTIVE

- 12 DISCHARGED OR RELEASED FROM HIS OR HER SERVICE WITH AN HONORABLE OR
- 13 GENERAL DISCHARGE.
