**OVERVIEW**

The House-passed version of Senate Bill 233, which was concurred to the Senate and signed into law with no vetoes, contains FY 2012-13 supplemental appropriations for the following purposes:

- Michigan Natural Resources Trust Fund (MNRTF) acquisition and development projects. The 76 MNRTF projects were approved by the MNRTF Board on December 5, 2012 and would be funded with MNRTF revenues.
- Emergency dredging projects in public harbors. A plan to fund the 49 emergency dredging projects was approved by the State Waterways Commission on February 8, 2013 and would be funded with GF/GP funding and State Waterways Fund revenues.
- A shift of \$250,000 GF/GP from the Department of Corrections to the Legislative Council to fund a review of Michigan's sentencing guidelines.
- An appropriation of \$3.0 million GF/GP for a veterans-related initiative.
- A shift of \$1.0 million GF/GP from an existing appropriation for agricultural loans to a new appropriation for marina dredging loans.

**FY 2012-13 Appropriation Items:**

**CAPITAL OUTLAY**

**1. Michigan Natural Resources Trust Fund**

Includes \$23.5 million for 22 land acquisition projects and 54 land development projects supported with revenues from the Michigan Natural Resources Trust Fund (MNRTF). The MNRTF provides financial assistance to local units of government and to the Department of Natural Resources for the purchase of lands for outdoor recreation, for protection of natural resources and open space, and for development of land for public outdoor recreation. The 22 land acquisition projects total \$14.5 million. Of these, 17 acquisition projects are for locals (\$12.0 million) and 5 projects are for the State (\$2.5 million). Of the 54 development projects totaling \$9.1 million, 49 are local projects (\$7.8 million) and 5 are State projects (\$1.3 million).

The MNRTF received revenues from the sale or lease of mineral rights, including bonuses, rentals, and subsequent royalties on all state lands-except those purchased with state or federal Game and Fish Protection Funds- until the corpus of the MNRTF reached \$500.0 million in May 2011. The Fund no longer receives these mineral rights revenues and now may only expend the amount of the annual interest and investment earnings of the \$500.0 million MNRTF investment corpus each year. **1. Michigan Natural Resources Trust Fund (continued)**

The Executive appropriated the \$23.5 million funding in one line item and lists the estimated funding amount per project in boilerplate. The Senate and House appropriate funding for each project by individual line items and reduce Acquisition Project #5, Cranberry Lake, by \$190,000 to reflect a revised MNRTF Board recommendation.

**4. Veterans' Service Delivery Initiative**

Provides funding for initiative as part of the restructuring of the administration and delivery of veterans' affairs programs, services, and benefits within DMVA and throughout state government following the creation of the Veterans Affairs Agency by Executive Order 2013-2. The new agency will raise the level of services provided through DMVA and throughout state government. (SBO request 2013-4)

**5. Capital Outlay — Emergency Dredging**

Appropriates \$21.0 million Gross (\$11.5 million GF/GP) to fund emergency dredging projects in public recreational harbors on or near the Great Lakes. The \$9.5 million restricted funding would be appropriated from the State Waterways Fund. \$8.7 million of this funding would be redirected from previously authorized projects; the bill reduces these previous appropriations through boilerplate language. The remaining \$722,000 is available from fund balance of the State Waterways Fund.

On February 8, 2013, the State Waterways Commission approved an Emergency Dredging Plan which recommended a list of 49 public harbors that should receive emergency dredging funding totaling \$21.0 million. **6. Qualified Agricultural Loan Origination Program**

Reflects removal of \$1.0 million GF/GP from the Qualified Agricultural Loan Origination Program. Funding will be transferred to the Marina Dredging Loan Origination Program. Public Act 305 of 2012 appropriated \$15.0 million for the Qualified Agricultural Loan Origination Program. It is determined that sufficient funding is available to make this fund shift.

**7. Marina Dredging Loan Origination Program**

Appropriates \$1.0 million GF/GP for a Marina Dredging Loan Origination Program. Funding will support financial assistance to eligible marinas through the payment of loan origination fees on qualified loans. Appropriation is supported by a transfer of unencumbered funds from the Qualified Agricultural Loan Origination Program. It is determined that sufficient funding is available to make this fund shift.

Provides that the funds appropriated in part 1 for the Marina Dredging Loan Origination Program are considered work project appropriations and if unencumbered or unallotted, they shall be carried forward into the succeeding fiscal year. Indicates payments will be made to qualified financial institutions to offset loan origination fees for administrative costs incurred by the qualified financial institution. Establishes a tentative completion date of March 1, 2014.
