- 4 (A) THE MORTGAGED PROPERTY IS CLAIMED AS A PRINCIPAL RESIDENCE
- 5 EXEMPT FROM TAX UNDER SECTION 7CC OF THE GENERAL PROPERTY TAX ACT,
- 6 1893 PA 206, MCL 211.7CC.
- 7 (B) THE FIRST NOTICE UNDER SECTION 3208 IS PUBLISHED AFTER
- 8 JANUARY 9, 2014.
- 9 (C) THE [SERVICING AGENT OF] THE MORTGAGE IS A DEFENDANT THAT
- 10 ENTERED INTO A CONSENT JUDGMENT IN UNITED STATES OF AMERICA, ET AL.

- 16 (C) INCLUDE IN THE WRITTEN NOTICE THE PERSON SENDS TO THE
- 17 MORTGAGOR UNDER 12 CFR 1024.39(B), OR ENCLOSE WITH THE NOTICE A
- 18 SEPARATE WRITTEN NOTICE THAT CONTAINS, ALL OF THE FOLLOWING
- 19 INFORMATION:
- 20 (i) THE NAME AND ADDRESS AND A DEDICATED TELEPHONE NUMBER AND
- 21 DEDICATED ELECTRONIC MAIL ADDRESS OF THE INDIVIDUAL, DEPARTMENT, OR
- 22 UNIT DESIGNATED UNDER SUBDIVISION (A).
- 23 (ii) A STATEMENT THAT THE MORTGAGOR MAY, WITHIN 30 DAYS, EITHER
- 24 BY CONTACTING THE INDIVIDUAL, DEPARTMENT, OR UNIT DESIGNATED UNDER
- 25 SUBDIVISION (A) DIRECTLY OR BY CONTACTING A HOMEOWNERSHIP COUNSELOR
- 26 OR COUNSELING ORGANIZATION FROM A LIST REFERRED TO IN THE WRITTEN
- 27 NOTICE UNDER 12 CFR 1024.39(B), REQUEST A MEETING WITH THE

- 1 INDIVIDUAL, DEPARTMENT, OR UNIT DESIGNATED UNDER SUBDIVISION (A) TO
- 2 ATTEMPT TO WORK OUT A MODIFICATION OF THE MORTGAGE LOAN TO AVOID
- 3 FORECLOSURE.
- 4 (D) IF THE MORTGAGOR REQUESTS A MEETING UNDER SUBDIVISION (C),
- 5 NOT COMMENCE FORECLOSURE PROCEEDINGS UNDER THIS CHAPTER UNLESS THE
- 6 MEETING HAS BEEN HELD. THIS SUBDIVISION DOES NOT APPLY IF THE
- 7 MORTGAGOR HAS NOT COOPERATED BY SCHEDULING A MEETING AT A TIME AND
- 8 PLACE THAT IS CONVENIENT TO ALL PARTIES, OR IN THE COUNTY WHERE THE
- 9 PROPERTY IS SITUATED, OR HAS NOT ATTENDED A SCHEDULED MEETING.
