HOUSE BILL No. 4587

April 18, 2013, Introduced by Rep. Switalski and referred to the Committee on Transportation and Infrastructure.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803f (MCL 257.803f), as amended by 1998 PA 68.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803f. (1) A person who is a totally disabled veteran with
- 2 an honorable discharge from the armed services OR A PERSON WHOSE
- 3 IMMEDIATE FAMILY MEMBER IS A TOTALLY DISABLED VETERAN WITH AN
- 4 HONORABLE DISCHARGE FROM THE ARMED SERVICES may make an application
- 5 to the secretary of state if he or she owns a private passenger
- 6 motor vehicle, and the secretary of state may issue a-1 OR MORE
 - special registration plate which shall be PLATES TO THE APPLICANT
- B THAT ARE inscribed with special identification numbers preceded by
- 9 the letters "DV" and shall have the words "disabled veteran"
- 10 inscribed beneath the registration number. For the purposes of this

- 2 (A) "IMMEDIATE FAMILY MEMBER" MEANS A SPOUSE, PARENT, CHILD,
- 3 OR SIBLING RESIDING IN THAT PERSON'S HOUSEHOLD.

- 5 which THAT is personally owned by the disabled veteran OR HIS OR

- 16 government to have a service-connected total or permanent total
- 17 disability rating for compensation.
- 18 (b) That the applicant OR HIS OR HER IMMEDIATE FAMILY MEMBER
- 19 has been determined to have a service-connected total or permanent
- 20 total disability rating and is receiving disability retirement pay
- 21 from a branch of the uniformed armed services.
- 22 (3) A special registration issued TO A DISABLED VETERAN under
- 23 this section is exempt from payment of the tax provided in section
- 24 801. A SPECIAL REGISTRATION ISSUED TO AN IMMEDIATE FAMILY MEMBER OF
- 25 A DISABLED VETERAN UNDER THIS SECTION IS SUBJECT TO THE TAX
- 26 PROVIDED IN SECTION 801 OR A TAX TO BE DETERMINED BY THE SECRETARY
- 27 OF STATE, AT THE SECRETARY OF STATE'S DISCRETION.

- 1 (4) The special registration plate shall expire on the
- 2 birthday of the disabled veteran PERSON APPLYING FOR THE SPECIAL
- 3 REGISTRATION PLATE in a year in which new plates are issued by the
- 4 secretary of state. Application AN APPLICATION for renewal of the
- 5 special registration plate shall be accompanied by a \$5.00 service
- 6 fee. The applicant shall OR THE APPLICANT'S IMMEDIATE FAMILY MEMBER
- 7 IS not be required to furnish the proof provided in subsection (2).
- 8 (5) The secretary of state may issue to a disabled person OR
- 9 HIS OR HER IMMEDIATE FAMILY MEMBER who has been issued a special
- 10 registration plate under this section a tab for persons with
- 11 disabilities. The tab for persons with disabilities shall be an
- 12 adhesive tab displaying the international wheelchair symbol or a
- 13 reasonable facsimile of that symbol. The tab for persons with
- 14 disabilities may be attached only to the special registration plate
- 15 issued to the disabled person OR HIS OR HER IMMEDIATE FAMILY MEMBER
- 16 under this section.
- 17 (6) An application for a tab for persons with disabilities
- 18 shall be on a form prescribed by the secretary of state. The
- 19 secretary of state shall require the same proof that the applicant
- 20 OR HIS OR HER IMMEDIATE FAMILY MEMBER is a disabled person as is
- 21 required for issuance of a permanent windshield placard under
- 22 section 675.
- 23 (7) The tab for persons with disabilities shall be issued free
- 24 of charge.
- 25 (8) When a disabled person OR HIS OR HER IMMEDIATE FAMILY
- 26 MEMBER who has been issued a tab for persons with disabilities
- 27 renews his or her special registration plate under this section,

- 1 the secretary of state shall issue a new tab for persons with
- 2 disabilities to the disabled person, free of charge. The disabled
- 3 person shall or his or her immediate family member is not be
- 4 required to again furnish the proof required under subsection (6).
- 5 (9) The use of the special registration plate or a tab for
- 6 persons with disabilities on a motor vehicle other than the motor
- 7 vehicle for which the special registration plate is issued, or by a
- 8 person who does not qualify under this section, is a misdemeanor.
