## **HOUSE BILL No. 4862**

June 20, 2013, Introduced by Reps. McBroom, Bumstead, Daley, Dianda, Foster, MacMaster, Lyons, Somerville and Walsh and referred to the Committee on Agriculture.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 40103, 41102, 41301, and 41302 (MCL 324.40103, 324.41102, 324.41301, and 324.41302), section 40103 as amended by 2012 PA 520, section 41102 as amended by 2000 PA 191, section 41301 as amended by 2009 PA 51, and section 41302 as added by 2009 PA 52.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 40103. (1) "Game" means any of the following animals but does not include privately owned cervidae species located on a cervidae livestock facility registered under the privately owned cervidae producers marketing act, 2000 PA 190, MCL 287.951 to 287.969, OR SPORTING SWINE LOCATED ON A SPORTING SWINE LIVESTOCK OPERATION THAT IS REGISTERED UNDER THE SPORTING SWINE MARKETING ACT:

- 16 (4) "Normal agricultural practices" means generally accepted
- 17 agricultural and management practices as defined by the commission
- 18 of agriculture and rural development.
- 19 (5) "Open season" means the dates during which game may be
- 20 legally taken.
- 21 (6) "Parts" means any or all portions of an animal, including
- 22 the skin, plumage, hide, fur, entire body, or egg of an animal.
- 23 (7) "Protected" or "protected animal" means an animal or kind
- 24 of animal that is designated by the department as an animal that
- 25 shall not be taken.
- 26 (8) "Residence" means a permanent building serving as a
- 27 temporary or permanent home. Residence may include a cottage,

- 1 cabin, or mobile home, but does not include a structure designed
- 2 primarily for taking game, a tree blind, a tent, a recreational or
- 3 other vehicle, or a camper.
- 4 Sec. 41102. (1) The department, in accordance with this part,
- 5 may regulate the taking or killing of all fish, game and fur-
- 6 bearing animals, and game birds protected by the laws of this
- 7 state, and may suspend or abridge the open season provided by law
- 8 for the taking or killing of such fish, animals, or game birds in
- 9 any designated waters or area of this state, if in the opinion of
- 10 the department it is necessary to assist in the increased or better
- 11 protection of the fish, game or fur-bearing animals, or game birds,
- 12 or any particular kinds or species of fish, game or fur-bearing
- 13 animals, or game birds, which may in the opinion of the department
- 14 be threatened from any cause or causes with depletion or
- 15 extermination in the waters or area. The department may promulgate
- 16 rules and orders necessary to implement this part after a thorough
- 17 investigation has been made by the department.
- 18 (2) This section does not apply to privately EITHER OF THE
- 19 FOLLOWING:
- 20 (A) PRIVATELY owned cervidae species located on a registered
- 21 cervidae livestock facility or involved in a registered cervidae
- 22 livestock operation REGISTERED under the privately owned cervidae
- 23 producers marketing act, 2000 PA 190, MCL 287.951 TO 287.969.
- 24 (B) SPORTING SWINE LOCATED ON A SPORTING SWINE LIVESTOCK
- 25 OPERATION REGISTERED UNDER THE SPORTING SWINE MARKETING ACT.
- 26 Sec. 41301. (1) As used in this part:
- 27 (a) "Genetically engineered" refers to an organism whose

- 1 genome, chromosomal or extrachromosomal, is modified permanently
- 2 and heritably, using recombinant nucleic acid techniques, or the
- 3 progeny of such an organism.
- 4 (b) "Introduce", with reference to an organism, means to
- 5 knowingly and willfully stock, place, plant, release, or allow the
- 6 release of the organism in this state at any specific location
- 7 where the organism is not already naturalized.
- 8 (c) "Prohibited species", subject to section 41302, means any
- 9 of the following:
- 10 (i) Any of the following prohibited aquatic plant species,
- 11 including a hybrid or genetically engineered variant of the species
- 12 or a fragment, including a seed or other propagule, of the species
- 13 or of a hybrid or genetically engineered variant:
- (A) African oxygen weed (Lagarosiphon major).
- 15 (B) Brazilian elodea (Egeria densa).
- 16 (C) Cylindro (Cylindrospermopsis raciborskii).
- 17 (D) European frogbit (Hydrocharis morsus-ranae).
- 18 (E) Fanwort (Cabomba caroliniana).
- 19 (F) Giant hogweed (Heracleum mantegazzianum).
- 20 (G) Giant salvinia (Salvinia molesta, auriculata, biloba, or
- 21 herzogii).
- 22 (H) Hydrilla (Hydrilla verticillata).
- 23 (I) Japanese knotweed (Fallopia japonica).
- 24 (J) Parrot's feather (Myriophyllum aquaticum).
- 25 (K) Starry stonewort (Nitellopsis obtusa).
- 26 (L) Water chestnut (Trapa natans).
- 27 (M) Yellow floating heart (Nymphoides peltata).

- 1 (ii) The following prohibited bird species, including a hybrid
- 2 or genetically engineered variant of the species or an egg of the
- 3 species or of a hybrid or genetically engineered variant: Eurasian
- 4 collared dove (Streptopelia decaocto).
- 5 (iii) The following prohibited crustacean species, including a
- 6 hybrid or genetically engineered variant of the species or an egg
- 7 of the species or of a hybrid or genetically engineered variant:
- 8 rusty crayfish (Orconectes rusticus).
- 9 (iv) Any of the following prohibited fish species, including a
- 10 hybrid or genetically engineered variant of the species or an egg
- 11 of the species or of a hybrid or genetically engineered variant:
- (A) Bighead carp (Hypophthalmichthys nobilis).
- 13 (B) Bitterling (Rhodeus sericeus).
- 14 (C) Black carp (Mylopharyngodon piceus).
- 15 (D) Eurasian ruffe (Gymnocephalus cernuus).
- 16 (E) Grass carp (Ctenopharyngodon idellus).
- 17 (F) Ide (Leuciscus idus).
- 18 (G) Japanese weatherfish (Misgurnus anguillicaudatus).
- 19 (H) Round goby (Neogobius melanostomus).
- 20 (I) Rudd (Scardinius erythrophthalamus).
- 21 (J) Silver carp (Hypophthalmichthys molitrix).
- 22 (K) A fish of the snakehead family (family Channidae).
- 23 (L) Tench (Tinca tinca).
- 24 (M) Tubenose goby (Proterorhinus marmoratus).
- (v) Any of the following prohibited insect species, including
- 26 a hybrid or genetically engineered variant of the species or an egg
- 27 of the species or of a hybrid or genetically engineered variant:

- 1 (A) Asian longhorned beetle (Anoplophora glabripennis).
- 2 (B) Emerald ash borer (Agrilus planipennis).
- (vi) The following prohibited mammal species, including a
- 4 hybrid or genetically engineered variant: nutria
- 5 (A) FERAL SWINE AS DEFINED IN SECTION 3 OF THE ANIMAL INDUSTRY
- 6 ACT, 1988 PA 466, MCL 287.703.
- 7 (B) NUTRIA (Myocastor coypus).
- 8 (vii) Any of the following prohibited mollusk species,
- 9 including a hybrid or genetically engineered variant of the species
- 10 or an egg of the species or of a hybrid or genetically engineered
- 11 variant:
- 12 (A) Brown garden snail (Helix aspersa).
- 13 (B) Carthusian snail (Monacha cartusiana).
- 14 (C) Giant African snail (Achatina fulica).
- 15 (D) Girdled snail (Hygromia cinctella).
- 16 (E) Heath snail (Xerolenta obvia).
- 17 (F) Wrinkled dune snail (Candidula intersecta).
- 18 (d) "Recombinant nucleic acid techniques" means laboratory
- 19 techniques through which genetic material is isolated and
- 20 manipulated in vitro and then inserted into an organism.
- 21 (e) "Restricted species", subject to section 41302, means any
- 22 of the following:
- 23 (i) Any of the following restricted aquatic plant species,
- 24 including a hybrid or genetically engineered variant of the species
- 25 or a fragment, including a seed or other propagule, of the species
- 26 or of a hybrid or genetically engineered variant:
- 27 (A) Curly leaf pondweed (Potamogeton crispus).

- 1 (B) Eurasian watermilfoil (Myriophyllum spicatum).
- 2 (C) Flowering rush (Butomus umbellatus).
- 3 (D) Phragmites or common reed (Phragmites australis).
- 4 (E) Purple loosestrife (Lythrum salicaria), except that
- 5 cultivars of purple loosestrife developed and recognized to be
- 6 sterile and approved by the director of the department of
- 7 agriculture AND RURAL DEVELOPMENT under section 16a of the insect
- 8 pest and plant disease act, 1931 PA 189, MCL 286.216a, are not a
- 9 restricted species.
- 10 (ii) Any of the following restricted mollusk species, including
- 11 a hybrid or genetically engineered variant of the species or an egg
- 12 of the species or of a hybrid or genetically engineered variant:
- (A) Quagga mussel (Dreissena bugensis).
- 14 (B) Zebra mussel (Dreissena polymorpha).
- 15 (2) For the purposes of this part:
- 16 (a) A person is not considered to possess a live organism
- 17 simply because the organism is present on land or in waters owned
- 18 by that person unless the person has knowingly introduced that live
- 19 organism on that land or in those waters.
- 20 (b) A person is not considered to possess a live organism if
- 21 the organism was obtained from the environment and the person only
- 22 possesses the organism at the specific location at which it was
- 23 obtained from the environment.
- 24 (c) A person is not considered to possess a live organism if
- 25 the possession is for the purpose of promptly destroying the
- 26 organism.
- 27 Sec. 41302. (1) The commission of EXCEPT AS PROVIDED IN

- 1 SUBSECTION (4), THE natural resources COMMISSION may, by order, add
- 2 to or delete from the list of prohibited species or restricted
- 3 species under section 41301 any species other than an insect or
- 4 plant species. Before issuing an order under this subsection, the
- 5 commission of natural resources COMMISSION shall consult with the
- 6 department of agriculture AND RURAL DEVELOPMENT. After the
- 7 consultation, and at least 30 days before the commission of natural
- 8 resources COMMISSION issues the order, the department of natural
- 9 resources shall post a copy of the proposed order on the department
- 10 of natural resources' website and shall submit a copy of the
- 11 proposed order to all of the following:
- 12 (a) The legislature.
- 13 (b) The standing committees of the senate and house of
- 14 representatives with primary responsibility for any of the
- 15 following:
- 16 (i) Agricultural issues.
- 17 (ii) Environmental issues.
- 18 (iii) Natural resources issues.
- 19 (2) The commission of agriculture AND RURAL DEVELOPMENT may,
- 20 by order, add to or delete from the list of prohibited species or
- 21 restricted species under section 41301 any insect or plant species.
- 22 Before issuing an order under this subsection, the commission of
- 23 agriculture AND RURAL DEVELOPMENT shall consult with the department
- 24 of natural resources. After the consultation, and at least 30 days
- 25 before the commission of agriculture AND RURAL DEVELOPMENT issues
- 26 the order, the department of agriculture AND RURAL DEVELOPMENT
- 27 shall post a copy of the proposed order on the department of

- 1 agriculture's AGRICULTURE AND RURAL DEVELOPMENT'S website and shall
- 2 submit a copy of the proposed order to all of the following:
- 3 (a) The legislature.
- 4 (b) The standing committees of the senate and house of
- 5 representatives with primary responsibility for any of the
- 6 following:
- 7 (i) Agricultural issues.
- 8 (ii) Environmental issues.
- 9 (iii) Natural resources issues.
- 10 (3) The commission of natural resources COMMISSION or the
- 11 commission of agriculture AND RURAL DEVELOPMENT, as applicable,
- 12 shall list a species as a prohibited species or restricted species
- 13 if the commission of natural resources COMMISSION or commission of
- 14 agriculture AND RURAL DEVELOPMENT, respectively, determines the
- 15 following:
- 16 (a) For a prohibited species, all of the following
- 17 requirements are met:
- 18 (i) The organism is not native to this state.
- 19 (ii) The organism is not naturalized in this state or, if
- 20 naturalized, is not widely distributed in this state.
- 21 (iii) One or more of the following apply:
- 22 (A) The organism has the potential to harm human health or to
- 23 severely harm natural, agricultural, or silvicultural resources.
- 24 (B) Effective management or control techniques for the
- 25 organism are not available.
- 26 (b) For a restricted species, all of the following
- 27 requirements are met:

1 (i) The organism is not native to this state. 2 (ii) The organism is naturalized and widely distributed in this state. 3 4 (iii) One or more of the following apply: 5 (A) The organism has the potential to harm human health or to harm natural, agricultural, or silvicultural resources. 6 7 (B) Effective management or control techniques for the organism are available. 8 (4) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, THE 9 10 NATURAL RESOURCES COMMISSION SHALL NOT LIST AS A PROHIBITED OR 11 RESTRICTED SPECIES SPORTING SWINE REGULATED UNDER THE SPORTING 12 SWINE MARKETING ACT. THE DEPARTMENT OF NATURAL RESOURCES SHALL NOT ENFORCE ANY ORDER UNDER THIS PART THAT IS INCONSISTENT WITH THIS 13 14 SUBSECTION. 15 Enacting section 1.
