A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 2027d.

- 1 SEC. 2027D. (1) IF A PROPERTY OR CASUALTY INSURER IS FOUND IN
- 2 AN ACTION UNDER SECTION 2027C TO HAVE UNDERTAKEN AN UNFAIR METHOD
- 3 OF COMPETITION, AN UNFAIR OR DECEPTIVE ACT OR PRACTICE, OR ANY
- 4 OTHER CONDUCT PROHIBITED BY SECTIONS 2001 TO 2050, OR IS FOUND TO
- 5 HAVE FAILED TO PAY BENEFITS IN A TIMELY MANNER AS DESCRIBED IN
- S SECTION 2027A(2), THERE IS A PRESUMPTION THAT THE PROPERTY OR
- CASUALTY INSURER WAS ACTING IN BAD FAITH. THE PRESUMPTION CREATED
- B BY THIS SECTION PLACES THE BURDEN OF DISPROVING THE BAD FAITH ON
