June 10, 2014, Introduced by Reps. Hooker, Kurtz, Rendon, Genetski, Heise, Zorn, Lauwers, Johnson, Haveman, Olumba, Potvin, Outman, Yonker, Goike, Muxlow, McMillin and Callton and referred to the Committee on Health Policy.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2012 PA 365.

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies
