A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811v.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811V. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER 2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 3 RECOGNIZING THE MICHIGAN BREAST AND CERVICAL CANCER CONTROL
- PROGRAM. THE SECRETARY OF STATE IN CONJUNCTION WITH THE MICHIGAN
- BREAST AND CERVICAL CANCER CONTROL PROGRAM SHALL DESIGN THE FUND-
  - RAISING PLATES AUTHORIZED IN THIS SECTION.
  - (2) THE BREAST CANCER AWARENESS FUND IS CREATED WITHIN THE
- 8 STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
  - ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE
  - TREASURER SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE

- 1 TREASURER SHALL CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND
- 2 INVESTMENTS. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR
- 3 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 4 THE SECRETARY OF STATE SHALL BE THE ADMINISTRATOR OF THE FUND FOR
- 5 AUDITING PURPOSES.
- 6 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
- 7 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE MICHIGAN
- 8 BREAST AND CERVICAL CANCER CONTROL PROGRAM TO THE STATE TREASURER,
- 9 WHO SHALL CREDIT THE DONATION MONEY TO THE BREAST CANCER AWARENESS
- 10 FUND ESTABLISHED UNDER SUBSECTION (2).
- 11 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE FUND
- 12 ESTABLISHED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO THE
- 13 MICHIGAN BREAST AND CERVICAL CANCER CONTROL PROGRAM.
- 14 (5) BEGINNING NOT LATER THAN FEBRUARY 1, 2014, THE MICHIGAN
- 15 BREAST AND CERVICAL CANCER CONTROL PROGRAM SHALL SUBMIT TO THE
- 16 STATE TREASURER A SUMMARY OF THE EXPENDITURES DURING THE PRECEDING
- 17 YEAR OF THE MONEY RECEIVED UNDER THIS SECTION.
