## **SENATE BILL No. 118**

January 30, 2013, Introduced by Senators JONES, BIEDA, ROCCA, SCHUITMAKER, ANDERSON, PROOS, KOWALL, PAPPAGEORGE and MARLEAU and referred to the Committee on Agriculture.

A bill to amend 1919 PA 339, entitled "Dog law of 1919," (MCL 287.261 to 287.290) by adding section 10a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 10A. (1) A PERSON THAT OPERATES A LARGE-SCALE COMMERCIAL

- 2 BREEDING KENNEL SHALL APPLY ANNUALLY TO THE DEPARTMENT FOR A LARGE-3 SCALE COMMERCIAL BREEDING KENNEL LICENSE. IN ADDITION, THE
- APPLICANT FOR A LARGE-SCALE COMMERCIAL BREEDING KENNEL LICENSE
- 5 SHALL PAY AN ANNUAL \$500.00 SITE INSPECTION FEE TO THE DEPARTMENT.
  - (2) BEFORE ISSUING A LARGE-SCALE COMMERCIAL BREEDING KENNEL LICENSE, THE DEPARTMENT SHALL INSPECT THE KENNEL TO VERIFY THAT THE KENNEL COMPLIES WITH ALL OF THE PROVISIONS CONCERNING LARGE-SCALE COMMERCIAL BREEDING KENNELS AS PROVIDED IN THE PUPPY PROTECTION ACT. THE DEPARTMENT MAY DELEGATE THE INSPECTION REQUIRED UNDER THIS

- 17 (C) "LICENSED VETERINARIAN" MEANS A PERSON LICENSED TO
- 18 PRACTICE VETERINARY MEDICINE UNDER ARTICLE 15 OF THE PUBLIC HEALTH
- 19 CODE, 1978 PA 368, MCL 333.16101 TO 333.18838.
- 20 Enacting section 1. This amendatory act takes effect January
- **21** 1, 2014.
- 22 Enacting section 2. This amendatory act does not take effect
- 23 unless Senate Bill No. 117
- of the 97th Legislature is enacted into law.
