A bill to amend 1979 PA 94, entitled "The state school aid act of 1979,"

(MCL 388.1601 to 388.1896) by adding section 72.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 72. (1) IN ADDITION TO THE MONEY APPROPRIATED UNDER
- 2 SECTION 11, THERE IS APPROPRIATED FOR 2012-2013 FROM THE GENERAL
- 3 FUND THE AMOUNT NECESSARY TO REIMBURSE DISTRICTS AND INTERMEDIATE
- 4 DISTRICTS FOR PROVIDING TRANSPORTATION FOR PUPILS AS PROVIDED UNDER
- 5 THIS SECTION.
 - (2) THE AMOUNT OF REIMBURSEMENT TO A DISTRICT OR INTERMEDIATE
- DISTRICT UNDER THIS SECTION SHALL BE CALCULATED BY MULTIPLYING
- 8 \$0.50 TIMES THE NUMBER OF MILES TRAVELED BY SCHOOL BUSES OPERATED
- 9 BY OR ON BEHALF OF THE DISTRICT OR INTERMEDIATE DISTRICT DURING THE
- 10 2012-2013 SCHOOL YEAR FOR TRANSPORTING PUPILS TO AND FROM SCHOOL,
- 11 EXCLUDING MILES TRAVELED FOR EXTRACURRICULAR ACTIVITIES.
