February 27, 2013, Introduced by Senators JONES, SCHUITMAKER, WALKER and GREEN and referred to the Committee on Regulatory Reform.

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2919) by adding section 1806a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1806A. (1) THE DEPARTMENT MAY ISSUE A LIMITED LICENSE TO
- 2 ENGAGE IN THE PRACTICE OF MORTUARY SCIENCE TO AN INDIVIDUAL IF THE
 - DEPARTMENT DETERMINES THAT ALL OF THE FOLLOWING ARE MET:
- 4 (A) THE INDIVIDUAL HOLDS A VALID LICENSE TO PRACTICE MORTUARY
- 5 SCIENCE, FUNERAL DIRECTING, OR ANOTHER OCCUPATION THAT IS THE
- 6 EQUIVALENT OF THE PRACTICE OF MORTUARY SCIENCE OR FUNERAL
- 7 DIRECTING, ISSUED BY THE STATE OF INDIANA, OHIO, OR WISCONSIN.
 - (B) THE STATE THAT ISSUED THE LICENSE DESCRIBED IN SUBDIVISION

- 1 (A) BY LAW PROVIDES INDIVIDUALS LICENSED UNDER THIS ARTICLE

- 5 (2) A LIMITED LICENSE IS VALID FOR 2 YEARS, BEGINNING ON THE

- 7 (3) AN INDIVIDUAL WHO HOLDS A LIMITED LICENSE MAY DO ANY OF
- 8 THE FOLLOWING:
- 9 (A) REMOVE A DEAD HUMAN BODY FROM THE PLACE OF DEATH IN THIS
- 10 STATE.
- 11 (B) REGISTER WITH A LOCAL REGISTRAR UNDER SECTION 1807.
- 12 (C) SUBJECT TO SECTION 1807, TRANSPORT A DEAD HUMAN BODY TO OR
- 13 FROM THE STATE IN WHICH HE OR SHE IS LICENSED.
- 14 (D) SUBJECT TO SECTION 1807, SUPERVISE THE FINAL DISPOSITION
- 15 OF A HUMAN BODY IN THIS STATE.
- 16 (4) AN INDIVIDUAL WHO HOLDS A LIMITED LICENSE SHALL NOT DO ANY
- 17 OF THE FOLLOWING IN THIS STATE:
- 18 (A) OPERATE A FUNERAL ESTABLISHMENT.
- 19 (B) ENGAGE IN THE PRACTICE OF EMBALMING.
- 20 (C) ADVERTISE MORTUARY SCIENCE, FUNERAL DIRECTING, OR
- 21 CREMATION SERVICES.
- 22 (D) DIRECTLY OR INDIRECTLY OWN, MANAGE, OPERATE, MAINTAIN, OR
- 23 BE EMPLOYED BY A CEMETERY.
- 24 (E) VIOLATE SECTION 1810.
- 25 (5) THE DEPARTMENT SHALL ENSURE THAT A LIMITED LICENSE IS
- 26 ISSUED WITH THE LIMITATIONS DESCRIBED IN THIS SECTION.
- 27 (6) AS USED IN THIS SECTION, "LIMITED LICENSE" MEANS A LICENSE
