## **SENATE BILL No. 635**

October 22, 2013, Introduced by Senator PROOS and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 21334 and 21736.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21334. (1) IF MEDICAL OR DENTAL CARE IS PROVIDED TO A
- 2 HOME FOR THE AGED RESIDENT ON THE PREMISES OF THE HOME FOR THE
- 3 AGED, THE HOME FOR THE AGED SHALL HAVE A PRIVATE EXAMINATION ROOM
- 4 FOR THE PURPOSE OF MEDICAL OR DENTAL EXAMINATION AND TREATMENT.
  - (2) THE HOME FOR THE AGED SHALL USE AN EXAMINATION ROOM
  - REQUIRED UNDER SUBSECTION (1) EXCLUSIVELY FOR THE MEDICAL AND
  - DENTAL EXAMINATION AND TREATMENT OF RESIDENTS AND SHALL KEEP THE
  - ROOM SEPARATE FROM COMMON AREAS, DINING FACILITIES, PATIENT ROOMS,
- 9 AND RESTROOMS. THE EXAMINATION ROOM MUST HAVE A DOOR OR OTHER MEANS
- 10 OF PREVENTING THE ENTRY OF UNAUTHORIZED INDIVIDUALS.
