SENATE BILL No. 861

March 11, 2014, Introduced by Senator RICHARDVILLE and referred to the Committee on Families, Seniors and Human Services.

A bill to amend 1982 PA 249, entitled

"An act to establish the state children's trust fund in the department of treasury; and to provide certain powers and duties of the department of treasury with respect to the trust fund,"

by amending section 1 (MCL 21.171), as amended by 2008 PA 238.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. (1) The children's trust fund is created as a charitable and educational endowment fund in the department of treasury. The fund shall be expended only as provided in this section.
 - (2) The state treasurer shall credit to the trust fund all amounts appropriated for this purpose under section 475 of the income tax act of 1967, 1967 PA 281, MCL 206.475, any amounts received under section 811j of the Michigan vehicle code, 1949 PA 300, MCL 257.811j, and section 8 of the child abuse and neglect

- 14 previous fiscal year, BEGINNING IN FISCAL YEAR 2015 AND CONTINUING
- 15 THROUGH FISCAL YEAR 2017, ALL MONEY CONTRIBUTED TO THE FUND THAT
- 16 YEAR, PLUS 4.25% OF THE 12-QUARTER ROLLING AVERAGE OF THE FUND,
- 17 INCLUDING UNREALIZED GAINS AND LOSSES, shall be available for
- 18 disbursement upon the authorization of the state board as provided
- 19 in section 9 of the child abuse and neglect prevention act, 1982 PA
- 20 250, MCL 722.609.
- 21 (5) ON OCTOBER 1, 2017, PROVIDED THAT THE ROLLING AVERAGE OF
- 22 THE FUND FOR THE PREVIOUS 12 QUARTERS, INCLUDING UNREALIZED GAINS
- 23 AND LOSSES, IS AT LEAST \$23,500,000.00, THEN, BEGINNING WITH FISCAL
- 24 YEAR 2018, UP TO 5% OF THE 12-QUARTER ROLLING AVERAGE SHALL BE
- 25 AVAILABLE FOR DISBURSEMENT AS SPECIFIED IN THIS SUBSECTION.
- 26 (6) (5) Money granted or received as gifts or donations to the
- 27 trust fund shall be available for disbursement upon appropriation

- 13 representatives appropriations committees.
