SENATE BILL No. 1016

July 16, 2014, Introduced by Senator KAHN and referred to the Committee on Appropriations.

A bill to amend 1987 PA 231, entitled

"An act to create a transportation economic development fund in the state treasury; to prescribe the uses of and distributions from this fund; to create the office of economic development and to prescribe its powers and duties; to prescribe the powers and duties of the state transportation department, state transportation commission, and certain other bodies; and to permit the issuance of certain bonds,"

by amending section 11 (MCL 247.911), as amended by 2012 PA 621.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) Bonds may be issued as authorized by the
- 2 commission for the purpose of funding projects under this act in
- 3 the manner provided in sections 18b and 18k of 1951 PA 51, MCL
- 4 247.668b and 247.668k, and in accordance with the adopted
- 5 policies of the commission. Bonds shall not be committed for any
- 6 project under this act until the requirements under section 3(1)
- 7 have been satisfied.

- 1 (2) After the payment of interest and principal on bonds
- 2 issued under this act and the appropriation for costs of
- 3 administration of the fund as provided under this act, fund
- 4 revenue shall be annually appropriated as follows:
- 5 (a) The first \$5,000,000.00 for a forest roads program.
- 6 Forest roads program funds shall be distributed each fiscal year

- 9 national park, and national lakeshore land in each qualified

- 8 When 2 or more counties occupy the same category, the funds
- 9 shall be divided equally.
- 10 Projects funded under this category shall be used for the
- 11 widening of county primary roads or city major streets or for
- 12 advanced traffic management systems in eligible counties.
- 13 (c) 25% for development projects within rural counties.
- 14 These revenues shall be distributed for the improvement of rural
- 15 primary roads in rural counties and major streets in cities and
- 16 villages with a population of 5,000 or less. Funds distributed
- 17 under this subdivision shall be allocated by the commission to
- 18 the regional rural task force areas defined in section 12a in the
- 19 same proportion that the rural primary mileage of the regional
- 20 rural task force area bears to the total rural primary mileage of
- 21 all counties. Each rural county shall be credited with an
- 22 allocation in the proportion that the county's rural primary
- 23 mileage is to the total rural primary mileage of those rural
- 24 counties within the same regional rural task force area. Projects

- 2 (4) For the fiscal years ending September 30, 2011,
- 3 September 30, 2012, and September 30, 2013, AND SEPTEMBER 30,
- 4 2014 only, there is appropriated \$12,000,000.00 from the fund for
- 5 credit to the state trunk line fund established in section 11 of
- 6 1951 PA 51, MCL 247.661, for the purposes of matching available
- 7 federal-aid highway funds, and the distribution to targeted
- 8 industries under subsection (3)(a) shall be reduced accordingly.
- 9 (5) The obligation authority for any federal funds allocated
- 10 under section 10 of 1951 PA 51, MCL 247.660, shall be distributed
- 11 equally among urban task forces and regional rural task forces
- 12 according to the distribution formula outlined in subsection
- 13 (3)(b) and (c). An additional 1.5% of the obligation authority
- 14 for federal funds identified in section 10 of 1951 PA 51, MCL
- 15 247.660, shall be distributed among the regional rural task
- 16 forces according to the distribution formula outlined in
- 17 subsection (3)(c). These funds shall be obligated and used
- 18 consistent with section 10 of 1951 PA 51, MCL 247.660.
