HOUSE BILL NO. 4353

<<A bill to amend 1969 PA 287, entitled

"An act to regulate pet shops, animal control shelters, and animal protection shelters; to establish uniform procedures and minimum requirements for adoption of dogs, cats, and ferrets; and to prescribe penalties and civil fines and to provide remedies,"

by amending sections 1, 2, 5a, 6, 7, and 9 (MCL 287.331, 287.332, 287.335a, 287.336, 287.337, and 287.339), sections 1, 6, 7, and 9 as amended by 1997 PA 7 and section 5a as added by 1980 PA 214, and by adding sections 8c, 9c, and 9d.>>

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. As used in this act:

2 (a) "Adoption" means a transfer of ownership, with or without
3 remuneration, of a ~~dog, cat, or ferret~~ **AN ANIMAL** from an animal
4 control shelter or animal protection shelter to an individual for

1 the purpose of being a companion animal for that individual. As
2 used in this subdivision, a companion animal includes, but is not
3 limited to, a dog that is used for hunting or as a guard dog.

4 (b) "Alteration" means a professional sterilization procedure
5 performed by a veterinarian that renders a dog, cat, or ferret
6 incapable of reproducing.

7 (c) "Altered", in reference to a dog, cat, or ferret, means
8 having undergone alteration.

9 (d) "Animal" means a ~~mammal except livestock as defined in~~
10 ~~1937 PA 284, MCL 287.121 to 287.131, and rodents.~~ **VERTEBRATE OTHER**
11 **THAN A HUMAN BEING.**

12 (E) "ANIMAL ABUSE OFFENSE" MEANS 1 OR MORE OF THE FOLLOWING,
13 BUT DOES NOT INCLUDE THE LAWFUL USE OF AN ANIMAL TO HUNT OR TO
14 PARTICIPATE IN FIELD TRIALS OR THE LAWFUL KILLING OR OTHER USE OF
15 AN ANIMAL IN FARMING OR A GENERALLY ACCEPTED ANIMAL HUSBANDRY OR
16 FARMING PRACTICE INVOLVING LIVESTOCK:

17 (i) A VIOLATION OF SECTION 49 OF THE MICHIGAN PENAL CODE, 1931
18 PA 328, MCL 750.49.

19 (ii) A VIOLATION OF SECTION 50 OF THE MICHIGAN PENAL CODE,
20 1931 PA 328, MCL 750.50.

21 (iii) A VIOLATION OF SECTION 50A OF THE MICHIGAN PENAL CODE,
22 1931 PA 328, MCL 750.50A.

23 (iv) A VIOLATION OF SECTION 50B OF THE MICHIGAN PENAL CODE,
24 1931 PA 328, MCL 750.50B.

25 (v) A VIOLATION OF SECTION 50C OF THE MICHIGAN PENAL CODE,
26 1931 PA 328, MCL 750.50C.

27 (vi) A VIOLATION OF SECTION 158 OF THE MICHIGAN PENAL CODE,

1 1931 PA 328, MCL 750.158, IF THE VIOLATION AROSE OUT OF A CRIME
2 AGAINST NATURE WITH AN ANIMAL.

3 (vii) A VIOLATION OF A LOCAL ORDINANCE SUBSTANTIALLY
4 CORRESPONDING TO A VIOLATION DESCRIBED IN SUBPARAGRAPHS (i) TO
5 (vi) .

6 (viii) AN ATTEMPT OR CONSPIRACY TO COMMIT AN OFFENSE DESCRIBED
7 IN SUBPARAGRAPHS (i) TO (vii) .

8 (F) ~~(e)~~—"Animal control shelter" means a facility operated by
9 a municipality for the impoundment and care of animals that are
10 found in the streets or at large, animals that are otherwise held
11 due to the violation of a municipal ordinance or state law, or
12 animals that are surrendered to the animal control shelter.

13 (G) ~~(f)~~—"Animal protection shelter" means a facility operated
14 by a person, humane society, society for the prevention of cruelty
15 to animals, or any other nonprofit organization for the care of
16 homeless animals.

17 (H) ~~(g)~~—"Cat" means a domestic cat of any age of the species
18 ~~felis~~**FELIS** catus.

19 (I) ~~(h)~~—"Department" means the state department of agriculture
20 **AND RURAL DEVELOPMENT**.

21 (J) ~~(i)~~—"Director" means the director of the department or his
22 or her authorized representative.

23 (K) ~~(j)~~—"Dog" means a domestic dog of any age of the species
24 ~~canis~~**CANIS** familiaris.

25 (L) ~~(k)~~—"Ferret" means an animal of any age of the species
26 ~~mustela~~**MUSTELA** furo.

27 ~~— (l) "Health certificate" means a certificate in a form~~

1 ~~prescribed by the department in which a veterinarian attests to the~~
2 ~~age, sex, breed, and description of an animal, and to the fact that~~
3 ~~at the time of preparation of the certificate, the veterinarian~~
4 ~~examined the animal and found the animal free from visual evidence~~
5 ~~of communicable disease.~~

6 (M) "ICHAT" MEANS THE INTERNET CRIMINAL HISTORY ACCESS TOOL
7 MAINTAINED BY THE DEPARTMENT OF STATE POLICE.

8 (N) "INTACT DOG" MEANS A DOG THAT HAS NOT BEEN ALTERED.

9 (O) "LARGE-SCALE DOG BREEDING KENNEL" MEANS A FACILITY WHERE
10 MORE THAN 15 FEMALE INTACT DOGS OVER THE AGE OF 4 MONTHS ARE HOUSED
11 OR KEPT FOR THE PRIMARY PURPOSE OF BREEDING. AS USED IN THIS
12 SUBDIVISION, "HOUSED OR KEPT FOR THE PRIMARY PURPOSE OF BREEDING"
13 MEANS THAT THE FEMALE DOG HAS PREVIOUSLY BEEN BRED AND WHELPED. A
14 FEMALE DOG THAT HAS NOT PREVIOUSLY PRODUCED OFFSPRING SHALL NOT BE
15 CONSIDERED TO HAVE BEEN HOUSED OR KEPT FOR THE PRIMARY PURPOSE OF
16 BREEDING.

17 (P) ~~(m)~~ "Municipality" means a county, city, village, or
18 township.

19 (Q) ~~(n)~~ "Person" means an individual, partnership,
20 corporation, association, governmental entity, or other legal
21 entity.

22 (R) "PET HEALTH CERTIFICATE" MEANS A CERTIFICATE IN A FORM
23 PRESCRIBED BY THE DIRECTOR IN WHICH A VETERINARIAN ATTESTS TO THE
24 SPECIES, AGE, SEX, BREED, AND DESCRIPTION OF AN ANIMAL; ANY MEDICAL
25 CONDITIONS OF THE ANIMAL; ANY MEDICAL TREATMENT AND VACCINATIONS
26 THAT THE ANIMAL RECEIVED WHILE UNDER THE CONTROL OF A PET SHOP OR
27 LARGE-SCALE DOG BREEDING KENNEL; AND TO THE FACT THAT AT THE TIME

1 OF THE PREPARATION OF THE CERTIFICATE THE VETERINARIAN EXAMINED THE
 2 ANIMAL AND FOUND THE ANIMAL FREE FROM VISUAL EVIDENCE OF
 3 COMMUNICABLE DISEASE.

4 (S) ~~(e)~~ "Pet shop" means a place where animals are sold or
 5 offered for sale, exchange, or transfer.

6 (T) ~~(p)~~ "Veterinarian" means a person licensed to practice
 7 veterinary medicine under ~~article 15~~ **PART 188** of the public health
 8 code, 1978 PA 368, MCL ~~333.16101~~ **333.18801** to 333.18838.

9 Sec. 2. (1) The ~~agriculture department shall issue~~ **MAY**
 10 **PROMULGATE** rules to accomplish the purposes of this act and to
 11 establish minimum standards for **THE** housing, care, and handling of
 12 animals to insure the humane care and handling of animals. **THE**
 13 **DEPARTMENT MAY ALSO PROMULGATE RULES TO ESTABLISH MINIMUM STANDARDS**
 14 **FOR LARGE-SCALE DOG BREEDING KENNELS.** The rules shall be

18 **LARGE-SCALE DOG BREEDING KENNEL SHALL NOT SELL, EXCHANGE, OR**

26 **(A) THE dog has been** ~~inoculated~~ **VACCINATED** against distemper,
27 ~~hepatitis, and leptospirosis, para influenza and, if~~ **PARVOVIRUS,**

1 AND CANINE ADENOVIRUS-2. THE DOG SHALL ALSO BE VACCINATED AGAINST
2 RABIES AND LEPTOSPIROSIS IF THE DOG IS 12 WEEKS OF AGE OR OLDER. IF
3 A RABIES VACCINE IS REQUIRED UNDER THIS SUBDIVISION, THE VACCINE
4 SHALL BE ADMINISTERED BY AN ACCREDITED VETERINARIAN. A PERSON
5 OPERATING A PET SHOP OR A LARGE-SCALE DOG BREEDING KENNEL SHALL
6 ENSURE THAT VACCINATIONS OTHER THAN THE RABIES VACCINATION ARE

19 medication and immunization.

1 ~~and, if~~ **AND FELINE HERPES VIRUS-1. THE CAT SHALL ALSO BE VACCINATED**
2 **AGAINST RABIES IF THE CAT IS 12 WEEKS OF AGE OR OLDER. IF A RABIES**
3 **VACCINE IS REQUIRED UNDER THIS SUBDIVISION, THE VACCINE SHALL BE**
4 **ADMINISTERED BY AN ACCREDITED VETERINARIAN. A PERSON OPERATING A**
5 **PET SHOP SHALL ENSURE THAT VACCINATIONS OTHER THAN THE RABIES**
6 **VACCINATION ARE ADMINISTERED TO THE CAT AS REQUIRED BY THIS**

17 signed by ~~a~~ **AN ACCREDITED** veterinarian **LICENSED TO PRACTICE**
18 **VETERINARY MEDICINE IN THE CAT'S STATE OF ORIGIN,** including records
19 of the cat's medication and immunization.

2 Sec. 6. (1) A municipality shall not operate an animal control
3 shelter unless the animal control shelter is registered with the
4 department.

5 (2) A society for the prevention of cruelty to animals ~~or~~
6 any other person ~~or~~ shall not operate an animal protection shelter
7 unless the shelter is registered with the department.

8 (3) A PERSON SHALL NOT OPERATE A LARGE-SCALE DOG BREEDING
9 KENNEL UNLESS THE LARGE-SCALE DOG BREEDING KENNEL IS REGISTERED
10 WITH THE DEPARTMENT. THE DEPARTMENT SHALL CHARGE AN ANNUAL FEE OF
11 \$500.00 PER REGISTRATION OF A LARGE-SCALE DOG BREEDING KENNEL.

12 (4) THIS ACT IS NOT INTENDED TO APPLY TO A DOG OWNER OR
13 BREEDER OTHER THAN A PERSON THAT OPERATES A LARGE-SCALE DOG

19 SEC. 8C. (1) AN ANIMAL CONTROL SHELTER OR ANIMAL PROTECTION

21 WHETHER TO ALLOW THAT INDIVIDUAL TO ADOPT AN ANIMAL. AN ANIMAL

5 Sec. 9. (1) ~~The~~ EXCEPT AS OTHERWISE PROVIDED IN THIS
6 SUBSECTION, THE licensing and registration requirements of this act
7 do not apply to a person who breeds his or her own animals or to a
8 person subject to 1969 PA 224, MCL 287.381 to 287.395. THE
9 LICENSING AND REGISTRATION REQUIREMENTS OF THIS ACT APPLY TO A
10 LARGE-SCALE DOG BREEDING KENNEL.

11 (2) Subsection (1) does not create an exemption from
12 vaccination and licensing requirements under the dog law of 1919,
13 1919 PA 339, MCL 287.261 to 287.290, or from vaccination and
14 handling requirements under 1994 PA 358, MCL 287.891 to 287.901.

15 (3) This act does not require the alteration of a dog, cat, or
16 ferret being reclaimed from an animal control shelter or animal
17 protection shelter by its owner unless a local ~~governmental~~
18 GOVERNMENT ordinance requires the alteration.

19 SEC. 9C. (1) A LARGE-SCALE DOG BREEDING KENNEL SHALL MAINTAIN
20 CURRENT VERIFIABLE RECORDS FOR A PERIOD OF AT LEAST 2 YEARS. THE
21 RECORDS SHALL INCLUDE ALL OF THE FOLLOWING INFORMATION:

22 (A) THE VERIFIED NAME AND ADDRESS OF THE PERSON FROM WHOM THE
23 DOG WAS ACQUIRED, WHERE THE DOG WAS ACQUIRED, AND THE DATE THAT THE
24 DOG WAS ACQUIRED.

25 (B) A DESCRIPTION AND IDENTIFICATION OF THE DOG, INCLUDING THE
26 DOG'S IDENTIFICATION INFORMATION, COLOR, BREED, SEX, ALTERATION
27 STATUS, AND APPROXIMATE WEIGHT AND AGE.

1 (C) THE DATE AND METHOD OF DISPOSITION OF THE DOG. IF THE DOG
2 IS ADOPTED, TRANSFERRED, OR SOLD, THE RECORDS SHALL ALSO INCLUDE
3 THE VERIFIED NAME AND ADDRESS OF THE PERSON TO WHOM THE DOG IS
4 ADOPTED, TRANSFERRED, OR SOLD.

5 (D) THE NUMBER OF DOGS ON SITE DAILY AT EACH PHYSICAL
6 LOCATION.

7 (E) THE NUMBER OF INTACT BREEDING ADULT FEMALE DOGS ON SITE
8 DAILY AT THE PHYSICAL LOCATION.

9 (F) BREEDING RECORDS FOR EACH FEMALE INTACT DOG THAT INCLUDE
10 THE APPROXIMATE DATE THE DOG WAS BRED AND THE BIRTH DATE AND SIZE
11 OF EACH LITTER DURING THE TIME THAT THE DOG WAS AT THE PHYSICAL
12 LOCATION.

13 (2) A LARGE-SCALE DOG BREEDING KENNEL SHALL MAKE THE RECORDS
14 REQUIRED UNDER SUBSECTION (1) AVAILABLE TO THE DIRECTOR OR HIS OR
15 HER REPRESENTATIVE ON REQUEST.

16 SEC. 9D. NO LATER THAN 18 MONTHS AFTER THE EFFECTIVE DATE OF
17 THE AMENDATORY ACT THAT ADDED THIS SECTION AND ANNUALLY THEREAFTER
18 UNTIL SEPTEMBER 30, 2019, THE DEPARTMENT SHALL PREPARE AND SUBMIT A
19 REPORT TO THE SENATE AND HOUSE STANDING COMMITTEES ON

27 KENNELS PERFORMED BY THE DEPARTMENT OR A PARTNER OF THE DEPARTMENT.

1 (D) THE NUMBER OF COMPLAINTS RECEIVED REGARDING LARGE-SCALE
2 DOG BREEDING KENNELS.

3 (E) THE NUMBER OF PENDING OR ASSESSED PENALTIES ARISING FROM
4 THE COMPLAINTS DESCRIBED IN SUBDIVISION (D).
