A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 312j.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 312J. (1) THE DEPARTMENT SHALL ESTABLISH A PILOT PROGRAM
- 2 THAT, AS DETERMINED BY THE DEPARTMENT, PROVIDES FOR THE SKILLS
- 3 TESTING OF AN INDIVIDUAL WHO HOLDS A VALID COMMERCIAL LEARNER'S
- 4 PERMIT ISSUED BY A STATE OTHER THAN THIS STATE.
- 5 (2) AN INDIVIDUAL WHO HOLDS A VALID COMMERCIAL LEARNER'S
- 6 PERMIT ISSUED BY A STATE OTHER THAN THIS STATE IS NOT ELIGIBLE FOR
- 7 SKILLS TESTING AS DESCRIBED IN SUBSECTION (1) UNLESS ALL OF THE
- 8 FOLLOWING ARE SATISFIED:
- 9 (A) THE INDIVIDUAL HAS SUCCESSFULLY COMPLETED A TRUCK DRIVER
- 10 TRAINING [CURRICULUM THAT HAS BEEN APPROVED BY THE DEPARTMENT AND] PROVIDED BY A PERSON THAT HAS BEEN APPROVED TO

- PROVIDE TRUCK DRIVER TRAINING UNDER THE DRIVER EDUCATION PROVIDER 1
- 2 AND INSTRUCTOR ACT, 2006 PA 384, MCL 256.621 TO 256.705.
- (B) THE STATE THAT ISSUED THE COMMERCIAL LEARNER'S PERMIT IS A 3
- PARTICIPANT IN AN ELECTRONIC NATIONAL COMMERCIAL DRIVER EXAMINATION
- REPORTING SYSTEM IN WHICH THIS STATE IS ALSO A PARTICIPANT. 5
- (3) THE PILOT PROGRAM DESCRIBED IN SUBSECTION (1) SHALL
- CONTINUE UNTIL THE DEPARTMENT ADOPTS CURRICULUM REQUIREMENTS FOR A 7
- PERSON PROVIDING INSTRUCTION TO INDIVIDUALS SEEKING A VEHICLE GROUP 8
- DESIGNATION OR INDORSEMENT DESCRIBED IN SECTION 312E. 9
- 10 Enacting section 1. This amendatory act takes effect 90 days
- 11 after the date it is enacted into law.
