

HOUSE SUBSTITUTE FOR  
SENATE BILL NO. 34

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 1. (1) As used in this act:

2           (a) "Felony" means, **EXCEPT AS OTHERWISE PROVIDED IN THIS**  
3 **SUBDIVISION**, that term as defined in section 1 of chapter I of the  
4 code of criminal procedure, 1927 PA 175, MCL 761.1, or a violation  
5 of a law of the United States or another state that is designated  
6 as a felony or that is punishable by death or by imprisonment for  
7 more than 1 year. **FELONY DOES NOT INCLUDE A VIOLATION OF A PENAL**  
8 **LAW OF THIS STATE THAT IS EXPRESSLY DESIGNATED AS A MISDEMEANOR.**

9           (b) "Firearm" means a weapon from which a dangerous projectile  
10 may be propelled by an explosive, or by gas or air. Firearm does  
11 not include a smooth bore rifle or handgun designed and  
12 manufactured exclusively for propelling by a spring, or by gas or  
13 air, BBs not exceeding .177 caliber.

14           (c) "Firearms records" means any form, information, or record  
15 required for submission to a government agency under sections 2,  
16 2a, 2b, and 5b, or any form, permit, or license issued by a  
17 government agency under this act.

18           (d) "Misdemeanor" means a violation of a penal law of this  
19 state or violation of a local ordinance substantially corresponding  
20 to a violation of a penal law of this state that is not a felony or

1 a violation of an order, rule, or regulation of a state agency that  
2 is punishable by imprisonment or a fine that is not a civil fine,  
3 or both.

4 (e) "Peace officer" means, except as otherwise provided in  
5 this act, an individual who is employed as a law enforcement  
6 officer, as that term is defined under section 2 of the commission  
7 on law enforcement standards act, 1965 PA 203, MCL 28.602, by this  
8 state or another state, a political subdivision of this state or  
9 another state, or the United States, and who is required to carry a  
10 firearm in the course of his or her duties as a law enforcement  
11 officer.

12 (f) "Pistol" means a loaded or unloaded firearm that is 26  
13 inches or less in length, or a loaded or unloaded firearm that by  
14 its construction and appearance conceals it as a firearm.

15 (g) "Purchaser" means a person who receives a pistol from  
16 another person by purchase or gift.

17 (h) "Reserve peace officer", "auxiliary officer", or "reserve  
18 officer" means, except as otherwise provided in this act, an  
19 individual authorized on a voluntary or irregular basis by a duly  
20 authorized police agency of this state or a political subdivision  
21 of this state to act as a law enforcement officer, who is  
22 responsible for the preservation of the peace, the prevention and  
23 detection of crime, and the enforcement of the general criminal  
24 laws of this state, and who is otherwise eligible to possess a  
25 firearm under this act.

26 (i) "Retired police officer" or "retired law enforcement  
27 officer" means an individual who was a police officer or law

1 enforcement officer who was certified as described under section 9a  
2 of the commission on law enforcement standards act, 1965 PA 203,  
3 MCL 28.609a, and retired in good standing from his or her  
4 employment as a police officer or law enforcement officer. **A POLICE  
5 OFFICER OR LAW ENFORCEMENT OFFICER RETIRED IN GOOD STANDING IF HE  
6 OR SHE RECEIVES A PENSION OR OTHER RETIREMENT BENEFIT FOR HIS OR  
7 HER SERVICE AS A POLICE OFFICER OR LAW ENFORCEMENT OFFICER OR  
8 ACTIVELY MAINTAINED A MICHIGAN COMMISSION ON LAW ENFORCEMENT  
9 STANDARDS OR EQUIVALENT STATE CERTIFICATION FOR 10 OR MORE  
10 CONSECUTIVE YEARS.**

11 (j) "Seller" means a person who sells or gives a pistol to  
12 another person.

13 (k) "State court judge" means a judge of the district court,  
14 circuit court, probate court, or court of appeals or justice of the  
15 supreme court of this state who is serving either by election or  
16 appointment.

17 (l) "State court retired judge" means a judge or justice  
18 described in subdivision (k) who is retired, or a retired judge of  
19 the recorders court.

20 (2) A person may lawfully own, possess, carry, or transport as  
21 a pistol a firearm greater than 26 inches in length if all of the  
22 following conditions apply:

23 (a) The person registered the firearm as a pistol under  
24 section 2 or 2a before January 1, 2013.

25 (b) The person who registered the firearm as described in  
26 subdivision (a) has maintained registration of the firearm since  
27 January 1, 2013 without lapse.

1 (c) The person possesses a copy of the license or record  
2 issued to him or her under section 2 or 2a.

3 (3) A person who satisfies all of the conditions listed under  
4 subsection (2) nevertheless may elect to have the firearm not be  
5 considered to be a pistol. A person who makes the election under  
6 this subsection shall notify the department of state police of the  
7 election in a manner prescribed by that department.

8 Sec. 2a. (1) The following individuals are not required to  
9 obtain a license under section 2 to purchase, carry, possess, use,  
10 or transport a pistol:

11 (a) An individual licensed under section 5b, **EXCEPT FOR AN**  
12 **INDIVIDUAL WHO HAS AN EMERGENCY LICENSE ISSUED UNDER SECTION 5A(4)**  
13 **OR A RECEIPT SERVING AS A CONCEALED PISTOL LICENSE UNDER SECTION**  
14 **5B(9) OR 5/(3).**

15 (b) A federally licensed firearms dealer.

16 (c) An individual who purchases a pistol from a federally  
17 licensed firearms dealer in compliance with 18 USC 922(t).

18 (2) If an individual described in subsection (1) purchases or  
19 otherwise acquires a pistol, the seller shall complete a record in  
20 triplicate on a form provided by the department of state police.  
21 The record shall include the purchaser's concealed weapon license  
22 number or, if the purchaser is a federally licensed firearms  
23 dealer, his or her dealer license number. If the purchaser is not  
24 licensed under section 5b and is not a federally licensed firearms  
25 dealer, the record shall include the dealer license number of the  
26 federally licensed firearms dealer who is selling the pistol. The  
27 purchaser shall sign the record. The seller may retain 1 copy of

1 the record. The purchaser shall receive 2 copies of the record and  
2 forward 1 copy to the police department of the city, village, or  
3 township in which the purchaser resides, or, if the purchaser does  
4 not reside in a city, village, or township having a police  
5 department, to the county sheriff, within 10 days following the  
6 purchase or acquisition. The return of the copy to the police  
7 department or county sheriff may be made in person or may be made  
8 by first-class mail or certified mail sent within the 10-day period  
9 to the proper address of the police department or county sheriff. A  
10 purchaser who fails to comply with the requirements of this  
11 subsection is responsible for a state civil infraction and may be  
12 fined not more than \$250.00. If a purchaser is found responsible  
13 for a state civil infraction under this subsection, the court shall  
14 notify the department of state police. If the purchaser is licensed  
15 under section 5b, the court shall notify the licensing authority of  
16 that determination.

17 (3) Within 10 days after receiving the record copy returned  
18 under subsection (2), the police department or county sheriff shall  
19 electronically enter the information into the pistol entry database  
20 as required by the department of state police if it has the ability  
21 to electronically enter that information. If the police department  
22 or county sheriff does not have that ability, the police department  
23 or county sheriff shall provide that information to the department  
24 of state police in a manner otherwise required by the department of  
25 state police. Any police department or county sheriff that provided  
26 pistol descriptions to the department of state police under former  
27 section 9 of this act shall continue to provide pistol descriptions

1 to the department of state police under this subsection. Within 48  
2 hours after entering or otherwise providing the information on the  
3 record copy returned under subsection (2) to the department of  
4 state police, the police department or county sheriff shall forward  
5 the copy of the record to the department of state police. The  
6 purchaser has the right to obtain a copy of the information placed  
7 in the pistol entry database under this subsection to verify the  
8 accuracy of that information. The police department or county  
9 sheriff may charge a fee not to exceed \$1.00 for the cost of  
10 providing the copy. The purchaser may carry, use, possess, and  
11 transport the pistol for 30 days beginning on the date of purchase  
12 or acquisition only while he or she is in possession of his or her  
13 copy of the record. However, the person is not required to have the  
14 record in his or her possession while carrying, using, possessing,  
15 or transporting the pistol after this period.

16 (4) This section does not apply to a person or entity exempt  
17 under section 2(7).

18 (5) An individual who makes a material false statement on a  
19 sales record under this section is guilty of a felony punishable by  
20 imprisonment for not more than 4 years or a fine of not more than  
21 \$2,500.00, or both.

22 (6) The department of state police may promulgate rules to  
23 implement this section.

24 (7) As used in this section:

25 (a) Before December 18, 2012, "federally licensed firearms  
26 dealer" means an individual who holds a type 01 dealer license  
27 under 18 USC 923.

1 (b) Beginning December 18, 2012, "federally licensed firearms  
2 dealer" means a person licensed to sell firearms under 18 USC 923.

3 (c) "Person" means an individual, partnership, corporation,  
4 association, or other legal entity.

5 Sec. 4. (1) A person who is prohibited from possessing, using,  
6 transporting, selling, purchasing, carrying, shipping, receiving,  
7 or distributing a firearm under section 224f(2) of the Michigan  
8 penal code, 1931 PA 328, MCL 750.224f, may apply to the ~~concealed~~  
9 ~~weapons licensing board~~ **CIRCUIT COURT** in the county in which he or  
10 she resides for restoration of those rights.

11 (2) A person who is prohibited from possessing, using,  
12 transporting, selling, carrying, shipping, or distributing  
13 ammunition under section 224f(4) of the Michigan penal code, 1931  
14 PA 328, MCL 750.224f, may apply to the ~~concealed weapons licensing~~  
15 ~~board~~ **CIRCUIT COURT** in the county in which he or she resides for  
16 restoration of those rights.

17 (3) Not more than 1 application may be submitted under  
18 subsection (1) or (2) in any calendar year. The ~~concealed weapons~~  
19 ~~licensing board may~~ **CIRCUIT COURT SHALL** charge a fee of not more  
20 than ~~\$10.00 for the actual and necessary expenses of each~~  
21 ~~application.~~ **AS PROVIDED IN SECTION 2529 OF THE REVISED JUDICATURE**  
22 **ACT OF 1961, 1961 PA 236, MCL 600.2529, UNLESS THE COURT WAIVES**  
23 **THAT FEE.**

24 (4) The ~~concealed weapons licensing board~~ **CIRCUIT COURT** shall,  
25 by written order, ~~of the board,~~ restore the rights of a person to  
26 possess, use, transport, sell, purchase, carry, ship, receive, or  
27 distribute a firearm or to possess, use, transport, sell, carry,



1 ship, or distribute ammunition if the ~~board~~ **CIRCUIT COURT**  
2 determines, by clear and convincing evidence, that all of the  
3 following circumstances exist:

4 (a) The person properly submitted an application for  
5 restoration of those rights as provided under this section.

6 (b) The expiration of 5 years after all of the following  
7 circumstances:

8 (i) The person has paid all fines imposed for the violation  
9 resulting in the prohibition.

10 (ii) The person has served all terms of imprisonment imposed  
11 for the violation resulting in the prohibition.

12 (iii) The person has successfully completed all conditions of  
13 probation or parole imposed for the violation resulting in the  
14 prohibition.

15 (c) The person's record and reputation are such that the  
16 person is not likely to act in a manner dangerous to the safety of  
17 other persons.

18 ~~—— (5) If the concealed weapons licensing board under subsection~~  
19 ~~(4) refuses to restore a right under this section, the person may~~  
20 ~~petition the circuit court for review of that decision.~~

21 Sec. 5. (1) County ~~sheriffs, local police agencies, and county~~  
22 clerks shall provide concealed pistol application kits during  
23 normal business hours and free of charge to individuals who wish to  
24 apply for licenses to carry concealed pistols. Each kit shall only  
25 contain all of the following:

26 (a) A concealed pistol license application form provided by  
27 the director of the department of state police.

1 (b) The fingerprint cards ~~required~~ under section  
2 ~~5b(11)-5B(10)~~, **IF REQUIRED**.

3 (c) Written information regarding the procedures involved in  
4 obtaining a license to carry a concealed pistol. ~~, including~~  
5 ~~information regarding the right to appeal the denial of a license~~  
6 ~~and the form required for that appeal.~~

7 (d) Written information identifying entities that offer the  
8 training required under section 5b(7)(c), **IF MAINTAINED BY THE**  
9 **COUNTY CLERK**.

10 (2) A ~~county sheriff, local police agency, or county clerk~~  
11 shall not deny an individual the right to receive a concealed  
12 pistol application kit under this section.

13 (3) An individual who is denied an application kit under this  
14 section and obtains an order of mandamus directing the ~~concealed~~  
15 ~~weapon licensing board~~ **COUNTY CLERK** to provide him or her with the  
16 application kit shall be awarded his or her actual and reasonable  
17 costs and attorney fees for obtaining the order.

18 (4) The department of state police shall provide the  
19 application kits required under this section to ~~county sheriffs,~~  
20 ~~local law enforcement agencies,~~ and county clerks in sufficient  
21 ~~quantities to meet demand.~~ **AN ELECTRONIC FORMAT**. The department of  
22 state police shall not charge a fee for the kits.

23 Sec. 5a. ~~(1) Each county shall have a concealed weapon~~  
24 ~~licensing board. The concealed weapon licensing board of each~~  
25 ~~county shall have the following members:~~

26 ~~—— (a) The county prosecuting attorney or his or her designee.~~

27 ~~However, if the county prosecuting attorney decides that he or she~~

1 ~~does not want to be a member of the concealed weapon licensing~~  
2 ~~board, he or she shall notify the county board of commissioners in~~  
3 ~~writing that he or she does not want to be a member of the~~  
4 ~~concealed weapon licensing board for the balance of his or her term~~  
5 ~~in office. The county board of commissioners shall then appoint a~~

23 ~~—— (a) The prosecuting attorney shall be notified of all~~  
24 ~~applications received by the concealed weapon licensing board.~~

25 ~~—— (b) The prosecuting attorney shall be given an opportunity to~~  
26 ~~object to granting a license to carry a concealed pistol and~~  
27 ~~present evidence bearing directly on an applicant's suitability to~~

1 ~~carry a concealed pistol safely.~~

2 ~~—— (c) The prosecuting attorney shall disclose to the concealed~~

17 LICENSING BOARD SHALL TRANSFER ALL LICENSE APPLICATIONS AND  
18 OFFICIAL DOCUMENTS IN ITS POSSESSION TO THE COUNTY CLERK OF THE  
19 COUNTY IN WHICH THE BOARD IS LOCATED NO LATER THAN NOVEMBER 30,  
20 2015. ALL PENDING APPLICATIONS REMAIN IN PLACE, ARE CONSIDERED TO

1 VISUAL EVIDENCE OF THREATS TO THE APPLICANT OR MEMBER OF THE  
2 APPLICANT'S FAMILY OR HOUSEHOLD. A COUNTY CLERK SHALL ONLY ISSUE AN  
3 EMERGENCY LICENSE TO CARRY A CONCEALED PISTOL TO AN APPLICANT WHO  
4 HAS OBTAINED A PERSONAL PROTECTION ORDER IF THE INDIVIDUAL IS  
5 ELIGIBLE UNDER SECTION 5B(7)(D), (E), (F), (H), (I), (J), (K), AND  
6 (M) TO RECEIVE A LICENSE BASED ON A CRIMINAL RECORD CHECK THROUGH  
7 THE LAW ENFORCEMENT INFORMATION NETWORK CONDUCTED BY THE DEPARTMENT  
8 OF STATE POLICE. THE COUNTY SHERIFF SHALL ONLY ISSUE A
