

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 647

A bill to amend 1976 PA 451, entitled
"The revised school code,"
(MCL 380.1 to 380.1852) by adding section 1170a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1170A. (1) BY NOT LATER THAN THE 2017-2018 SCHOOL YEAR,
2 THE DEPARTMENT SHALL ENSURE THAT THE MODEL CORE ACADEMIC CURRICULUM
3 CONTENT STANDARDS FOR HEALTH EDUCATION AND THE SUBJECT AREA CONTENT
4 EXPECTATIONS AND GUIDELINES FOR HEALTH EDUCATION UNDER SECTION
5 1278A PROVIDE FOR ALL OF THE FOLLOWING:

6 (A) INSTRUCTION IN CARDIOPULMONARY RESUSCITATION FOR PUPILS
7 ENROLLED IN GRADES 7 TO 12. SUBJECT TO SUBSECTION (5), THE CONTENT
8 STANDARDS AND SUBJECT AREA CONTENT EXPECTATIONS SHALL ENSURE THAT
9 THE PSYCHOMOTOR SKILLS NECESSARY TO PERFORM CARDIOPULMONARY

1 RESUSCITATION ARE INCORPORATED INTO THE INSTRUCTION AND THAT THE
2 INSTRUCTION IS BASED ON EITHER OF THE FOLLOWING:

3 (i) AN INSTRUCTIONAL PROGRAM DEVELOPED BY THE AMERICAN RED
4 CROSS OR THE AMERICAN HEART ASSOCIATION.

5 (ii) NATIONALLY RECOGNIZED, EVIDENCE-BASED GUIDELINES FOR
6 CARDIOPULMONARY RESUSCITATION.

7 (B) INSTRUCTION ABOUT AUTOMATED EXTERNAL DEFIBRILLATORS FOR
8 PUPILS ENROLLED IN GRADES 7 TO 12.

9 (2) THE CONTENT STANDARDS OR SUBJECT AREA CONTENT EXPECTATIONS
10 AND GUIDELINES UNDER SUBSECTION (1) SHALL NOT REQUIRE A
11 CERTIFICATED TEACHER TO BE AN AUTHORIZED CPR/AED INSTRUCTOR TO
12 FACILITATE, PROVIDE, OR OVERSEE INSTRUCTION DESCRIBED IN SUBSECTION
13 (1) (A) IF THAT INSTRUCTION DOES NOT RESULT IN A PUPIL EARNING A CPR
14 CERTIFICATION CARD OR STATUS.

15 (3) IF INSTRUCTION DESCRIBED IN SUBSECTION (1) (A) WILL RESULT
16 IN A PUPIL EARNING A CPR CERTIFICATION CARD OR STATUS, THAT
17 INSTRUCTION MUST BE TAUGHT BY AN AUTHORIZED CPR/AED INSTRUCTOR, AS
18 APPLICABLE.

19 (4) SCHOOL DISTRICTS, PUBLIC SCHOOL ACADEMIES, AND NONPUBLIC
20 SCHOOLS ARE ENCOURAGED TO USE LOCALLY AVAILABLE RESOURCES TO
21 PROVIDE THE INSTRUCTION REQUIRED TO MEET THE CONTENT STANDARDS OR
22 SUBJECT AREA CONTENT EXPECTATIONS AND GUIDELINES UNDER SUBSECTION
23 (1), INCLUDING, BUT NOT LIMITED TO, EMERGENCY MEDICAL TECHNICIANS,
24 PARAMEDICS, POLICE OFFICERS, FIREFIGHTERS, REPRESENTATIVES OF THE
25 AMERICAN HEART ASSOCIATION OR AMERICAN RED CROSS, OR PROPERLY
26 TRAINED TEACHERS OR OTHER SCHOOL EMPLOYEES.

27 (5) THE CONTENT STANDARDS AND SUBJECT AREA CONTENT

1 EXPECTATIONS AND GUIDELINES REQUIRED UNDER SUBSECTION (1) SHALL
2 PROVIDE THAT A SCHOOL OR PROGRAM THAT PROVIDES 100% ONLINE
3 INSTRUCTION IS EXEMPT FROM HAVING TO INCORPORATE PSYCHOMOTOR SKILLS
4 INTO THE INSTRUCTION UNDER THIS SECTION.

5 (6) AS USED IN THIS SECTION:

6 (A) "AUTHORIZED CPR/AED INSTRUCTOR" MEANS AN INSTRUCTOR WHO IS
7 AUTHORIZED BY THE AMERICAN HEART ASSOCIATION, AMERICAN RED CROSS,
8 OR A SIMILAR NATIONALLY RECOGNIZED ASSOCIATION TO PROVIDE
9 INSTRUCTION IN CARDIOPULMONARY RESUSCITATION THAT RESULTS IN THE
10 ISSUANCE OF A CPR CERTIFICATION CARD OR STATUS.

11 (B) "CPR CERTIFICATION CARD OR STATUS" MEANS A CARD OR OTHER
12 CREDENTIAL EVIDENCING SUCCESSFUL COMPLETION OF INSTRUCTION IN
13 CARDIOPULMONARY RESUSCITATION THAT IS ISSUED BY THE AMERICAN HEART
14 ASSOCIATION, AMERICAN RED CROSS, OR A SIMILAR NATIONALLY RECOGNIZED
15 ORGANIZATION USING EVIDENCE-BASED GUIDELINES FOR THE TEACHING OF
16 CARDIOPULMONARY RESUSCITATION.

17 Enacting section 1. This amendatory act takes effect 90 days
18 after the date it is enacted into law.
