- 18 Sec. 233. Sixty days prior to the public announcement of the
- 19 intention to sell any department real property, the department
- 20 shall submit notification of that intent to the subcommittees and
- 21 the senate and house fiscal agencies.
- 22 Sec. 234. The one-time appropriations in part 1 for special
- 23 maintenance shall be carried forward at the end of the fiscal year
- 24 consistent with section 248 of the management and budget act, 1984
- 25 PA 431, MCL 18.1248.
- 26 Sec. 240. In addition to the metrics required under section
- 27 447 of the management and budget act, 1984 PA 431, MCL 18.1447, for

- 16 section 5 of article XI of the state constitution of 1963. These
- 17 positions include the following: department director the adjutant
- 18 general for Michigan; assistant adjutant general army; assistant
- 19 adjutant general installations; assistant adjutant general air;
- 20 senior policy executive Michigan veterans affairs agency; senior
- 21 deputy director state operations; director strategy and policy;
- 22 chief executive officer for the veteran health system; and director
- 23 Michigan veterans affairs agency.
- 24 (2) Not less than 30 days prior to the department submitting a
- 25 request for an additional unclassified employee position from the
- 26 civil service commission, or for any substantive change to the

- 1 duties of an existing unclassified employee position, the
- 2 department shall notify the subcommittees and the senate and house
- 3 fiscal agencies.

### 4 ARMORIES AND JOINT FORCE READINESS

- 5 Sec. 302. (1) From the funds appropriated in part 1 for
- 6 military operations, effective and efficient executive direction
- 7 and administrative leadership shall be provided to the department.
- 8 (2) The department shall operate and maintain National Guard
- 9 armories.
- 10 (3) The department shall evaluate armories and submit a
- 11 quarterly report on the status of the armories.
- 12 (4) The department shall maintain a system to measure the
- 13 condition and adequacy of the armories.
- 14 (5) The Michigan Army National Guard and Air National Guard
- 15 shall work to provide a culture that is free of sexual assault,
- 16 through an environment of prevention, education and training,
- 17 response capability, victim support, reporting procedures, and
- 18 appropriate accountability that enhances the safety and well-being
- 19 of all quard members.
- 20 (6) By December 1, the department shall report the following
- 21 information to the subcommittees, the senate and house fiscal
- 22 agencies, and the state budget office:
- 23 (a) An assessment of the grounds and facilities of each armory
- 24 to objectively measure and determine the current facility condition
- 25 and capability to support authorized manpower, unit training, and
- 26 operations.
- 27 (b) Recommendations for the placement of new armories, the

- 1 relocation or consolidation of existing armories, or a change in
- 2 the mission of units assigned to armories to ideally position the
- 3 National Guard in current or projected population centers.
- 4 (c) Recommendations for the enhanced use of armories to
- 5 facilitate family support programs during deployments.
- 6 (d) An analysis of the feasibility, potential costs, and
- 7 benefits of use of armories shared with other local, state, or
- 8 federal agencies to improve responses to local emergencies as well
- 9 as the community support provided to armories.
- 10 (e) An investment strategy and proposed funding amounts in a
- 11 prioritized project list to correct the most critical facility
- 12 shortfalls across the inventory of armories in this state.

#### 13 NATIONAL GUARD TRAINING FACILITIES AND AIR BASES

- 14 Sec. 304. (1) The department shall provide Army and Air
- 15 National Guard forces, when directed, for state and local
- 16 emergencies and in support of national military requirements.
- 17 (2) The department shall operate and maintain Army National
- 18 Guard training facilities, including Fort Custer and Camp Grayling.
- 19 (3) The department shall maintain a system that measures the
- 20 condition and adequacy of air facilities using both quality and
- 21 functionality criteria.
- 22 (4) The department shall operate and maintain Air National
- 23 Guard air bases, including Selfridge Air National Guard base,
- 24 Battle Creek Air National Guard base, and Alpena combat readiness
- 25 training center.
- 26 (5) The department shall provide the following information as
- 27 provided under section 219:

- 1 (a) The apportioned and assigned strength of the Michigan Army
- 2 National Guard.
- 3 (b) The apportioned and assigned strength of the Michigan Air
- 4 National Guard.
- 5 (c) Recruiting, retention, and attrition data, including
- 6 measurement against stated performance goals, for the Michigan Army
- 7 National Guard.
- 8 (d) Recruiting, retention, and attrition data, including
- 9 measurement against stated performance goals, for the Michigan Air
- 10 National Guard.
- 11 Sec. 305. There is hereby created and established under the
- 12 jurisdiction and control of the department a revolving account to
- 13 be known as the billeting fund account. All of the fees and other
- 14 revenues generated from the operation of the chargeable transient
- 15 quarters program shall be deposited in the billeting fund account.
- 16 Appropriations will be made from the account for the support of
- 17 program operations and the maintenance and operations of the
- 18 chargeable transient quarters program and will not exceed the
- 19 estimated revenues for the fiscal year in which they are made,
- 20 together with unexpended balances from prior years. The department
- 21 shall submit an annual report of operations and expenditures
- 22 regarding the billeting fund account to the appropriations
- 23 committees of the senate and house of representatives, the house
- 24 and senate fiscal agencies, and the state budget office at the end
- 25 of the fiscal year.
- 26 MICHIGAN YOUTH CHALLENGE ACADEMY
- 27 Sec. 307. (1) The department shall maintain the Michigan youth

- 1 challeNGe academy to provide values, skills, education, and self-
- 2 discipline instruction for at-risk youth as provided under 32 USC
- **3** 509.
- 4 (2) The department shall take steps to recruit candidates to
- 5 the challenge program from economically disadvantaged areas,
- 6 including those with low-income and high-unemployment backgrounds.
- 7 (3) The department shall partner with the department of health
- 8 and human services to identify youth who may be eligible for the
- 9 challeNGe program from those youth served by department of health
- 10 and human services programs. These eligible youth shall be given
- 11 priority for enrollment in the program.
- 12 (4) The department shall maintain the staffing and resources
- 13 necessary to train at least 144 cadets simultaneously at the
- 14 Michigan youth challeNGe academy.
- 15 (5) The department shall ensure that the average grade level
- 16 increase for Michigan youth challeNGe academy graduates is 2 years
- 17 as measured with the test adult basic education (TABE) metrics.

### 18 MILITARY FAMILY RELIEF FUND

- 19 Sec. 308. (1) The department shall provide grants for
- 20 disbursement from the military family relief fund, as provided
- 21 under the military family relief fund act, 2004 PA 363, MCL 35.1211
- 22 to 35.1216, and R 200.5 to R 200.95 of the Michigan administrative
- 23 code.
- 24 (2) The department shall provide information on the revenues,
- 25 expenditures for advertising and assistance grants, and fund
- 26 balance of the Michigan military family relief fund, as provided
- 27 under section 219.

- 1 (3) The department shall provide sufficient staffing and other
- 2 resources to provide outreach to the Michigan families of members
- 3 of the reserve component of the armed forces called into active
- 4 duty and to support the processing and approval of grant
- 5 applications this fiscal year under the Michigan military relief
- 6 fund and report those applications as provided in section 219.

#### 7 STARBASE GRANT

- 8 Sec. 309. The department shall maintain the starbase program
- 9 at Air National Guard facilities, as provided under 10 USC 2193b,
- 10 to improve the knowledge, skills, and interest of students,
- 11 primarily in the fifth grade, in math, science, and technology. The
- 12 starbase program is to specifically target minority and at-risk
- 13 students for participation.

### 14 NATIONAL GUARD TUITION ASSISTANCE PROGRAM

- 15 Sec. 310. (1) The department shall establish and maintain a
- 16 National Guard tuition assistance program for members of the
- 17 Michigan Air and Army National Guard.
- 18 (2) The objective of the National Guard tuition program is to
- 19 bolster military readiness by increasing recruitment and retention
- 20 of Michigan Air and Army National Guard service members (and to
- 21 fill federally authorized strength levels for the state), improve
- 22 the Michigan Air and Army National Guard's competitive draw from
- 23 other military enlistment options in the state, enhance the ability
- 24 of the Michigan Air and Army National Guard to compete for members
- 25 and federal dollars with surrounding states, and increase the pool
- 26 of eligible candidates within the Michigan Air and Army National
- 27 Guard to become commissioned officers.

- 1 (3) The department shall make efforts to increase the number
- 2 of Michigan Air and Army National Guard members participating in

- 12 estimates, with a goal of reaching 100% and enabling 100% to access
- 13 benefit information online.
- 14 (b) Communicate veteran benefit information pertaining to the

- 16 fund, and USDVA health, financial, and memorial benefits to which
- 17 they are entitled.
- 18 (c) Provide sufficient staffing and other resources to approve
- 19 requests for military discharge certificates (DD-214) annually.
- 20 (d) Continue the process to digitize all medical records,
- 21 military discharge documents, and burial records that are currently
- 22 on paper and microfilm.
- (e) Provide a report, as provided under section 219, on the
- 24 MVAA's performance on the performance measures, outcomes, and
- 25 initiatives developed by the agency in the strategic plan required
- 26 by section 501 of 2013 PA 9.

- 1 (f) Provide a report to the subcommittees, senate and house
- 2 fiscal agencies, and the state budget office no later than April 1

- 14 assistants to the Grand Rapids home for veterans shall ensure that

- 23 related to the following:
- 24 (i) Infrastructure/capital outlay improvements.
- 25 (ii) Information technology updates.
- 26 (iii) Financial management.
- 27 (e) Updates on corrective action status related to any audit

- 1 and survey findings until such findings have been fully addressed.
- 2 (18) The Grand Rapids and D.J. Jacobetti homes for veterans
- 3 shall provide to the subcommittees, the senate and house fiscal
- 4 agencies, and the state budget office the results of any annual or
- 5 for-cause survey conducted by the USDVA-VHA and any corresponding
- 6 corrective action plan. This information shall also be made
- 7 available publicly through the department's or MVAA's website.
- 8 (19) The MVAA shall provide to the legislature and the state
- 9 budget office quarterly reports regarding the status of Medicaid
- 10 certification efforts, including, but not limited to, descriptions
- 11 of incremental milestones, associated expenditures, and the percent
- 12 of plan completed.
- Sec. 502. (1) From the increased funds appropriated in part 1
- 14 for the D.J. Jacobetti home for veterans, the department shall
- 15 pursue compliance with current Centers for Medicare and Medicaid

- 3 appropriations are anticipated to be the same as those for fiscal
- 4 year 2016-2017, excluding appropriations designated as one-time
- 5 appropriations and adjusting for changes in caseload and related
- 6 costs, federal fund match rates, economic factors, and available
- 7 revenue. These adjustments will be determined after the January
- 8 2017 consensus revenue estimating conference.
- 9 Sec. 1202. The veterans affairs agency shall provide the
- 10 percentage of Michigan veterans contacted, with a goal of 100%, and
- 11 report upon those outreach findings to the subcommittees at
- 12 quarterly legislative hearings.
- 13 Sec. 1203. The veterans affairs agency shall maintain a
- 14 minimum 50% fully developed claims as determined by the USDVA.
