- 10 (c) A physician who devotes a substantial portion of his or
- 11 her time to the practice of psychiatry and is approved by the

- 13 (10) "Psychologist" means an individual who is licensed or
- 14 otherwise authorized to engage in the practice of psychology under
- 15 part 182 of the public health code, 1978 PA 368, MCL 333.18201 to
- 16 333.18237, and who devotes a substantial portion of his or her time

- 9 Sec. 429. (1) A hospital designated under section 422 shall
- 10 receive and detain an individual presented for examination under
- 11 section 426, 427, 435, 436, or 428 438, for not more than 24 hours.
- 12 During that time the individual shall be examined by a physician or
- 13 a licensed psychologist UNLESS A CLINICAL CERTIFICATE HAS ALREADY

- Sec. 435. (1) If the petition is accompanied by 1 clinical
- 17 certificate, the court shall order the individual to be examined by
- 18 a psychiatrist.
- 19 (2) If the petition is not accompanied by a clinical
- 20 certificate, and if the court is satisfied a reasonable effort was
- 21 made to secure an examination, the court shall order the individual
- 22 to be examined by a psychiatrist and either a physician or a

- 5 (vii) ASSISTED COMMUNITY TREATMENT TEAM SERVICES.
- 6 (viii) SUBSTANCE USE DISORDER TREATMENT.
- 7 (ix) SUBSTANCE USE DISORDER TESTING FOR INDIVIDUALS WITH A
- 8 HISTORY OF ALCOHOL OR SUBSTANCE USE AND FOR WHOM THAT TESTING IS
- 9 NECESSARY TO ASSIST THE COURT IN ORDERING TREATMENT DESIGNED TO
- 10 PREVENT DETERIORATION. A COURT ORDER FOR SUBSTANCE USE TESTING IS
- 11 SUBJECT TO REVIEW ONCE EVERY 180 DAYS.

- 9 ADVANCE DIRECTIVE, OR INDIVIDUAL PLAN OF SERVICES DEVELOPED UNDER
- 10 SECTION 712, THE ASSISTED OUTPATIENT TREATMENT ORDER SHALL BE
- 11 REVIEWED FOR POSSIBLE ADJUSTMENT BY A PSYCHIATRIST NOT PREVIOUSLY
- 12 INVOLVED WITH DEVELOPING THE ASSISTED OUTPATIENT TREATMENT ORDER.
- 13 IF AN ORDER FOR ASSISTED OUTPATIENT TREATMENT CONFLICTS WITH THE
- 14 PROVISIONS OF AN EXISTING ADVANCE DIRECTIVE, DURABLE POWER OF
- 15 ATTORNEY, OR INDIVIDUAL PLAN OF SERVICES DEVELOPED UNDER SECTION
- 16 712, THE COURT SHALL STATE THE COURT'S FINDINGS ON THE RECORD OR IN
- 17 WRITING IF THE COURT TAKES THE MATTER UNDER ADVISEMENT, INCLUDING

- 1 than 10 days, but not longer than the duration of the order for
- 2 assisted outpatient treatment OR A COMBINATION OF HOSPITALIZATION
- 3 AND ASSISTED OUTPATIENT TREATMENT, or not longer than 90 days,
- 4 whichever is less.
- 5 (5) The court may direct peace officers to transport the
- 6 individual to a designated facility or a preadmission screening
- 7 unit, as applicable, and the court may specify conditions under
- 8 which the individual may return to assisted outpatient treatment
- 9 before the order expires.
- 10 (6) An individual hospitalized without a hearing as provided
- 11 in subsection (4) may object to the hospitalization according to
- 12 the provisions of section 475a.
