A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1136.

- 22 (D) DOES NOT USE ANY FACIAL RECOGNITION TECHNOLOGY OR ANY

- 24 ASSESSMENT OR TEST OR ANY OTHER SCHOOL-RELATED ACTIVITY.
- 25 (E) DOES NOT DISCLOSE TO ANY AGENCY OF THE FEDERAL GOVERNMENT,
- 26 TO THE STATE BOARD, OR TO ANY OTHER OUTSIDE ENTITY ANY INFORMATION
- 27 CONTAINED IN A STUDENT RECORD THAT WOULD REVEAL ANY OF THE
