January 27, 2015, Introduced by Rep. Franz and referred to the Committee on Energy Policy.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 32503 and 32512 (MCL 324.32503 and 324.32512), as amended by 2012 PA 247.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 32503. (1) Except as otherwise provided in this section,
- 2 the department, after finding that the public trust in the waters
- 3 will not be impaired or substantially affected, may enter into
