A bill to amend 2013 PA 93, entitled "Michigan indigent defense commission act," by amending section 3 (MCL 780.983).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. As used in this act:
- 2 (a) "Adult" means either of the following:
- 3 (i) An individual $\frac{17}{18}$ years of age or older.
- 4 (ii) An individual less than 17-18 years of age at the time of
 5 the commission of a felony if any of the following conditions
 6 apply:
 - (A) During consideration of a petition filed under section 4 of chapter XIIA of the probate code of 1939, 1939 PA 288, MCL 712A.4, to waive jurisdiction to try the individual as an adult and upon granting a waiver of jurisdiction.

- 2 2d(1) of chapter XIIA of the probate code of 1939, 1939 PA 288, MCL
- 3 712A.2d, as a case in which the juvenile is to be tried in the same

- 6 attorney under section 2d(2) of chapter XIIA of the probate code of

- 11 complaint and warrant for a specified juvenile violation under
- 12 section 1f of chapter IV of the code of criminal procedure, 1927 PA
- 13 175, MCL 764.1f.
- 14 (b) "Effective assistance of counsel" or "effective
- 15 representation" means legal representation that is compliant with
- 16 standards established by the appellate courts of this state and the
- 17 United States supreme court.SUPREME COURT.
- 18 (c) "Indigent" means meeting 1 or more of the conditions
- 19 described in section 11(3).
- 20 (d) "Indigent criminal defense services" means local legal
- 21 defense services provided to a defendant and to which both of the
- 22 following conditions apply:
- 23 (i) The defendant is being prosecuted or sentenced for a crime
- 24 for which an individual may be imprisoned upon conviction,
- 25 beginning with the defendant's initial appearance in court to
- 26 answer to the criminal charge.
- 27 (ii) The defendant is determined to be indigent under section

- 3 authorized to be provided under the appellate defender act, 1978 PA

- 5 (f) "Indigent criminal defense system" or "system" means
- 6 either of the following:
- 7 (i) The local unit of government that funds a trial court
- 8 combined with each and every trial court funded by the local unit
- 9 of government.
- 10 (ii) If a trial court is funded by more than 1 local unit of
- 11 government, those local units of government, collectively, combined
- 12 with each and every trial court funded by those local units of
- 13 government.
- 14 (g) "Local share" or "share" means an indigent criminal
- 15 defense system's average annual expenditure for indigent criminal
- 16 defense services in the 3 fiscal years immediately preceding the
- 17 creation of the MIDC under this act, excluding money reimbursed to
- 18 the system by individuals determined to be partially indigent.
- 19 (h) "MIDC" or "commission" means the Michigan indigent defense
- 20 commission created under section 5.
- 21 Enacting section 1. This amendatory act takes effect 90 days
- 22 after the date it is enacted into law.
