A bill to amend 1954 PA 116, entitled

"Michigan election law,"

by amending section 282a (MCL 168.282a) and by adding section 282b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 282a. At its fall state convention of 1964, each
- 2 political party may nominate 8 candidates for membership on the
- 3 state board of education. Two candidates shall be nominated for 2-
- 4 year terms, 2 for 4-year terms, 2 for 6-year terms and 2 for 8-year
  - terms. At its fall state convention of 1966, and every 2 years
- thereafter, each political party may, SUBJECT TO SECTION 282B,
- 7 nominate 2 candidates for membership on the state board of
- 8 education.
  - SEC. 282B. (1) IN ORDER TO BETTER PROMOTE A DIVERSITY OF
