THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 277. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2015, A TAXPAYER WHO IS AN ELIGIBLE EDUCATOR AT A PUBLIC SCHOOL OR
- 3 PUBLIC SCHOOL ACADEMY MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY
- 4 THIS ACT EQUAL TO THE COST PAID BY THE TAXPAYER IN THE TAX YEAR NOT
- 5 TO EXCEED \$200.00 FOR A SINGLE RETURN OR \$400.00 FOR A JOINT RETURN
- 6 FOR CLASSROOM SUPPLIES USED BY THE TAXPAYER FOR EDUCATIONAL
- 7 PURPOSES THAT DIRECTLY RELATE TO THE TAXPAYER'S CLASSROOM
- 8 COURSEWORK.
- 9 (2) IF THE CREDIT ALLOWED UNDER THIS SECTION EXCEEDS THE TAX
