THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1319. (1) THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE

- 5 ACTIVITY UNLESS THE SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY HAS
