THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 2. As used in this act:

(a) "Animal control officer" means a county animal control officer as described in sections 29a and 29b of the dog law of 4 1919, 1919 PA 339, MCL 287.289a and 287.289b, or a city, village, or township animal control officer as described in section 29c of the dog law of 1919, 1919 PA 339, MCL 287.289c.

(b) "Animal control shelter" or "animal protection shelter" 7 means an animal control shelter or animal protection shelter, 8 9 respectively, registered with the department under section 6 of 1969 PA 287, MCL 287.336. 10

(c) "Department" means the department of agriculture AND RURAL
 DEVELOPMENT.

3 (d) "Dog" means an animal of the species Canis familiaris or4 Canis lupus familiaris.

5 (e) "Expert on wolf-dog cross identification" means an
6 individual who has, cumulatively, at least 10 years of training and
7 field experience in wolf and wolf-dog cross behavioral and
8 morphological characteristics and who is recognized as an expert at
9 the state and national levels by others in the same field.

10 (f) "Facility" means an indoor or outdoor cage, pen, or 11 similar enclosure where a wolf-dog cross is kept.

12 (g) "Law enforcement officer" means:

13 (i) A sheriff or sheriff's deputy.

14 (*ii*) A village or township marshal.

15 (*iii*) An officer of the police department of a city, village,16 or township.

17 (*iv*) An officer of the Michigan state police.

18 (v) A peace officer who is trained and LICENSED OR certified
19 under the commission on law enforcement standards act, 1965 PA 203,
20 MCL 28.601 to 28.616.28.615.

(vi) A conservation officer appointed by the department ofnatural resources.

24 (viii) A law enforcement officer of the federal government25 authorized to enforce any federal law regulating animals.

26 (h) "Livestock" means that term as defined in section 5 of the27 animal industry act of 1987, 1988 PA 466, MCL 287.705.

(i) "Local unit" means a city, village, township, or county.

(j) "Permit" means a permit issued under section 4.

3 (k) "Permitting agency" means the agency of a local unit that4 issues permits under section 4.

5 (l) "Person" means an individual, partnership, corporation,
6 association, governmental entity, or other legal entity.

7 (m) "Pet shop" means a pet shop licensed by the department
8 under section 3 of 1969 PA 287, MCL 287.333.

9 (n) "Veterinarian" means a person licensed to practice

(o) "Wolf" means an animal of the species Canis rufus or Canis
lupus, but does not include an animal of the species Canis lupus
familiaris.

(p) "Wolf-dog cross" means a canid resulting from the breeding of any of the following:

18 (*ii*) A wolf-dog cross with a wolf.

19 (*iii*) A wolf-dog cross with a dog.

20 (*iv*) A wolf-dog cross with a wolf-dog cross.

21 Enacting section 1. This amendatory act takes effect 90 days22 after the date it is enacted into law.

23 Enacting section 2. This amendatory act does not take effect
24 unless Senate Bill No. 92 or House Bill No. (request no.
25 00913'15 *) of the 98th Legislature is enacted into law.
