## **HOUSE BILL No. 5642**

May 11, 2016, Introduced by Reps. Guerra, Hughes, Barrett, Durhal, Lucido and Bizon and referred to the Committee on Communications and Technology.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 2950o.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2950o. (1) AN ORDER ISSUED UNDER SECTION 2950N MUST BE
- 2 SERVED ON THE WIRELESS TELEPHONE SERVICE PROVIDER AS REQUIRED UNDER
- 3 THE MICHIGAN COURT RULES.
- 4 (2) IF THE WIRELESS TELEPHONE SERVICE PROVIDER CANNOT
- 5 OPERATIONALLY OR TECHNICALLY EFFECTUATE AN ORDER ISSUED UNDER
- 6 SECTION 2950N BECAUSE OF ANY OF THE FOLLOWING CIRCUMSTANCES, THE
- 7 WIRELESS TELEPHONE SERVICE PROVIDER SHALL SO NOTIFY THE PETITIONER
- 8 WITHIN 72 HOURS AFTER THE WIRELESS TELEPHONE SERVICE PROVIDER
  - RECEIVES THE ORDER:
    - (A) THE CUSTOMER HAS TERMINATED SERVICE FOR THE NUMBER.
    - (B) DIFFERENCES IN NETWORK TECHNOLOGY PREVENT THE

- 12 PETITIONER SHALL ASSUME ALL FINANCIAL RESPONSIBILITY FOR SERVICE TO
- 13 THE TRANSFERRED NUMBER, MONTHLY SERVICE COSTS, AND COSTS FOR ANY
- 14 MOBILE DEVICE ASSOCIATED WITH THE NUMBER.
- 15 (5) SECTION 2950N AND THIS SECTION DO NOT PRECLUDE A WIRELESS
- 16 TELEPHONE SERVICE PROVIDER FROM APPLYING ANY ROUTINE AND CUSTOMARY
- 17 REQUIREMENTS FOR THE ESTABLISHMENT OF SERVICE TO THE PETITIONER AS
- 18 PART OF A TRANSFER OF BILLING RESPONSIBILITY FOR A WIRELESS
- 19 TELEPHONE NUMBER AND ANY DEVICES ASSOCIATED WITH THE NUMBER,
- 20 INCLUDING, BUT NOT LIMITED TO, IDENTIFICATION, FINANCIAL
- 21 INFORMATION, AND CUSTOMER PREFERENCES.
- 22 (6) A WIRELESS TELEPHONE SERVICE PROVIDER AND ITS EMPLOYEES
- 23 AND AGENTS ARE NOT LIABLE FOR ANY ACTIONS TAKEN IN ACCORDANCE WITH
- 24 THIS SECTION OR A COURT ORDER ISSUED UNDER SECTION 2950N.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
- 27 Enacting section 2. This amendatory act does not take effect
