## **HOUSE BILL No. 5719**

June 2, 2016, Introduced by Rep. Kosowski and referred to the Committee on Appropriations.

A bill to amend 1971 PA 140, entitled "Glenn Steil state revenue sharing act of 1971," (MCL 141.901 to 141.921) by adding section 915.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 915. (1) FOR STATE FISCAL YEARS BEGINNING ON AND AFTER 2 THE 2016-2017 STATE FISCAL YEAR, THE DEPARTMENT OF TREASURY SHALL 3 IMPLEMENT AN INCENTIVE PROGRAM AND THE DEPARTMENT OF TREASURY SHALL 4 USE THE PROGRAM TO DISTRIBUTE ADDITIONAL REVENUE SHARING PAYMENTS 5 TO CITIES, VILLAGES, TOWNSHIPS, AND COUNTIES AS PROVIDED UNDER 6 SUBSECTION (2).

7 (2) TO THE EXTENT THAT A CITY, VILLAGE, TOWNSHIP, OR COUNTY
8 RECEIVED A PAYMENT UNDER SECTION 952 OR 955, OR BOTH, OF ARTICLE

7 (A) CATEGORY 1, CONSOLIDATION OF SERVICES, 8.0% BONUS, 8 REQUIRES EACH ELIGIBLE CITY, VILLAGE, TOWNSHIP, OR COUNTY TO 9 CERTIFY THAT IT HAS ENTERED INTO A PLAN SINCE JANUARY 1, 2012 WITH 10 1 OR MORE PROPOSALS TO INCREASE ITS EXISTING LEVEL OF COOPERATION, 11 COLLABORATION, AND CONSOLIDATION, EITHER WITHIN THE JURISDICTION OR 12 WITH OTHER JURISDICTIONS. A PLAN SHALL INCLUDE A LISTING OF ANY 13 PREVIOUS SERVICES CONSOLIDATED WITH THE COST SAVINGS REALIZED FROM 14 EACH CONSOLIDATION AND AN ESTIMATE OF THE POTENTIAL SAVINGS FOR ANY 15 NEW SERVICE CONSOLIDATIONS BEING PLANNED. A PLAN SHALL BE MADE 16 READILY AVAILABLE TO THE PUBLIC. EACH CITY, VILLAGE, TOWNSHIP, AND 17 COUNTY APPLYING FOR A PAYMENT UNDER THIS SUBDIVISION SHALL SUBMIT A COPY OF THE COOPERATION, COLLABORATION, AND CONSOLIDATION PLAN TO 18 19 THE DEPARTMENT OF TREASURY.

(B) CATEGORY 2, WORKFORCE REDUCTION, 4.0% BONUS, REQUIRES EACH
CITY, VILLAGE, TOWNSHIP, OR COUNTY THAT HAS ENTERED A PLAN AS
PROVIDED UNDER SUBDIVISION (A) TO PROVIDE DOCUMENTATION TO THE
DEPARTMENT VERIFYING THAT PURSUANT TO THE PLAN THE CITY, VILLAGE,
TOWNSHIP, OR COUNTY HAS REDUCED ITS WORKFORCE BY AT LEAST 5.0% OR 3
EMPLOYEES, WHICHEVER IS MORE, SINCE JANUARY 1, 2012.

26 (C) CATEGORY 3, BUDGET REDUCTION, 4.0% BONUS, REQUIRES EACH
27 ELIGIBLE CITY, VILLAGE, TOWNSHIP, OR COUNTY TO CERTIFY THAT SINCE

JANUARY 1, 2012 THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY HAS REDUCED
 ITS OVERALL BUDGET BY AT LEAST 5.0%.

3 (D) CATEGORY 4, BALANCED BUDGET, 4.0%, REQUIRES EACH ELIGIBLE
4 CITY, VILLAGE, TOWNSHIP, OR COUNTY TO CERTIFY THAT SINCE JANUARY 1,
5 2012 THAT CITY, VILLAGE, TOWNSHIP, OR COUNTY HAS MAINTAINED A
6 BALANCED BUDGET FOR 2 CONSECUTIVE YEARS.

7 (3) PAYMENTS UNDER THIS SECTION ARE SUBJECT TO THE FOLLOWING8 CONDITIONS:

9 (A) IN ORDER FOR A CITY, VILLAGE, TOWNSHIP, OR COUNTY TO 10 QUALIFY FOR A CATEGORY UNDER SUBSECTION (2), THE CITY, VILLAGE, 11 TOWNSHIP, OR COUNTY SHALL MEET EVERY CRITERIA FOR THAT CATEGORY 12 INCLUDING A CERTIFICATION TO THE DEPARTMENT THAT IT HAS MET THE 13 REQUIRED CRITERIA FOR THAT CATEGORY AND SUBMISSION OF THE REQUIRED 14 COOPERATION, COLLABORATION, AND CONSOLIDATION PLAN AND OTHER 15 REQUIRED DOCUMENTATION AS REQUIRED BY SUBSECTION (2). A DEPARTMENT OF TREASURY REVIEW OF THE PLAN IS NOT REQUIRED IN ORDER FOR A CITY, 16 17 VILLAGE, TOWNSHIP, OR COUNTY TO RECEIVE A PAYMENT UNDER SUBSECTION 18 (2). THE DEPARTMENT SHALL DEVELOP A CERTIFICATION PROCESS AND 19 METHOD FOR CITIES, VILLAGES, TOWNSHIPS, AND COUNTIES TO FOLLOW.

(B) FOR EACH CATEGORY THAT A CITY, VILLAGE, TOWNSHIP, OR
COUNTY QUALIFIES FOR IN SUBSECTION (2), THE CITY, VILLAGE,
TOWNSHIP, OR COUNTY SHALL RECEIVE ITS POTENTIAL INCENTIVE PROGRAM
PAYMENT AMOUNT AS CALCULATED IN ACCORDANCE WITH SUBSECTION (2).
(C) IF A CITY, VILLAGE, TOWNSHIP, OR COUNTY DOES NOT PROVIDE
THE REQUIRED CERTIFICATION OR FAILS TO SUBMIT THE REQUIRED

7 (E) PAYMENTS UNDER THIS SECTION SHALL BE DISTRIBUTED ON THE
8 LAST BUSINESS DAY OF OCTOBER, DECEMBER, FEBRUARY, APRIL, JUNE, AND
9 AUGUST.

(4) EXCEPT AS OTHERWISE PROVIDED UNDER SECTIONS 17A AND 21, A
CITY, VILLAGE, TOWNSHIP, OR COUNTY THAT QUALIFIES FOR AN INCREASED
PAYMENT UNDER THIS SECTION SHALL CONTINUE TO RECEIVE THAT INCREASED
PAYMENT UNDER THIS SECTION EACH STATE FISCAL YEAR AND ADDITIONAL
VERIFICATION IS NOT REQUIRED TO QUALIFY FOR PAYMENTS IN SUBSEQUENT
FISCAL YEARS.
