A bill to amend 1961 PA 236, entitled

"Revised judicature act of 1961,"

by amending section 151e (MCL 600.151e), as amended by 2004 PA 465.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 151e. (1) The money in the juror compensation
- 2 reimbursement fund shall be distributed each year as provided in
- 3 this section.
- 4 (2) Each court funding unit shall submit a report semiannually
- 5 to the state court administrator, for each court for which it is a
- 6 funding unit, giving the total amount of the expense incurred
- 7 during the fiscal year by that funding unit due to the ANY increase
