A bill to amend 1893 PA 206, entitled "The general property tax act,"

(MCL 211.1 to 211.155) by adding section 9p.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 9P. (1) BEGINNING DECEMBER 31, 2016, ELIGIBLE BROADBAND
- 2 EQUIPMENT IS EXEMPT FROM THE COLLECTION OF TAXES UNDER THIS ACT.
- 3 (2) AS USED IN THIS SECTION:
- 4 (A) "BROADBAND SERVICE" MEANS INTERNET ACCESS SERVICE CAPABLE
- 5 OF TRANSMITTING DATA AT A RATE OF AT LEAST 50 MEGABITS PER SECOND
- 6 OF DOWNLOAD SPEED AND 5 MEGABITS PER SECOND OF UPLOAD SPEED.
- 7 (B) "ELIGIBLE BROADBAND EQUIPMENT" MEANS ANY EQUIPMENT OWNED
- 8 BY A QUALIFIED BUSINESS THAT MEETS ALL OF THE FOLLOWING:

- 1 (i) IS USED FOR OR IS SUBSTANTIALLY RELATED TO PROVIDING
- 2 BROADBAND SERVICE IN AT LEAST 1 DIRECTION. THE TERM INCLUDES, BUT
- 3 IS NOT LIMITED TO, ASYNCHRONOUS TRANSFER MODE SWITCHES, DIGITAL
- 4 SUBSCRIBER LINE ACCESS MULTIPLEXERS, ROUTERS, SERVERS,
- 5 MULTIPLEXERS, FIBER OPTICS, AND RELATED EQUIPMENT. THE TERM ALSO
- 6 INCLUDES, BUT IS NOT LIMITED TO, THE FOLLOWING:

- 19 (ii) WAS FIRST INSTALLED OR USED BY THE QUALIFIED BUSINESS
- 20 AFTER DECEMBER 31, 2015 AND HAS BEEN USED BY THE QUALIFIED BUSINESS
- 21 FOR NOT MORE THAN 10 YEARS.
- 22 (C) "PERSON" MEANS AN INDIVIDUAL, SOLE PROPRIETORSHIP,
- 23 PARTNERSHIP, CORPORATION, ASSOCIATION, LIMITED LIABILITY COMPANY,
- 24 OR ANY OTHER LEGAL ENTITY.
- 25 (D) "QUALIFIED BUSINESS" MEANS A PERSON WHO PROVIDES
- 26 TERRESTRIAL BROADBAND SERVICE.
